**Application by EPL 001 Limited: Stonestreet Green Solar (Application Reference: EN010135)**

**Applicant Submissions at Deadline 6**

Further to the publication of the Rule 6 letter on 22 October 2024 [[PD-004](#)], the Rule 8 letter on 28 November 2024 [[PD-005](#)] and the variation letter on 14 April 2025 [[PD-009](#)], I write to provide EPL 001 Limited's (the 'Applicant') written submissions for Deadline 6 of the Examination of the Stonestreet Green Solar Development Consent Order ('DCO') Application.
