

## 1 Introduction

#### 1.1 Introduction

- 1.1.1 This Guide to the Application ('Guide') provides an overview of the documents that make up the Development Consent Order ('DCO') application ('DCO Application') for Stonestreet Green Solar (the 'Project'). The DCO Application is made by EPL 001 Limited (the 'Applicant') to the Planning Inspectorate (on behalf of the Secretary of State) for a DCO to be granted by the Secretary of State for Energy Security and Net Zero pursuant to the Planning Act 2008 ('PA 2008').
- 1.1.2 The Project comprises the construction, operation and maintenance and decommissioning of solar photovoltaic arrays and energy storage, together with associated infrastructure and an underground cable connection to the existing National Grid Sellindge Substation.
- 1.1.3 The Project will include a generating station (incorporating solar arrays) with a total capacity exceeding 50 megawatts ('MW'). The agreed grid connection for the Project will allow the export and import of up to 99.9 MW of electricity to the grid. The Project will connect to the existing National Grid Sellindge Substation via a new 132 kilovolt substation constructed as part of the Project and cable connection under the Network Rail and High Speed 1 railway.
- 1.1.4 This Guide provides an overview of the documents that have been submitted to satisfy the PA 2008, the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017.

#### 1.2 Structure of this Guide

# 2 Overview of Application Documents

## 2.1 Application Structure

2.1.1 Table 2.1 below sets out the DCO Application structure. The DCO Application is organised into books. The full list of documents is set out in Section 6 of this Guide. Book 5: Environmental Statement is organised into volumes due to its size.

Book 7: Other Reports and Management Plans	Includes additional reports and management plans produced to support the DCO Application.




## 3 Control Documents

#### 3.1 Overview

3.1.1 Control documents are used to set the parameters for and secure the mitigation proposed for the Project. Figure 1 below sets out the hierarchy of controls for the Project.

Figure 1: Hierarchy of Project controls



- 3.1.2 The DCO once made would grant the Applicant the powers and authority to deliver the Project, with the Articles and Schedules in the DCO setting the scope and limit of those powers as well as controls which must be complied with.
- 3.1.3 Schedule 1 of the **Draft Development Consent Order (Doc Ref. 3.1)** describes the Authorised Development for which consent is being sought. Schedule 2 sets out Requirements which are a series of commitments and controls that relate to the construction, operation and decommissioning of the Project. Schedule 14 identifies the documents that are to be certified by the Secretary of State following the granting of development consent.
- 3.1.4 The **Schedule of Other Consents and Licences (Doc Ref. 3.4)** sets out the parallel regimes through which the Applicant seeks consent to undertake certain works.



#### 3.2 Control Documents

- 3.2.1 The DCO Application contains a number of Control Documents that will be secured within the **Draft Development Consent Order (Doc Ref. 3.1)** and act as legal controls for the Project. The list of Control Documents is as follows:

- 3.2.2 Some Control Documents are compliance documents and must be complied with when certain activities are carried out. These are:
  - Works Plans (Doc Ref. 2.3)
  - Traffic Regulations Measures Plans (Doc Ref. 2.4)
  - Streets, Rights of Way and Access Plans (Doc Ref. 2.5)
  - Design Principles (Doc Ref. 7.5)
- 3.2.3 The remaining Control Documents provide a framework for the production of more detailed strategies, as detailed in Section 3.3 below.
- 3.3 Management Plans
- 3.3.1 The outline management plans included within Book 7: Other Reports and Management Plans provide the framework and overarching principles for mitigation during the construction, operation and decommissioning phases of the Project.
- 3.3.2 The **Draft Development Consent Order (Doc Ref. 3.1)** includes Requirements that secure further detailed management plans where necessary. These detailed management plans are required to be submitted to and approved by an identified



statutory body, typically Ashford Borough Council as local planning authority. Table 3.1 below sets out to which phases of the Project each outline management plan applies.

# 4 Document Referencing

#### 4.1 Overview

4.1.1 Each document that forms part of the DCO Application has been assigned a reference number that allows it to be located within the DCO Application document list. When an application document refers to another application document, the full name of that document is provided followed by the reference number in bold. An example of this is as follows:

"the Draft Development Consent Order (Doc Ref. 3.1) secures that..."

- 4.1.2 Where references to external or third-party documents are made that do not form part of the DCO Application, these are supplied with footnotes with full references provided in the Harvard referencing format at the end of each document.
- 4.2 Revisions during Pre-Examination and Examination
- 4.2.1 Where documents have been updated by the Applicant during the Pre-Examination and Examination phases, their reference numbers have been updated to reflect that a new version has been submitted. This follows the pattern below, using the Draft Development Consent Order as the example:
  - Version 1 of a document being the original document reference (e.g. Draft Development Consent Order (Doc Ref. 3.1));
  - Version 2 of document including (A) (e.g. Draft Development Consent Order (Doc Ref. 3.1(A)).
  - This referencing approach then means Version 3 is 3.1(B), Version 4 is 3.1(C) etc.
