## **Applicant Submissions at Deadline 8**

Further to the publication of the Rule 6 letter on 22 October 2024 [PD-004], the Rule 8 letter on 28 November 2024 [PD-005] and the variation letter on 14 April 2025 [PD-009], I write to provide EPL 001 Limited's (the 'Applicant') written submissions for Deadline 8 of the Examination of the Stonestreet Green Solar Development Consent Order ('DCO') Application.

Appendix 1 of this letter provides an overview of the documents submitted by the Applicant at Deadline 8. Table 1 comprises the DCO Application documents for which updated versions are being submitted and summarises why each document has been updated. Table 2 comprises the new documents submitted and summarises why these have been provided by the Applicant at Deadline 8. These new documents are included in Book 8 – Examination.

A Policy Compliance Checklist was appended to the **Planning Statement (Doc Ref. 7.6)** [APP-151] and the Planning Statement Addendum (**Doc Ref. 8.9**) [REP2-035] which was submitted at Deadline 1 which has taken account of the revised NPPF and Clean Power 2030.

Due to illness the KCC SoCG has not been signed, however the Applicant has confirmed with KCC that the current version of the KCC SoCG can be submitted at Deadline 8 as the final version.

As set out in Section 5 of the **Closing Statement (Doc Ref 8.25)**, there are Crown interests within the Order land. The Order includes an article (Article 42 in the Draft DCO (Doc Ref. 3.1(G)) protecting the position of the Crown. The Applicant has been engaged in discussions with the SoS for Transport since 2022 in order to secure the rights and access necessary to carry out the relevant parts of the authorised development and to obtain the consent of the Crown to the inclusion of provisions applying in relation to Crown land. The



consent of the SoS for Transport required pursuant to section 135 of the PA 2008, has not yet been received, but is anticipated to be received very shortly.

In response to the ExA's request for information of 13 May, the **Signed Statement of Common Ground with Ashford Borough Council (Doc Ref. 8.3.1(C))** includes the updated position, which reflects a discussion with ABC on the 13 May.
