# 1 Application guide

## 1.1 Introduction

- 1.1.1.1 This guide to the application summarises the structure of the application for development consent for the Morgan Offshore Wind Project: Generation Assets (hereafter referred to as the Morgan Generation Assets). Its purpose is to provide an understanding of the structure of the Application and the principal contents within each 'category' of documents.
- 1.1.1.2 Updating this document will be an iterative process and new versions will be made available as updates are made.
- 1.1.1.3 This document will be updated during the examination of the application and will be a quick-reference guide to the latest version of the application documents.

## 1.2 Document categories

- 1.2.1.1 There are seven categories of application documents, as set out in Table 1.1. These follow, wherever possible, the structure described in Table 1 of 'Advice Note 6 – Suggested Order of Information Submitted with Application' and 'Appendix 1 of the Planning Inspectorate Advice Note 6' (The Planning Inspectorate, 2017).

**Table 1.1: Report categories that make up the master document list for the Morgan Generation Assets application for consent.**

Category	Details
A: Application Information	Provides details of the specific application information required by the Planning Inspectorate
B: Plans and Drawings	Contains the various plans which show the location of the Morgan Generation Assets, the proposed works or are related to other powers sought in the Development Consent Order
C: Draft Development Consent Order	This category outlines the legal power sought by the Applicant for the Morgan Generation Assets.
D: Land	This category includes the Funding Statement, Statement of Reasons and Land Plan required to be submitted for the Morgan Generation Assets.
E: Reports	This category contains the documents required to be submitted with the application for consent, including the Consultation Report.
F: Environmental Statement	Outlines how the Applicant has assessed the potential impact of the Project on the environment.
J: Additional Application documents	This category includes any additional information submitted with the application for consent, including outline and in principles plans.

- 1.2.1.2 Regulation 5 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 sets out a list of documents to accompany an application for development consent. As set out in Regulation 5, some of those documents are only to be submitted '*where applicable*' to the development consent order being applied for. There are a number of documents that are not applicable to the development consent order sought for the Morgan Generation Assets and are therefore not submitted with the application. These are set out below for reference.

The Applicant has submitted all documents required by Regulation 5 that are applicable. Please also see the Draft Section 55 Checklist (Document Reference A2).

**1.2.1.3 Compulsory acquisition and land documents** - the Draft DCO (Document Reference C1) does not contain any articles that give powers to compulsory acquisition of land or rights in land. The following documents are only of relevance to an application where compulsory powers are sought and are therefore not applicable to, and are not submitted with, the Morgan Generation Assets application: book of reference (reg.5(2)(d)), statement of reasons and funding statement (reg. 5(2)(h)), access and rights of way plan (reg.5(2)(k)), Crown land plan (reg. 5(2)(n)).

**1.2.1.4 Flood risk assessment (reg.5(2)(e))** – as the project is located entirely in the marine environment, no flood risk assessment is required or has been undertaken as part of the application.
