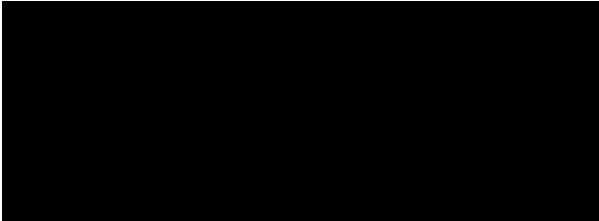
Outline Vessel Traffic Management plan (tracked)
