EN010136 - Application by Morgan Offshore Wind Limited for an Order Granting Development Consent for the Morgan Offshore Wind Farm: Generation Assets

Withdrawal of objection by Barrow Offshore Wind Limited

This letter is submitted by Barrow Offshore Wind Limited, a company incorporated under the Companies Acts (Registered Number 04145993) and having its registered office at 5 Howick Place, London, SW1P 1WG.

During the Examination of the application for an order granting development consent for the Morgan Offshore Wind Farm: Generation Assets (the “**Proposed Development**”), Barrow Offshore Wind Limited made a number of representations to the Examining Authority in respect of the potential impact of the Proposed Development on an operational offshore wind farm owned and operated by Barrow Offshore Wind Limited.

Following the close of the Examination, the Applicant and Barrow Offshore Wind Limited have continued to negotiate terms of an agreement that would address the matters raised and that (i) allows Barrow Offshore Wind Limited to withdraw its objection to the Proposed Development and (ii) provides mitigation of identified wake effects on Barrow Offshore Wind Farm. Agreement has now been reached between the parties.

As such, Barrow Offshore Wind Limited **withdraws its objection** to the application for development consent for the Proposed Development, and to the development consent order being made in the terms sought by the Applicant.

For the avoidance of doubt, Barrow Offshore Wind Limited does not consider any additional provisions are required in the development consent order (e.g. a requirement or protective provisions) in respect of wake loss impacts. Barrow Offshore Wind Limited is aware that the Mona Offshore Wind Farm Order 2025 was recently granted and included a requirement (requirement 29 (wake effects)) that *inter alia* secured further steps to be taken by the undertaker of the Mona Offshore Wind Farm to mitigate potential wake impacts on the operational offshore wind farm owned and operated by Barrow Offshore Wind Limited. As agreement has now been reached between the parties in respect of the Proposed Development, Barrow Offshore Wind Limited does not consider an equivalent requirement is needed in any DCO granted for the Proposed Development in respect of Barrow Offshore Wind Farm.


However, if the Secretary of State decides to include a requirement in the development consent order regarding mitigation of wake loss impacts on Barrow Offshore Wind Farm, Barrow Offshore Wind

Limited considers suitable mitigation has been provided, such that any requirement could be discharged without any further controls on design or a need to consult further with Barrow Offshore Wind Limited.

Barrow Offshore Wind Limited consider that the Secretary of State can be satisfied that the Applicant has provided suitable mitigation and meets the relevant policy tests in respect of the assets owned and operated by the Barrow Offshore Wind Limited. In light of the agreement reached between the Applicant and Barrow Offshore Wind Limited, it is considered that the Secretary of State can be satisfied that the Applicant has met the policy tests within the draft EN-3 that relate to wake effects. The Secretary of State can be satisfied that the applicant has worked collaboratively with Barrow Offshore Wind Limited and taken reasonable steps to minimise the possible impact of wake effects on the operations of Barrow Offshore Wind Limited.

Finally, for completeness Barrow Offshore Wind Limited wishes to confirm that it has also reached agreement with the undertaker of the Mona Offshore Wind Project in respect of mitigation for wake effects. Barrow Offshore Wind Limited intends to write to the Secretary of State separately to confirm that it is satisfied that requirement 29 of the Mona Offshore Wind Farm Order 2025 so far as it relates to the interests of Barrow Offshore Wind Farm can be discharged.
