**EN010136 - Application by Morgan Offshore Wind Limited for an Order Granting Development Consent for the Morgan Offshore Wind Farm: Generation Assets**  
**Withdrawal of objection by Morecambe Wind Limited**

This letter is submitted by Morecambe Wind Limited, a company incorporated under the Companies Acts (Registered Number 05294242) and having its registered office at 5 Howick Place, London, SW1P 1WG.

During the Examination of the application for an order granting development consent for the Morgan Offshore Wind Farm: Generation Assets (the “**Proposed Development**”), Morecambe Wind Limited made a number of representations to the Examining Authority in respect of the potential impact of the Proposed Development on an operational offshore wind farm owned and operated by Morecambe Wind Limited.

Following the close of the Examination, the Applicant and Morecambe Wind Limited have continued to negotiate terms of an agreement that would address the matters raised and allow Morecambe Wind Limited and that (i) allows Morecambe Wind Limited to withdraw its objection to the Proposed Development and (ii) provides mitigation of identified wake effects on West of Duddon Sands Offshore Wind Farm. Agreement has now been reached between the parties, and they have executed a contract in this regard.

As such, Morecambe Wind Limited **withdraws its objection** to the application for development consent for the Proposed Development, and to the development consent order being made in the terms sought by the Applicant.

For the avoidance of doubt, Morecambe Wind Limited does not consider any additional provisions are required in the development consent order (e.g. a requirement or protective provisions) in respect of wake loss impacts. Morecambe Wind Limited is aware that the Mona Offshore Wind Farm Order 2025 was recently granted and included a requirement (requirement 29 (wake effects)) that *inter alia* secured further steps to be taken by the undertaker of the Mona Offshore Wind Farm to mitigate potential wake impacts on the operational offshore wind farm owned and operated by Morecambe Wind Limited. As agreement has now been reached between the parties in respect of the Proposed Development, Morecambe Wind Limited does not consider an equivalent requirement is needed in any DCO granted for the Proposed Development in respect of West of Duddon Sands Offshore Wind Farm.

However, if the Secretary of State decides to include a requirement in the development consent order regarding mitigation of wake loss impacts on West of Duddon Sands Offshore Wind Farm, Morecambe Wind Limited considers suitable mitigation has been provided, such that any requirement could be discharged without any further controls on design or a need to consult further with Morecambe Wind Limited.

Morecambe Wind Limited consider that the Secretary of State can be satisfied that the Applicant has provided suitable mitigation and meets the relevant policy tests in respect of the assets owned and operated by the Morecambe Wind Limited.

In light of the agreement reached between the Applicant and Morecambe Wind Limited, it is considered that the Secretary of State can be satisfied that the Applicant has met the policy tests within the draft EN-3 that relate to wake effects. The Secretary of State can be satisfied that the applicant has worked collaboratively with Morecambe Wind Limited and taken reasonable steps to minimise the possible impact of wake effects on the operations of Morecambe Wind Limited.

Finally, for completeness Morecambe Wind Limited wishes to confirm that it has also reached agreement with the undertaker of the Mona Offshore Wind Project in respect of mitigation for wake effects. Morecambe Wind Limited intends to write to the Secretary of State separately to confirm that it is satisfied that requirement 29 of the Mona Offshore Wind Farm Order 2025 so far as it relates to the interests of West of Duddon Sands Offshore Wind Farm can be discharged.
