In 2014 (on 16/5/14 to be precise) I introduced myself to you as a former student of


your father at LSE when you happened to sit opposite me on a train from north Wales to London after you had been to the Airbus factory in Broughton in Flintshire.

I live in the tiny community (5.2 square miles, 359 population) of Cefn Meiriadog in Denbighshire and we are currently facing a crisis in the form of a tidal wave of very large-scale energy infrastructure projects locating in our community which in number and scale is massively disproportionate both to the size of our community and to the scale of similar development in other, neighbouring communities.

As Secretary of State for Energy Security and Net Zero you currently have on your desk the report of the Planning Inspectorate on the Mona Offshore Windfarm DCO application, which seeks consent for a large-scale substation to be located in our community and follows other large-scale infrastructure projects already constructed or consented, and with other proposals of similar size already in the planning pipeline. Taken cumulatively these are wholly out of scale with the size and nature of our community and will undoubtedly do very serious, possibly terminal, harm to its character, identity and history.

Labour will always be the party of social justice, therefore as a resident and Community Councillor I would request that a concept of community justice is brought to bear on the situation we are facing whereby in our region our small community is wholly unfairly being made to bear all the pain of the transition to renewables and net zero which we all support but which is proving so very damaging to this our community. Both the local authority (Denbighshire C C) and the Welsh Government say they are aware of our predicament but are not able to help. I would ask, therefore, that you be aware of this very difficult situation we are facing when making your decision about the Mona DCO application.
