# 1 Introduction

#### **Purpose of this document**

- 1.1 This document provides a guide to the Application for a Development Consent Order ('DCO') for the extension of the generating capacity of the Rivenhall Integrated Waste Management Facility ('IWMF') ('the Proposed Development'). The Application is made by Indaver Rivenhall Limited ('the Applicant') to the Secretary of State pursuant to the Planning Act 2008 ('PA 2008').
- 1.2 The Applicant is seeking a DCO to increase the generating capacity of the Energy from Waste ('EfW') plant that forms part of the consented Rivenhall IWMF to more than 50MW. The greater generating capacity would be achieved by carrying out engineering operations which would optimise the design and operation of the boiler, steam turbine and generator to provide a greater rate of energy recovery. It would not require an increase in waste throughput or physical changes to the consented building envelope or external layout. The Proposed Development involves the carrying out of engineering operations to either: i) remove and replace the steam turbine inlet control valves; or ii) install unrestricted turbine inlet control valves. Development consent is sought for both options. Which option would be carried out depends upon the timing of a DCO being granted and the stage of construction the consented IWMF.
- 1.3 As the generating capacity of the EfW within the Proposed Development would exceed 50MW, it is considered a Nationally Significant Infrastructure Project ('NSIP') under Sections 14(1)(a) and 15(1)(2)(a) to (c) of the Planning Act 2008. Therefore, development consent in the form of a DCO is required under Section 31 of the Planning Act 2008.
- 1.4 This Guide aims to help the Examining Authority ('ExA') and Interested Parties understand the Application through signposting the documents that make up the Application. This is a live document that will be updated throughout the examination period and submitted at each deadline.

### **Application Books**

- 1.5 The documents and plans have been grouped into 'Books' corresponding with the Planning Inspectorate's ('PINS') Advice Note Six: Preparation and submission of application documents (Version 11).
- 1.6 The categories of Books are set out in Table 1. The Application comprises seven Books.
