#### 1. Introduction

#### 1.1. Purpose of this document

1.1.1. The purpose of this document is to set out the current status of negotiations between RWE (the Applicant) and each landowner with land interests affected by the powers of compulsory acquisition sought by the Applicant to deliver Byers Gill Solar (the Proposed Development).

- 1.1.2. This document has combined the latest submitted Compulsory Acquisition Schedule (Change Only) [REP6b-021] and Compulsory Acquisition Schedule [REP6-026] to show all Affected Parties (AP) in a single document. Substantive updates are shown in the track change version of Table 2-1 below.
- 1.1.3. This document relates to the land interests affected by the Applicant's change application, made on 18 October 2024, only. It therefore updates the position on those land interests as reported in the Compulsory Acquisition Schedule [CR1-011] submitted on 18 October 2024.
- 1.1.4. In respect of each relevant landowner, Table A-1 of this document summarises:
  - the landowner's interest in the relevant land plots identified in the Book of Reference,
  - the type of rights sought to be acquired compulsorily by the Applicant,
  - the current status of negotiations between the parties for the Applicant to secure the necessary rights through voluntary agreement, and
  - the status of any objection or other representation submitted by each landowner to the Examination.
- 1.1.5. This document will be further updated at each requested deadline of the Examination.
- 1.1.6. This document has been updated in response to matters raised at CAH2 held on 15 January 2025. The Applicant has reviewed all submissions and enquiries that have been made by the Affected Parties to establish whether objections have been received outside of the Applicant's formal consultation held from 7 November, or through the Relevant Representations and Written Representations submitted to the Planning Inspectorate for the Change Request. The Schedule has been updated to reflect the latest position known to the Applicant at Deadline 8 in respect of the landowners listed.
- 1.1.7. The Applicant will write to all APs informing them of the close of the Examination and that their position has been recorded in this document in the week commencing 20 January (when this document is made available on the Planning Inspectorate website). The Applicant has also written to the new interests with unique reference number 187, 188 and 189 in this table that have been identified as part of due diligence land registry refresh.
