1. Introduction

1.1. Purpose of this document

- 1.1.1. This Updated Guide to the Application has been prepared on behalf of Enso Green Holdings D Limited (the 'Applicant') in relation to an application for a Development Consent Order (DCO) for the Helios Renewable Energy Project (the 'Proposed Development').
- 1.1.2. This Updated Guide to the Application ('Updated Guide') has been prepared to help the Examining Authority (ExA) and Interested Parties understand the Application by signposting documents that make up the Application.
- 1.1.3. This Updated Guide should be read in conjunction with Sections 0 to 8 of the **Guide to the Application [APP-004]**. Section 9 of the **Guide to the Application [APP-004]** is superseded by this Updated Guide.

2. Application Documents Tracker

- 2.1.1. The documents submitted as part of the DCO Application have been grouped into volumes as detailed in **Table 2.1** Guide to Application Volumes below.
