



1. Introduction

1.1 Purpose of this Document

- 1.1.1 This Statement of Common Ground (SoCG) has been prepared to support an application for the proposed Tillbridge Solar Project ("the Application" or "the Scheme") made by Tillbridge Solar Limited ("the Applicant"). The Application was submitted to the Secretary of State for Energy Security and Net Zero ("the Secretary of State") for a Development Consent Order (DCO) ("the Order") under section 37 of the Planning Act 2008 ("PA 2008") (Ref 1) and accepted for examination on 8 May 2024.
- 1.1.2 This SoCG does not seek to replicate information which is available elsewhere within the Application documents. All documents are available in the deposit locations and/or on the Planning Inspectorate's website at <https://national-infrastructure-consenting.planninginspectorate.gov.uk/projects/EN010142/documents>.
- 1.1.3 SoCGs are an established means in the planning process of allowing all parties to identify and focus on specific issues that may need to be addressed during the examination. This SoCG has been produced to confirm to the Examining Authority (ExA) where agreement has been reached between the parties and where agreement has not (yet) been reached. The SoCG will be progressed during the pre-examination and examination periods to reach a final position between the Parties and to clarify if any issues remain unresolved. This SoCG will be revised and updated as appropriate and/or required by the ExA at relevant examination deadlines.

1.2 Parties to this Statement of Common Ground

- 1.2.1 This SoCG has been prepared between (1) the Applicant and (2) Anglian Water Services Limited (jointly referred to as "the Parties").
- 1.2.2 The Applicant is a joint venture between Tribus Clean Energy Limited and Recurrent Energy, a subsidiary of Canadian Solar, who are both experienced developers of renewable energy projects.
- 1.2.3 Anglian Water Services Limited ("Anglian Water") is listed as a Statutory Consultee as part of the DCO Application. As a statutory undertaker whose functions are likely to be affected by the Scheme, Anglian Water is a prescribed consultee under Schedule 1 of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 ("APFP Regulations"). The Applicant has accordingly consulted with Anglian Water during the preparation of the Application and following its acceptance.
- 1.2.4 The **Book of Reference [EN010142/APP/4.3(Rev04)]** and **Land and Crown Land Plans [AS-040]** identify apparatus for Anglian Water in the following plots 1-07, 12-01, 12-03, 13-07, 13-10, 13-19, 14-01a, 15- 01, 16-03, 17-06e, 17-07, 18-07, 18-08, 18-22, 19- 02, 19-07, 19-11, 20-01, 21-08, 21-08a, 21-08b, 21- 08c, 21-08d, 21-23, 21-26, 22-03, 23-02, 23-03, 23- 05, 5-12a, 9-10 and 9-11. The Parties are currently working to put in place relevant protective provisions to ensure that Anglian Water's functions as a statutory undertaker are not adversely impacted by the Scheme.

1.3 The Scheme

- 1.3.1 The Order, if granted, would authorise the construction, operation (including maintenance), and decommissioning of ground-mounted solar photovoltaic (PV) arrays. The Scheme will also include associated development to support the solar PV arrays.
- 1.3.2 The Scheme is made up of the Principal Site, the Cable Route Corridor and works to the existing National Grid Cottam Substation. The Principal Site comprises the solar PV arrays, electrical substations, grid balancing infrastructure, cabling and areas for landscaping and ecological enhancement.
- 1.3.3 The associated development element of the Scheme includes but is not limited to access provision; a Battery Energy Storage System (BESS), to support the operation of the ground mounted solar PV arrays; the development of on-site substations; underground cabling between the different areas of solar PV arrays; and areas of landscaping and biodiversity enhancement.
- 1.3.4 The Scheme also includes a 400kV underground Cable Route Corridor of approximately 18.5km in length connecting the Principal Site to the National Electricity Transmission System (NETS) at the existing National Grid Cottam Substation. The Scheme will export and import electricity to the NETS.

1.4 Terminology

- 1.4.1 Section 2 of the SoCG provides a high-level overview of the correspondence to date between the Parties. This record of engagement is not exhaustive of all communications but focuses on those which are more pertinent to the Application and Anglian Waters interests.
- 1.4.2 Section 3 of the SoCG summarises the issues that are ‘agreed’ or are ‘under discussion’.
- 1.4.3 These terms are used as follows:
 - a. “Agreed” indicates where the issue has been resolved;
 - b. “Under discussion” indicates where these points will be the subject of on-going discussion wherever possible to resolve, or refine, the extent of disagreement between the parties;
 - c. “Not Agreed” indicates a final position where the Parties have agreed to disagree.

2. Record of Engagement

2.1.1 A summary of all meetings and correspondence that have taken place between the Parties in relation to the Application is outlined in **Table 1**. This includes email correspondence between the Parties to discuss sharing of information, arrangement of meetings and, where appropriate, to comment on draft documentation. **Table 1** reflects the key meetings and emails to date.

This can be found in Table 10-5 in Chapter 10: Water Environment of the ES [REP3-012].</p> <p>Following a meeting on 20 January 2025, Anglian Water reviewed the information provided by the Applicant on 14 February 2025 and consulted with their Operations team regarding the potential impact the Scheme could have on Anglian Water assets as identified in the Book of Reference [EN010142/APP/4.3(Rev04)]. At a subsequent meeting on 18 March 2025, the Applicant confirmed that, in accordance with the Protective Provisions, they will provide a plan for any proposed works within a certain proximity to Anglian Water assets, which will be subject to Anglian Water's approval. Furthermore, the Applicant highlighted the ability for Anglian Water to access their apparatus in the public highway for maintenance purposes under the Protective Provisions.</p>
