Notice of Duty to Notify Secretary of State of proposed application in accordance with section 46 of the Planning Act 2008 (as amended) (the Act)

We are writing to notify you, in accordance with section 46 'Duty to notify Secretary of State' of the Act that SSE Renewables and Equinor, acting through Doggerbank Offshore Wind Farm Project 4 Projco Limited (company number 13587611) of No.1 Forbury Place, 43 Forbury Road, Reading, United Kingdom, RG1 3JH (**the Applicant**) intend to apply to the Secretary of State under section 37 of the Act for a Development Consent Order (**DCO**) to construct, operate, maintain and decommission an offshore wind farm known as the Dogger Bank D Offshore Wind Farm (**the Project**).

As the proposed generating capacity exceeds 100 megawatts (MW), the Project is classified as a Nationally Significant Infrastructure Project under section 15(3) of the Act and therefore requires development consent.

The Applicant expects to submit the DCO application for the Project in 2026. The DCO application will include full details of the Project and will be accompanied by an Environmental Statement (**ES**), prepared in accordance with section 37(3) of the Act and the Infrastructure Planning (Environmental Impact Assessment (EIA)) Regulations 2017 (the EIA Regulations).

The Project

The offshore wind turbines will be located in the Dogger Bank area of the southern North Sea, covering a total area of 262km² and is situated approximately 210km off the Yorkshire coast. Electricity generated from the Project will be transmitted to shore via offshore export cables, making landfall southeast of Skipsea in East Riding of Yorkshire. From there, underground onshore high voltage direct current (HVDC) cables will connect to a converter station, with high voltage alternating current (HVAC) cables continuing to the proposed National Grid Birkhill Wood Substation. Note that Birkhill Wood Substation is being developed separately by National Grid Electricity Transmission (NGET) and does not form part of the Project proposals.



Project Infrastructure

The Project will include both permanent and temporary infrastructure across the offshore and onshore development areas. This will include, but is not limited to:

- Offshore infrastructure such as offshore wind turbines and associated foundation structures, offshore platform(s) and associated foundation structures, inter-array cables and offshore export cables:
- Landfall infrastructure including a transition joint bay and associated underground link box to connect the offshore and onshore export cables;
- Onshore infrastructure including underground HVDC cables (up to 500kV), HVAC cables (400kV), jointing bays, link boxes, a converter station, energy storage and balancing infrastructure, and a connection to the national grid; and
- Environmental areas for biodiversity net gain, enhancement and/or mitigation, with permanent access for operation and maintenance of those areas.

Statutory Consultation

The Applicant will begin consultation with consultation bodies identified under section 42 of the Act on **Tuesday 10 June 2025**. The consultation will close at **23:59** on **Tuesday 5 August 2025**. In accordance with section 45(2) of the Act, everyone consulted will have at least 28 days from the day after they receive the consultation documents to submit their comments.

Statutory Consultation under section 42 of the Planning Act 2008 (the Act) and Regulation 13 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the EIA Regulations)

We are writing to consult with you regarding the proposed application for the Dogger Bank D Offshore Wind Farm (the Project). You have either been identified as a prescribed consultee for the purposes of section 42 of the Act 2008 and/or Regulation 13 of the EIA Regulations or because we believe it is appropriate to seek your views as a non-statutory consultee.

Background

SSE Renewables and Equinor, acting through Doggerbank Offshore Wind Farm Project 4 Projco Limited (**the Applicant**), are developing the Project, a proposed offshore wind located in the North Sea. The Project has the potential to export up to 1.5 gigawatts (GW) of renewable electricity and is expected to support the UK's Net Zero targets.

As the proposed generating capacity exceeds 100 megawatts (MW), the Project is classified as a Nationally Significant Infrastructure Project (NSIP) under sections 14(1)(a) 15(3) of the Act and therefore requires development consent. As a result, an application for development consent will be



prepared in accordance with section 37 of the Act. The Applicant expects to submit the DCO application in 2026.

The Application

Notice is hereby given that SSE Renewables and Equinor acting through Doggerbank Offshore Wind Farm Project 4 Projco Limited of No.1 Forbury Place, 43 Forbury Road, Reading, United Kingdom, RG1 3JH (the "Applicant"), are proposing to submit an application to the Secretary of State for Energy Security and Net Zero under Section 37 of the Planning Act 2008 for development consent (the "Application") for the Project.

Dogger Bank Wind Farm is the world's largest offshore wind farm in construction, located in the North Sea. The first three phases of Dogger Bank Wind Farm, Dogger Bank A, B and C, are underway. The Project is a proposed fourth phase which seeks to maximise the capacity of the eastern portion of the original Dogger Bank C area. The Project has the potential to export up to 1.5GW of energy and is expected to support the UK's Net Zero targets.

The Project is a development for which development consent is required under Section 31 of the Planning Act 2008. As the Project is an offshore generating station with a proposed capacity of more than 100MW it is classified as a nationally significant infrastructure project under Sections 14(1)(a) and 15(3) of the Planning Act 2008.

The Application will seek powers for the Applicant to construct, operate and maintain and decommission the Project. It will also cover:

- The temporary and permanent compulsory acquisition of land and/or rights which are required for the Project and/or are required to facilitate or are incidental to the Project;
- Overriding easements and other rights over or affecting the land for the Project;
- The application and/or disapplication of legislation relevant to the Project including legislation relating to compulsory acquisition; and
- Such ancillary, incidental and consequential provisions, permits and consents as are necessary and convenient including deemed marine licences.

About the Project

The Project will comprise both permanent and temporary infrastructure for the generation and transmission of electricity from up to 113 wind turbines in the array area located in the Dogger Bank, North Sea. Electricity generated from the Project will be transmitted to shore via offshore export cables, making landfall southeast of Skipsea in East Riding of Yorkshire. From there, underground onshore high voltage direct current (HVDC) cables will connect to a converter station, with high voltage alternating current (HVAC) cables continuing to the proposed National Grid Birkhill Wood Substation. Note that Birkhill Wood Substation is being developed separately by National Grid Electricity Transmission and does not form part of the Project proposals.

Project infrastructure will comprise, but is not limited to:

- Offshore infrastructure including offshore wind turbines and associated foundation structures, offshore platform(s) and associated foundation structures, inter-array cables and offshore export cables;

The Project is an "EIA development" for the purposes of the EIA Regulations and an ES will form part of the Application.

The Project is consulting on its preliminary assessment of the environmental effects that are compiled in a Preliminary Environmental Information Report (PEIR) and is accompanied by a Non-Technical Summary (NTS) of the PEIR.
