of oral presentation made at the Preliminary Meeting (PM) by Dr the Begbroke & Yarnton Green Belt Campaign (BYG). At the PM Dr spoke on matters relating to site selection, already alluded to in BYG's Relevant Representation. He made a general point about the Applicant seemingly not attempting to select a site which avoided impact on "best and most versatile" agricultural land; on the Green Belt; and on the Blenheim Palace World Heritage Site. also referred at the PM to the Rochdale Envelope and questioned how it would be used in the ExA. Regarding this, _____, Chair of BYG, when requesting Dr. attendance at the PM submitted BYG's thoughts on this subject in an email. This has been numbered PDA-004. [This matter was also discussed at ISH1.] Finally at the PM, Dr. asked for clarification in respect of the "Brief Amplification" of the Assessment of Alternatives regarding the reference to "preferred routes", "potential routes" and "blocking valve stations". We understand from the ExA's helpful response that the "routes" are cable routes and that the inclusion of blocking valve stations was an error. **END**
