Notice of variation to the examination timetable

We write to provide notification that the Examining Authority (ExA) has made a procedural decision to vary the examination timetable relating to the Applicant's forthcoming second change request. The variation is set out in **annex A and in summary:**

One additional variation is the formal inclusion of the submission on the applicant's second change request at Deadline 5, in accordance with the ExA's instructions for that change request set out in [PD-011].
