Purpose of OFH3

The main purpose of the Open Floor Hearing is to hear from those Interested Parties and/ or Affected Persons on the application, as varied by the Applicant's proposed second change request.

Attendees

Each Interested Party (IP) who has indicated a wish to speak will be invited in turn by the ExA to speak. Following each submission, the ExA may wish to ask the speaker questions.

The IPs who have registered to speak will be given five minutes within which to set out their case, after which the ExA may ask questions or seek clarifications. The calling/ running order for the Hearing is set out in **Annex A**, with some indicative timings to aid understanding.

The Applicant will be invited to respond to all of the points raised by the attendees at the end of the public speaking session in agenda item 3, though reserve the right to respond in writing by the next available deadline in the Examination timetable.

Registration Process

Parties who have registered to speak (both in person and virtually) will receive a Joining Instruction email shortly before the Hearing which will include a link to the virtual event on Microsoft Teams, and a telephone number should they need to participate by telephone. To enable the Hearing to start on time at **09:30am** those attending virtually should join promptly at **9:00am**. This will ensure that all virtual attendees can complete the registration process in good time.

Procedure at OFH3

Guidance under the Planning Act 2008 and the Infrastructure Planning (Examination Procedure) Rules 2010 provides that it is for the ExA to probe, test and assess the evidence through direct questions of persons making oral representations at Hearings. Questioning at the Hearing will be led by the ExA. Cross questioning of a person giving evidence by another person will only be permitted if the ExA decides it is necessary to ensure representations are adequately tested or that an IP has had a fair chance to put its case.
