### **Springwell Solar Farm – Deadline 2 Submissions**

On behalf of Springwell Energyfarm Limited (the 'Applicant') and further to the publication of the **Rule 6 letter** [PD-005] on 9 April 2025 and the **Rule 8 letter** [PD-006] on 13 May 2025, we write to provide the Applicant's written submissions for Deadline 2 of the Springwell Solar Farm Development Consent Order (DCO) Examination.

#### Submissions made at Deadline 2

Appendix 1 of this letter provides an overview of the documents submitted by the Applicant at this Deadline. Table 1 comprises the application documents for which updated versions are being submitted, and summarises how and why each document has been updated. Each updated document has been submitted with both clean and tracked change versions to aid the Examining Authority (the 'ExA') in identifying the changes made.

Table 2 comprises new documents being submitted which were requested by the ExA in the Rule 8 letter to be provided by the Applicant at Deadline 2. These are provided in response to submissions made at Deadline 1, and following further engagement with Interested Parties. These are included within a new Part 8 – Examination Documents and are also identified in the **Guide to the Application [EN010149/APP/1.2.4]**, which sets out the current status of documents.

Revised documents are submitted with both tracked change and clean versions to aid signposting to where changes are made. The exclusions to this are the ES Figures packages (ES Volume 2) and the Plans submitted as Part 2 of the DCO application, where a Revisions Schedule has been provided as part of those documents.

#### **Cumulative Assessment**

At Deadline 1, a revised version of **ES Volume 1, Chapter 16: Cumulative Assessment [EN010149/APP/6.1.2]** was submitted at to take account of the Leoda Solar Farm (EN0110016) for which the EIA Scoping Report was submitted in January 2025.

This ES Chapter is being submitted at Deadline 2 to include a full update of the inter-project long and short lists, with an assessment cut-off date of 30 May 2025. The same process will be repeated for Deadline 4, with an assessment cut-off date of 29 August 2025.



#### **Environmental Management Plans**

The Applicant has continued to engage with the Ministry of Defence following submission of their Relevant Representation [RR-278] and has updated the Outline Construction Environmental Management Plan [EN010149/APP/7.7.3], the Outline Operational Environmental Management Plan [EN010149/APP/7.10/3] and the Outline Decommissioning Environmental Management Plan [EN010149/APP/7.13.3] to each include a new Works Management Plan appendix for submission at Deadline 2. As each of these new appendices contains a plan that remains under discussion between the Applicant and the Ministry of Defence, a Confidential version is submitted alongside clean and tracked versions to provide details of that plan for the ExA.

The **Draft DCO [EN010149/APP/3.1.2]** [REP1-006] will be updated at Deadline 3 to include these revisions in Schedule 13 – Certified Documents.

### Statements of Common Ground ('SoCGs')

The Applicant worked with key stakeholders throughout the pre-submission and preexamination stages to draft SoCGs, and a summary of the status of discussions was set out in the Statement of Commonality submitted as part of the DCO Application.

The **Rule 8 letter** [PD-006] requests submissions of SoCGs by the Applicant at Deadlines 2, 3 and 5. The Applicant was able to submit draft SoCGs at an earlier deadline (Deadline 1) to aid the ExA. Updated SoCGs will be submitted at Deadlines 3 and 5 as requested.
