## Accompanied site inspection itinerary – 18 July 2025

The itinerary for the accompanied site inspection (ASI) can be found below.

Case Team

Please note that the Examining Authority's (ExA) inspection of sites is not an opportunity to provide any oral representations on the project or discuss evidence. It is an opportunity for the ExA to look at the physical features that can be seen on, or from the sites. Participants may be invited by the ExA to point out specific features or sites of interest.

If you would like to make oral representations please attend the open floor hearing on the evening of 15 July 2025, as detailed in the hearing notification.

#### Joining the site visit

The site inspection will commence at 9:15am at The Venue, Navenby, LN5 0JJ. Participants are asked to assemble promptly as the ExA will not wait for parties who are not present at the start time.

The deadline by which parties were asked to request attendance at the ASI was Tuesday 8 July 2025. To ensure the smooth running of the ExA's inspection, we ask that attendees notify the case team if there are any changes in attendance, and ensure The Planning Inspectorate is made aware of any special access requirements.

### Clothing

Attendees are recommended to wear appropriate sturdy footwear and weather appropriate clothing. The Applicant will provide Personal Protective Equipment, if required.

#### Sites on private land

Access onto private land is at all times by permission of the person controlling it; householders, occupiers and landowners may refuse to allow some persons accompanying the ExA onto their land. Under those circumstances, the ExA will decide whether or not to proceed with that part of the inspection and may ask those refused access to wait outside.

## Detailed itinerary for accompanied site inspection

Please note that the inspection point numbers below correspond to the proposed inspection points in the Applicant's draft itinerary [REP1-076]. In finalising the itinerary, the ExA has made the following changes to the Applicant's draft itinerary:


- Inspection points 4 (Green Man Road), 5 (Heath Lane) and 8 (Junction of Navenby Lane and Main Street) have been removed from the itinerary as these locations can all be easily viewed from public land and will be visited by the ExA on a further unaccompanied site inspection (USI).
- Inspection points 6 (Route from Gorse Hill Lane to St John the Baptist Church) and 12 (Low Field Farm) have been removed from the itinerary as these locations were visited by the ExA on USI1 [EV1-001].
- Inspection point 13 (Spires and Steeples Way) has been removed from the itinerary as this route was also walked by the ExA on USI1 and will be revisited by the ExA on the further USI.

10:05 – 10:20	2	Toll Bar Cottages, LN4 3JN	Turning back onto the A15, travel southbound to Toll Bar Cottages. Park at the Toll Bar Equestrian car park and reach inspection point.
10:30 – 10:45	3	Junction of A15 and B1191 (nearest postcode LN4 3JJ)	Continue southbound on the A15. Drive will allow attendees to consider design response along the A15 and passes Viewpoint 29. Turn right onto Temple Road, parking on lay-by and walking to the inspection point utilising field margin.
11:00 – 11:15	Break (15 minutes)	The Venue, Navenby, LN5 0JJ	Continue westbound on Temple Road, passing Viewpoint 32 before turning right onto Pottergate Road to return to The Venue for a comfort break.

Turn left onto the B1191, travelling towards Scopwick Mill, passing RAF Digby and viewpoint 18. Park on track adjacent to the property.
12:25 – 12:55	Lunch (30 minutes)	Scopwick Village Hall, Scopwick, LN4 3PA	Continue eastbound on the B1191. Turn right onto the B1188 and then left onto Main Street, arriving at Scopwick Village Hall for a lunch break.
13:10 – 13:35	10	Route from Scopwick Mill towards B1191 Start: Scopwick Mill, Heath Road, LN4 3JB End: LN4 3JD	Drive back towards Scopwick Mill via the B1191. Drive up the track adjacent to the Scopwick Mill to begin walking route (c. 1.10km), connecting to Rows/5/1 footpath. Meet the vehicle on track to wastewater plant.
