The ExA may ask questions of IPs and Non-IPs about matters arising from written and oral submissions. If they do so during a timed oral submission, the time taken by the ExA will not count against the speaking time.

- 5. Close of the Hearing**

Purpose of OFH

Open Floor Hearings are your opportunity to raise anything directly to the Examining Authority that is important and relevant and that you think we should know about and consider. They are not about a particular location or topic. The topic of your representations about the proposals is therefore up to yourself.

Attendees

Anyone wishing to attend the Hearing in person, who has not already advised the Case Team of this, should do so as soon as possible.

The event will be livestreamed and a link for watching the livestream will be posted on the [project webpage of the National Infrastructure Planning website](#) closer to the Hearing date. Interested Parties and members of the public who wish to observe the Hearing can therefore view and listen to the Hearing using the livestream, or view and listen to the recording, after it has concluded.

Timing

The ExA will keep to the agenda as much as possible. The hearing is not expected to go beyond 20.00.

Anyone who is not able to provide all their oral submissions by the close of the hearing should follow it up in writing.

Registration Process

Parties who have registered to speak (both in person and virtually) will receive a Joining Instruction email shortly before the Hearing which will include a link to the virtual event on Microsoft Teams, and a telephone number should they need to participate by telephone. To enable the Hearing to start on time at 17.00 those attending virtually should join promptly at 16.30 to ensure that all virtual attendees can complete the Registration Process in good time.

Procedure at OFH

Guidance under the Planning Act 2008 and the Infrastructure Planning (Examination Procedure) Rules 2010 provides that it is for the ExA to probe, test and assess the evidence through direct questions of persons making oral representations at Hearings. Questioning at the Hearing will be led by the ExA.
