Springwell Solar Farm – Deadline 3 Submissions

On behalf of Springwell Energyfarm Limited (the 'Applicant') and further to the publication of the **Rule 6 letter** [PD-005] on 9 April 2025 and the **Rule 8 letter** [PD-006] on 13 May 2025, we write to provide the Applicant's written submissions for Deadline 3 of the Springwell Solar Farm Development Consent Order (DCO) Examination.

Submissions made at Deadline 3

Appendix 1 of this letter provides an overview of the documents submitted by the Applicant at this Deadline. Table 1 comprises the application documents for which updated versions are being submitted, and summarises how and why each document has been updated. Each updated document has been submitted with both clean and tracked change versions to aid the Examining Authority (the 'ExA') in identifying the changes made.

Table 2 comprises new documents being submitted which were requested by the ExA in the Rule 8 letter to be provided by the Applicant at Deadline 3. These are provided in response to submissions made at Deadline 2, and following further engagement with Interested Parties. These are included within Part 8 – Examination Documents and are also identified in the **Guide to the Application [EN010149/APP/1.2.4]**, which sets out the current status of documents.

Revised documents are submitted with both tracked change and clean versions to aid signposting to where changes are made. The exclusions to this are the ES Figures packages (ES Volume 2) and the Plans submitted as Part 2 of the DCO application, where a Revisions Schedule has been provided as part of those documents.



Cumulative Assessment

At Deadline 1, a revised version of **ES Volume 1, Chapter 16: Cumulative Assessment [EN010149/APP/6.1.2]** was submitted to take account of Leoda Solar Farm (EN0110016) for which the EIA Scoping Report was submitted in January 2025. This ES Chapter was then submitted again at Deadline 2 following a full update of the inter-project long and short lists **[EN010149/APP/6.1.3]**.

A further update to this ES Chapter **[EN010149/APP/6.1.4]** is being submitted at Deadline 3 to respond to Action Points arising from Issue Specific Hearing 4 held on 17 July 2025 and to consider the recently-issued Scoping Report for the National Grid Navenby Substation. A full update of the chapter will be submitted at Deadline 4, with an assessment cut-off date of 29 August 2025.

Statements of Common Ground ('SoCGs')

The Applicant has worked with key stakeholders throughout the pre-submission and preexamination stages to draft SoCGs, and a summary of the status of discussions was set out in the Statement of Commonality submitted as part of the DCO Application.

The **Rule 8 letter** [PD-006] requests submissions of SoCGs by the Applicant at Deadlines 2, 3 and 5. SoCGs are being submitted for a number of parties at Deadline 3; with the Environment Agency and National Highways SoCGs as signed 'draft' versions. Final signed versions will be submitted at Deadline 4.

In the cases of Anglian Water, Exolum, Cadent and Lincolnshire Fire and Rescue Service, there have been no changes to agreed matters and protective provisions are being finalised by the Applicant's legal team. The final SoCGs will be submitted when available by Deadline 5.
