1. Introduction

1.1. Purpose of this document

- 1.1.1. This Schedule of Changes to the Book of Reference (BoR) relates to an application made by Springwell Energyfarm Ltd (the “Applicant”) to the Secretary of State for Energy Security and Net Zero via the Planning Inspectorate under section 37 of the Planning Act 2008 (the “2008 Act”) for a Development Consent Order (“DCO”). If made, the DCO would grant consent for the Applicant to undertake the Springwell Solar Farm proposed development (the “Proposed Development”).
- 1.1.2. The DCO application was accepted for examination on 18 December 2024.
- 1.1.3. This Schedule of Changes details all amendments to plots and land ownership information identified through ongoing engagement with landowners, and updates by provided by the Examination Authority, throughout the examination process. As such, this Schedule of Changes should be read in conjunction with the **BoR [EN010149/APP/4.3]** and the **Land Plans [EN010149/APP/2.2]**.
- 1.1.4. This document has been updated at Deadline 4 to demonstrate the ongoing land referencing due diligence, and to show any new legal interests in the order land which have been identified since submission through these methods.
