## DEADLINE 1 – ENVIRONMENT AGENCY WRITTEN REPRESENTATION. BEACON FEN ENERGY PARK, LINCOLNSHIRE

Following our Relevant Representation (RR) [RR-006] dated 2 July 2025, we have continued to engage with the Applicant and their consultants on the fluvial flood modelling and the breach modelling for the Proposed Development. At the time of writing, neither the fluvial flood modelling and the breach modelling are ready to be signed off.

Following Issue Specific Hearing 1, which took place on 24 September 2025, the Applicant and their consultants have reached out to the Environment Agency to request meetings to discuss issues raised in our RR. These meetings are set to take place on 7 and 10 October 2025. At the time of writing, all issues raised in our RR remain outstanding.
