## 1. Introduction

#### 1.1 Overview

- 1.1.1 An Application for Beacon Fen Energy Park ("the Proposed Development") was made by Beacon Fen Energy Park Limited ("the Applicant") to the Secretary of State for Energy Security and Net Zero ("the Secretary of State") for a Development Consent Order (DCO) ("the Order) under section 37 of the Planning Act 2008 ("PA 2008") (Ref. 1).
- 1.1.2 On 12 August 2025, the Examining Authority (ExA) issued its Rule 6 letter [PD-003] which set out in Annex D a request for a draft itinerary for the Accompanied Site Inspection (ASI) to be submitted by the Applicant at Deadline 1 (Tuesday 07 October 2025).
- 1.1.3 To support this, Annex D of the Rule 6 letter also sets out the request for suggested location(s) for site inspections (accompanied or unaccompanied), including justification and whether the locations require access to private land (if any) for Procedural Deadline A (Tuesday 16 September).
- 1.1.4 Following this, comments on the Applicants draft itinerary for the ASI will be submitted to the ExA for Deadline 2 (Tuesday 21 October 2025).
- 1.1.5 These timescales were later confirmed in the ExA's Rule 8 Letter on 1 October 2025.
- 1.1.6 The Applicant notes that during Issue Specific Hearing 1 held 24 September 2025 the ExA requested that the Applicant (and other parties who suggested potential ASI locations) considered whether they needed to be visited as part of an ASI or whether the ExA could visit them unaccompanied but with prearranged access where required for non-publicly accessible, private land.
- 1.1.7 The Applicant believes that a site visit to the locations previously suggested in the Applicant's Suggested Locations for Site Inspections [PDA-008] could be visited unaccompanied, as the Applicant can arrange access to the locations located on private land at the ExA's convenience.
- 1.1.8 With regards to the locations suggested by North Kesteven District Council (NKDC) [PDA-015] and Boston Borough Council (BBC) [PDA-016], following engagement with both the Applicant agrees that it may be helpful for the ExA to also visit the Public Right of Way Bick/2/1 by Bicker Fen Substation (location 9 in table 2.1) and long distance view of Kyme Tower (location 12).
- 1.1.9 Nevertheless, for robustness the Applicant has prepared a draft itinerary which includes all of the locations suggested by the Applicant, in addition to all those suggested by NKDC and BBC.
- 1.1.10 Regard has also been had to the note detailing the ExA's Unaccompanied Site Inspection on 10 July 2025 [PD-002] to avoid duplication, unless private views from certain receptors were specifically requested by NKDC or BBC. This means that locations 1, 5, 7, 10, 11 14 and 16 as set out in Figure 2.1 are not included in the itinerary.



# 2. Draft Itinerary for the ASI

## 2.1 General Arrangements

#### Preparation of the draft itinerary

- 2.1.1 The Applicant has set out the planned inspection points for the ASI, as well as approximate timings and information relevant to the location in **Table 2.1** below. The locations of the inspection points are shown in **Figure 2.1** with those in yellow suggested by the Applicant (numbers 1 to 7), those in blue suggested by NKDC (numbers 12 to 25) and those in green suggested by BBC (numbers 8 to 11).
- 2.1.2 The draft itinerary has been prepared having reviewed the locations submitted by Interested Parties at Procedural Deadline A, as set out in paragraph 1.1.10, and the Applicant's own suggestions.

#### **Timings and Assumptions**

- 2.1.3 The Applicant believes this ASI could be carried out in just over a half a day.
- 2.1.4 The Applicant also believes this could be carried out unaccompanied, in which case the timings would not change.
- 2.1.5 This itinerary has been drafted on the basis that any included PRoWs will be accessible at the time of the site inspection. It has not been possible to verify this on the ground however; the Applicant has reviewed Lincolnshire's Public Rights of Way website<sup>1</sup> and LCC have also confirmed that the suggested PRoWs remain active.

#### **Transport**

- 2.1.6 Should an ASI be held, the Applicant will provide transport for all attendees during the ASI for convenience due to the limited number of parking spaces close to many of the inspection locations. Attendees will need to make their own arrangements to get to and from the meeting place.
- 2.1.7 The transport provided by the Applicant will return to the meeting place upon the conclusion of the ASI.
- 2.1.8 The Applicant can confirm that all of the Applicant's chosen locations can be accessed using a standard vehicle or on foot from a short distance away.

### **Health and Safety**

2.1.9 For the safety of themselves and others, attendees will be required at all times to comply with the Applicant's applicable site security and safety requirements, for which a briefing will be provided.

- 2.1.10 A first aid kit will be provided on the transport for the ASI, and the Applicant will provide a qualified first aider.
- 2.1.11 The Applicant will carry out a briefing ahead of the start of the ASI. The aim of this briefing will be to ensure that attendees are aware of any health and safety risks. It is important to follow all instructions and to remain with group.
- 2.1.12 Part of the ASI may involve walking in areas which have become muddy. Footwear should have ankle support and suitable grip. Long sleeve clothing/long trousers are recommended. Attendees are also recommended to bring waterproofs, sun cream and multiple layers due to the potential for changeable weather.

#### **Next Steps**

2.1.13 Interested Parties will have an opportunity to provide comments on this ASI Itinerary by 21 October 2025. Following this, should the ExA propose an ASI it will take place w/c 10 November 2025 and the ExA will publish the final Itinerary ahead of this.
