This submission constitutes the responses from Boston Borough Council (BBC) to the questions raised by the ExA in ExQ1 (PD-007). The responses are set out in an amended form of the table provided by the ExA in ExA Q1. The table has been amended to delete the questions which are not addressed to BBC and add a response column.

The ExA also asks to be kept up-to-date on changes to the status of any development plan which a local authority has previously relied upon during examination.	Appendix A of the Local Impact Report contains the wording of the relevant local planning policies from the SELLP referenced within BBC's submissions. The South East Lincolnshire Local Plan'(SELLP) 2011-2036, was adopted on 8th March 2019. The South East Lincolnshire Joint Strategic Planning Committee met on 1 July 2024 to consider a report on the review that had been undertaken on the SELLP. The conclusion of the review was that (a) the 5-year review of the SELLP had been completed and that, based on the review that had taken place, (b) there was no requirement to update the Local Plan at that time. BBC will keep the ExA updated on any change to the status of the policies of the SELLP of the Local Plan itself during the Examination.

Are the HLAs content with the applicant's policy analysis?	BBC have previously agreed the relevant local planning policies for the Proposed Development with the Applicant which is contained within the current draft SoCG (APP-283). For the avoidance of doubt these are: • Policy 1 Spatial Strategy (Part D) • Policy 2 'Development Management' • Policy 3 'Design of New Development' • Policy 4 'Approach to Flood Risk' • Policy 28 'The Natural Environment' • Policy 29 'The Historic Environment' • Policy 30 'Pollution' • Policy 31 'Climate Change and Renewable and Low Carbon Energy' • Policy 32 Community, Health and Well Being (Part 1) The agreed policies within the draft SoCG go further than that of the EIA Scoping Report which quotes only policies 4, 29 and 31 from the SELLP. The submitted Planning Statement (APP-277) aligns with the draft SoCG referencing the above policies at table 5.3. Table 4C at Appendix 4 to the Planning Statement sets out assessment against these policies.

BBC Answer to GCT 1.2 continued

The Applicants assessment of these particular policies should be considered in the context of BBC's LIR (REP1-059) and WR (REP1-060) submitted at deadline one which sets out a number of concerns in relation to:

- The loss of agricultural land, including high quality Best and Most Versatile Agricultural Land.
- The scale and significance of the impact on the landscape and visual amenity of the area including the impacts on Landscape Character Area, nearby residential properties and Public Rights of Way.
- Biodiversity Net Gain and impact upon LWS South Forty Foot Drain.
- The significance of disruption to the community during the construction phase

Until these matters are resolved with the Applicant or further discussions have taken place then BBC is unlikely to agree to the assessment of those policies that relate to the above subject matter.

The Applicant also makes the assessment against policies of the SELLP for the whole scheme i.e. suggest compliance with policies based upon infrastructure or enhancement that are not located within the Borough's area.

	 The Applicant when assessing Policy 32 also references enhancement to PROW via the new footbridge over the dyke on the northeast border, connecting the PRoW to a wider network of PRoWs and safe crossing points will be created for the PRoWs that cross the Bespoke Access Road, however these are not located within the Borough either.

Application reference B/25/0224 should be added to the list and considered due to the overlap and being adjacent to the Order Limits accepting however that the application is yet to be determined.

The ExA asks for a list of topics to be submitted which you believe would benefit from being examined in a hearing context and why a hearing, as opposed to written representations, would be needed?	BBC consider that landscape and visual effects of the extension to the Substation at Bicker Fen particularly in regard to the mitigation proposed, BNG and the Construction Impacts including Cumulative Impacts should be considered for a future Hearing Topic. The reasons for the request are so that: • the landscape and visual mitigation and BNG for the Borough can be thoroughly examined; and • to provide reassurance that all has been done that is possible to ensure that adequate construction impact management and mitigation is in place and secured within the Requirements of the draft DCO. BBC will however be discussing these matters with the Applicant as the Examination progresses.

Can the HLAs confirm their position in relation to the need for a s106 agreement and confirm if any discussions or consideration has been given to this?	BBC in their Written Representation (REP1-060) and Local Impact Report (REP1-059) have set out concerns regarding the mitigation of the landscape and visual effects of the extension to Bicker Fen Substation, BNG within the Borough and the uncertainty over the delivery of Socio-Economic benefits. The resolution of these concerns may result in the potential need for s106 agreement in regard to: • mitigation for the landscape and visual effects of the extension to the Substation, if not site-specific measures, then via contributions. • BNG measures that benefit the Borough, if not site-specific measures, then via contributions. • a Employment Skills and Education contribution that would secure funds for initiatives and commitments within the OSSCEP(APP-179). This is particularly in regard to (1) Reskilling of temporary farm workers to avoid economic displacement, and/or support in finding alternative agricultural work; and (2) Potential upskilling of local residents through apprenticeships and partnerships with local educational institutions. BBC intends to discuss these matters further with the Applicant through the Examination.

BBC notes that the designated heritage assets mentioned by Historic England are all within North Kesteven's area and as confirmed by our Local Impact Report BBC have an agreement with the County Council, that they will act on the Boroughs behalf in relation to Archaeology. BBC therefore have no comments to make with North Kesteven and the County Council better placed to answer this question.
