1. Introduction

- 1.1.1 This Change Request Application Index has been prepared on behalf of Beacon Fen Energy Park Ltd (the 'Applicant') it forms part of a Change Request relating to an application for a Development Consent Order ('DCO'), that has been submitted to the Secretary of State (the 'SoS') for the Department for Energy Security and Net Zero, under Section 37 of the Planning Act 2008 (the '2008 Act'). The DCO application was accepted for Examination on 1 May 2025 and the Examination commenced on 23 September 2025.
- 1.1.2 The Applicant is seeking development consent for the construction and operation of the Beacon Fen Energy Park, a solar photovoltaic (PV) and battery energy storage facility located approximately 6.5 km northeast of Sleaford and 2.5 km north of Heckington (hereafter referred to as the 'Proposed Development').
- 1.1.3 On 5 November 2025, the Applicant notified the Planning Inspectorate (PINS) of its intention to submit a request to change the DCO application to incorporate changes relating to the proposed extension works at the Bicker Fen Substation (**AS-029**). The Proposed Change to the Bicker Fen Substation extension works entails the inclusion of a new overhead line (OHL) tower of up to 56.2 metres (m) in height, additional cabling and changes to the Work Numbers shown on the **Works Plan (Document Ref: 2.4)** and described in Schedule 1 to the **Draft DCO (Document Ref: 3.1)** (hereafter referred to as the 'Proposed Change'). Further details of the Proposed Change are provided in the covering letter and documents submitted alongside this Application Index.
- 1.1.4 The Proposed Change will not alter the Order Limits as shown in the DCO application and does not include a request for additional powers of compulsory acquisition within the DCO Application. As such, the requirements of the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 (the CA Regulations) do not apply to this application.

1.2 Purpose of this Document

- 1.2.1 PINS has issued advice to applicants on how to request changes to applications for NSIPs after they have been accepted for examination 'Nationally Significant Infrastructure Projects: Changes to an application after it has been accepted for examination' (last updated March 2025). This Application Index has been prepared as part of 'Step 4 – change application' which states the change application must include 'a full schedule of all application documents and plans listing the revisions to each document and plan which would occur because of the change or, as necessary, marked as 'no change'.
- 1.2.2 This document has therefore been prepared to list all the application documents which are being submitted with the Change Request. Table 2.1 in Section 2 of this document lists all the DCO Application documents and their document reference assigned by the Applicant. The third column in Table 2.1

titled 'Document submitted for the Change Request on 17 December 2025?' confirms which documents have been submitted for the Change Request by containing a 'YES' in the relevant column and providing the revision number in the fifth column titled 'Revision Number for the Change Request'. Accordingly where a document is not being updated for the Change Request and there is no change the third column of Table 2.1 contains 'NO'.

- 1.2.3 Table 2.1 also identifies the documents which will be submitted should the Change Request be accepted by the Examining Authority. This is shown by a YES in the fourth column titled: 'Document to be submitted if and when the Change Request is accepted.' This relates to a small number of documents which supplement the information already provided in other documents submitted for the Change Request, or where changes will be incorporated into other changes to the document. The Applicant has provided commentary in the sixth column of table 2.1.
- 1.2.4 It should also be noted that the submitted Figure 6.31 Landscape Strategy Plan Parts 1 to 3 (Document Refs: 6.4.42a to c) and Figure 6.32 Vegetation Removal Plan Parts 1 to 3 (Document Refs: 6.4.43a to c) also illustrate the addition of soil stockpiles within the Bespoke Access Corridor in advance of Deadline 5.
