1 Introduction

1.1 Purpose of this Schedule of Changes

- 1.1.1 This Schedule of Changes to the Book of Reference relates to an application made by Low Carbon on behalf of Beacon Fen Energy Park Limited (the “**Applicant**”) on 8th April 2025 under section 37 of the Planning Act 2008 (the “**PA 2008**”) for an order to grant development consent for Beacon Fen Energy Park (the “**Proposed Development**”). The DCO application was accepted for examination on 1st May 2025.
- 1.1.2 This Schedule of Changes should be read in conjunction with the updated **Book of Reference (Document Reference: 4.3)** submitted alongside this document. This Schedule of Changes details all changes in land ownership identified through regular refresh of landowner and title data and information identified through ongoing engagement with land interests.
