Fenwick Solar Project Limited (a Boom Power company) is proposing a new solar farm with energy storage facilities at Fenwick (the scheme). The scheme will generate low carbon electricity from photovoltaic (PV) panels on land to the east of Fenwick, in the north of the City of Doncaster borough near the town of Askern and the smaller villages of Moss, Topham and Skyehouse. The scheme will deliver enough carbon-free electricity to power approximately 75,000 homes.

We are holding a public statutory consultation for Fenwick Solar Farm to explain our proposal. The consultation is running for six weeks, from **18 April to 23:59 on 31 May 2024**.

This statutory consultation is being carried out in line with the requirements of the Planning Act 2008. As the solar farm would produce over 50 MW of electricity, the Scheme is classed as a Nationally Significant Infrastructure Project, and therefore requires planning consent by way of a Development Consent Order (DCO).
