This submission for Procedural Deadline A is in response to the requests set out by the Examining Authority (ExA) in the Rule 6 letter published on 8<sup>th</sup> October 2025.

#### Draft Examination Timetable

Runcorn Carbon Dioxide Spur Pipeline, LBCCS do not wish to attend OPH1 and



ISH1. However, LBCCS would like to reserve the right to attend ISH1 if the agenda changes following close of Procedural Deadline A.

Notification of wish to attend accompanied Site Inspection At this time, LBCCS does not wish to propose any specific sites or locations for the ExA's site inspection.

LBCCS would like to reiterate that our principal concerns regarding the Frodsham Solar Farm DCO application are set out in our Relevant Representation submitted on 28 August 2025 [RR-011]. Whilst LBCCS supports the overall principle of the Frodsham Solar Project, we will continue to engage with the Applicant. As stated in Annex E of the Rule 6 letter, LBCCS are working with the Applicant on a Statement of Common Ground (SoCG) and note the request for the submission of a draft SoCG at Deadline 2.
