Applicant Response to Planning Act 2008 – section 88 and 89 and The Infrastructure Planning (Examination Procedure) Rules 2010 – rules 6, 9 and 13 letter

I write on behalf of Frodsham Solar Ltd (the "Applicant") in response to the Examining Authority's (ExA's) letter dated 08 October 2025 ('Rule 6 letter') in respect of Procedural Deadline B. The Applicant's position regarding the points identified for Procedural Deadline B is set out below.

Draft Statement of Common Ground with Natural England

Procedural Deadline B requires the submission of a draft SoCG with Natural England (NE). Since acceptance the Applicant has held two meetings with Natural England and has supplied additional data to resolve a number of the issues identified in the NE Relevant Representation (RR-12).

A draft SoCG is submitted to the ExA for Procedural Deadline B, which reflects the good progress made between the parties and which has been agreed with Natural England prior to submission.

As part of Procedural Deadline B, the Applicant submits a number of documents are submitted, as explained below:

	Provisions are not yet fully agreed, in particular the parties are still in discussion in relation to Cadent's suggested provisions with regard to security and insurance. In respect of National Gas Transmission, the Applicant has agreed all requests for changes from them and anticipates this will enable that party to withdraw from
Updated Land Plans	the Examination. These plans have been updated to account for a typographical error in the Application version of the Land Plans relating to the access road to the existing Frodsham SPEN substation. As described in the Book of Reference, the relevant plot descriptions describe the road, however the plans mistakenly did not align with the OS mapping for the road. This updated version of the Land Plans therefore shows the plots within the OS mapping for the road. The labels on this plan have also been updated to better reflect the powers sought for each 'colour' as described in the DCO.
Updated Book of Reference (clean and tracked)	This document has been updated to account for on-going diligent inquiry, responses to National Highway's Relevant Representation and that following the update to the Land Plans, a plot has been able to be removed.
Schedule of Land Rights Changes	Further to the changes to the Land Plans and Book of Reference, this document is submitted as requested by Annex E of the Rule 6 Letter.
Updated Application Document Tracker	As requested by Annex E of the Rule 6 Letter.
Guide to the Application document (clean and tracked)	Updated to reflect the additional documents submitted in Volume 8 Pre-Examination

The Applicant notes that on 13 November 2025, the Department for Energy Security and Net Zero announced the consultation outcome of the proposed revisions to National Policy Statements EN-1, EN-3 and EN-5, which were published for consultation on 24 April 2025. The government has confirmed that it intends to proceed with the proposed updates to the NPSs, with some amendments.

Paragraph 6.3.3 of the Planning Statement (APP-128) recognised the consultation in April and noted that the most significant change related to solar development was the integration of the Clean Power 2030 Action Plan into the NPSs. The Applicant plans to submit a document at Deadline 1 summarising the key changes to the NPSs and how these affect the application.
