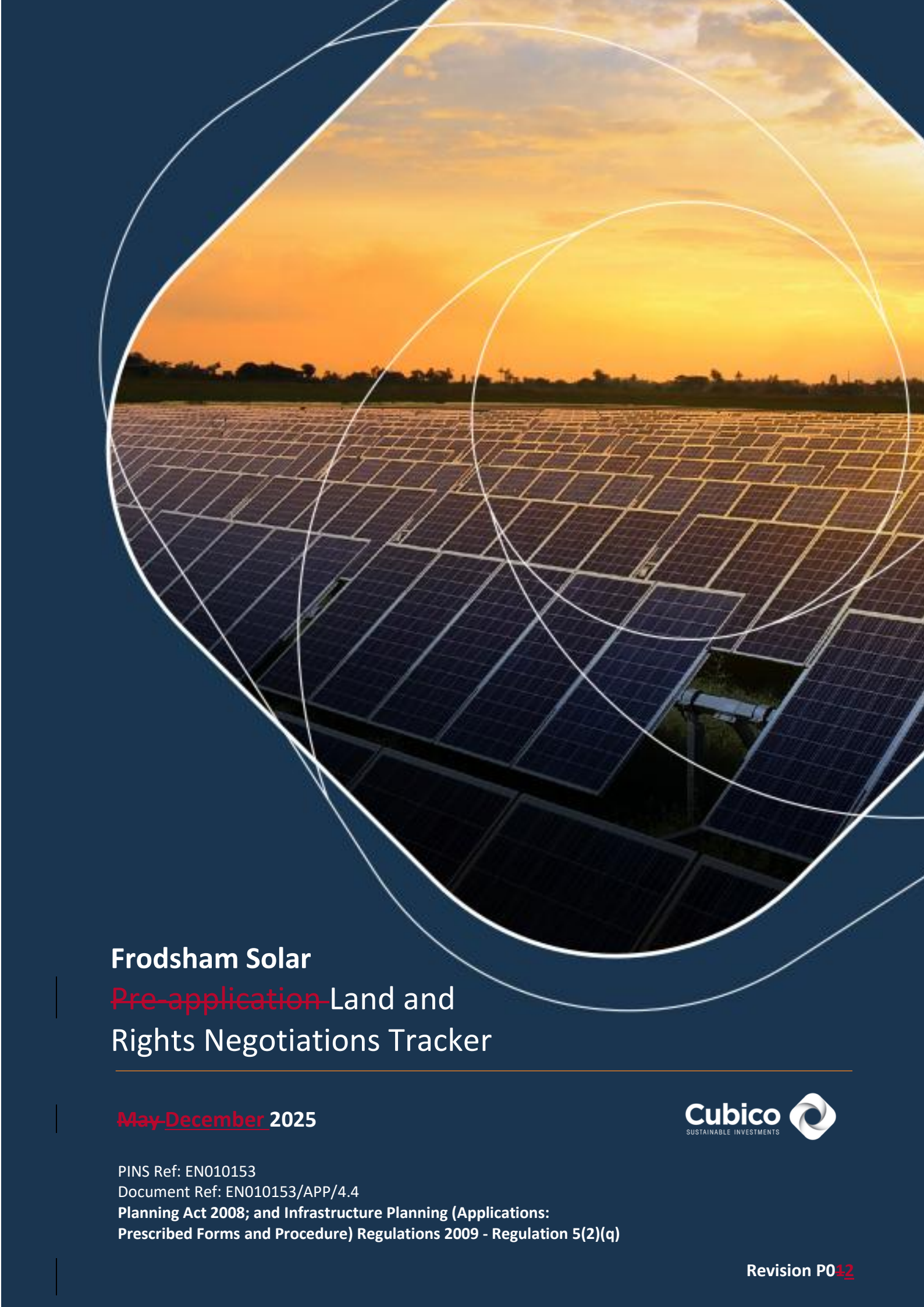

This document establishes one of two preferred formats for the applicant to track negotiations relating to the proposed compulsory acquisition/ temporary possession of land and rights at the pre-application stage. This simplified tracker is suitable for projects with a more limited and/ or less complex land and rights profile. The [Detailed Land and Rights Negotiations Tracker](#) is the preferred format for projects with a more extensive and/ or complex land and rights profile, for example including special category and/ or crown land. Applicants should discuss with The Planning Inspectorate's Case Team the most suitable tracker for their project.

The negotiations tracker will inform interactions between the applicant and The Planning Inspectorate throughout the pre-application stage. It is therefore important that the tracker is kept up to date by the applicant and shared with the Inspectorate regularly. The tracker must be submitted with the application as an appendix to the Statement of Reasons in an editable format.

If the applicant proposes to present the tracking of negotiations in a different way, this should be discussed and agreed with the Planning Inspectorate's Case Team.
