1.0 Introduction

Purpose of this Schedule of Changes

- 1.0.1 This Schedule of Land Rights Changes relates to an application submitted by Cubico Sustainable Investments on behalf of Frodsham Solar Limited (the 'Applicant') on 30 May 2025 under section 37 of the Planning Act 2008 (the 2008 Act) for an order to grant development consent for Frodsham Solar (the 'Proposed Development'). The DCO application was accepted for examination on 27 June 2025.
- 1.0.2 This Schedule should be read in conjunction with the updated Book of Reference submitted alongside this document. This Schedule (rev. P05) details all changes in land ownership identified through regular refresh of landowner and title data and information identified through ongoing engagement with land interests since the application was submitted.
