1. Introduction

1.1 Overview

- 1.1.1 This Adequacy of Consultation Milestone (AOCM) Report is submitted in support of an application by Fosse Green Energy Limited (hereafter referred to as “the Applicant”) to the Secretary of State for Energy Security and Net Zero (SoS) for a Development Consent Order (DCO) for a new solar and energy storage park with associated infrastructure, connecting into the National Grid transmission system at a proposed new substation near Navenby.
- 1.1.2 The Applicant, Fosse Green Energy Limited, is a partnership of Windel Energy Limited and Recurrent Energy.
- 1.1.3 Founded in 2018, Windel Energy is a privately held company dedicated to driving the transition towards a sustainable future. Specialising in the origination, development and integration of renewable energy projects and low-carbon disruptive technologies, Windel Energy is at the forefront of clean energy innovation. With a portfolio exceeding 5 gigawatts of renewable power in various stages of development, Windel Energy’s team of talented professionals bring a deep understanding and high level of expertise in land viability, electricity networks, planning (Town and Country Planning Act 1990, Developments of National Significance) and consenting for Nationally Significant Infrastructure Projects, legal processes and construction feasibility. Windel Energy adopts a long-term ownership approach, ensuring the efficient operation and management of renewable assets. - 1.1.4 Recurrent Energy, a subsidiary of Canadian Solar Inc., is one of the world’s largest and most geographically diversified utility-scale solar and energy storage project development, ownership, and operations platforms. With an industry-leading team of in-house energy experts, Recurrent Energy serves as Canadian Solar’s global development and power services business. To date, Recurrent Energy has successfully developed, built, and connected 11 GWp of solar projects and more than 3 GWh of energy storage projects across six continents. As of December 31, 2024, its global pipeline includes over 28 GWp of solar and 67 GWh of energy storage capacity.

1.2 Summary of the Proposed Development



Figure 1-1 - Project Location Map

- 1.2.1 The Fosse Green Energy project (the Proposed Development) is proposed to be located on land 5.6 miles (9 km) south west of Lincoln in North Kesteven, Lincolnshire.
- 1.2.2 The Proposed Development will generate and export more than 50MW of electricity which will be exported to the national grid. It is therefore classified as a Nationally Significant Infrastructure Project (NSIP) under the Planning Act 2008 (PA 2008) and is subject to an application for a DCO.
- 1.2.3 The Proposed Development consists of a Principal Site and a Cable Corridor.
- 1.2.4 The Principal Site includes ground-mounted solar photovoltaic (PV) panels, Solar Stations, Battery Energy Storage System (BESS), Onsite Substation, planting and mitigation areas, interconnecting cables between solar PV areas, and associated infrastructure.
- 1.2.5 The Cable Corridor is the area of the Site in which the 400 kilovolt (kV) and associated cables (the Grid Connection Cables) will be installed between the Onsite Substation and the proposed substation at Navenby. The proposed substation at Navenby is the subject of a separate planning application by National Grid and does not form part of the Proposed Development. The Cable Corridor partially overlaps the Principal Site and is approximately 10km in length.
- 1.2.6 The key components of the Proposed Development comprise:

- a. Solar PV panels (also known as 'modules');
 - b. PV panel mounting structures;
 - c. Battery Energy Storage System (BESS);
 - d. Inverters;
 - e. Transformers;
 - f. Switchgear;
 - g. An Onsite Substation and control buildings;
 - h. Onsite cabling;
 - i. Ancillary infrastructure (e.g. combiner boxes, weather stations);
 - j. Electricity export and import via high-voltage Grid Connection Cable and connection to the National Electricity Transmission System;
 - k. Fencing and security;
 - l. Access tracks; and
 - m. Landscaping, permissive paths and biodiversity mitigation and enhancement areas.
- 1.2.7 The Order Limits for the Proposed Development are located within the administrative boundary of the following local authorities (the "host authorities"):
- a. Lincolnshire County Council
 - b. North Kesteven District Council

1.3 Need for Consultation

- 1.3.1 Before an application for a DCO is made, the Applicant is required to consult with those living in the vicinity of the land proposed for development (under s47 of the PA 2008, key local authorities, persons with an interest in the land (PIL) and prescribed statutory bodies, as well as publicising the proposed application (under s48 of the PA 2008).
- 1.3.2 The Applicant has also followed the Gunning Principles when conducting consultation. The Gunning Principles are that:
 - a. Consultation must take place when the proposal is still at a formative stage;
 - b. Sufficient reasons must be put forward for the proposal to allow for intelligent consideration and response;
 - c. Adequate time must be given for consideration and response; and
 - d. The product of consultation must be conscientiously taken into account.
- 1.3.3 The purpose of this document is to describe the consultation that has been undertaken, in accordance with the AOCM, as explained below.
- 1.3.4 Non-statutory consultation was undertaken between 11 September 2023 and 20 October 2023 and statutory consultation was undertaken between 21 October 2024 and 2 December 2024.
- 1.3.5 Feedback from the non-statutory and statutory consultations was taken into account and has informed the evolution of the application for the Proposed Development which will be submitted to the Planning Inspectorate (“the Inspectorate”) on behalf of the SoS in July 2025. A list of changes made to the Proposed Development to reflect comments received during consultation are contained in Chapter 4 of this AOCM report.

1.4 Adequacy of Consultation Milestone

- 1.4.1 Updated guidance was published by the Department for Levelling Up, Housing and Communities (DLUHC) (now the Ministry of Housing, Communities and Local Government) on 30 April 2024, entitled ‘Planning Act 2008: Pre-application stage for Nationally Significant Infrastructure Projects’ (Ref 1) (the “Guidance”). This replaced the previous guidance published by the Department for Communities and Local Government’s (DCLG) ‘Planning Act 2008: Guidance on the pre-application process’ (Ref 2). The Government also published the ‘Nationally Significant Infrastructure Projects: 2024 Pre-application Prospectus’ (Ref 3) (the “Prospectus”) in May 2024.

- 1.4.2 Paragraph 025 (Reference ID 02-025-20240430) of the Guidance and Paragraph 009 (Reference 1-009-20240516) of the Prospectus introduce a new early adequacy of consultation milestone (AOCM). In particular the Guidance and Prospectus provide that:
- a. The AOCM should be early enough to enable applicants to consider how to undertake additional engagement that may be required, but sufficiently towards the end of the pre-application stage to assess the consultation that has been undertaken. The suggested timescale for this is no later than around 3 months prior to the intended submission date.
 - b. The AOCM should be recorded by the applicant and submitted to the Inspectorate as a short statement of the elements of consultation which have been carried out compared with the components set out in the Programme Document and the Statement of Community Consultation (SoCC). It should include views and any supporting material from local authorities (LAs), if available.
 - c. The AOCM is an informal, but important, milestone that gives the opportunity for the Inspectorate to check in on the consultation that has been taken and identify any concerns that may delay acceptance of the application.
- 1.4.3 This Report forms the statement that must be submitted to the Inspectorate, setting out:
- a. Consultation and engagement with LAs and local representatives in relation to the approach to be taken to consultation, during both the non-statutory and statutory consultations (Chapter 2).
 - b. Details as to how each stage of consultation was carried out and how it complied with the SoCC (Chapter 3).
 - c. A summary of how the Proposed Development has evolved throughout the pre-application process as a result of the consultation that has been undertaken (Chapter 4).
 - d. A summary of how a supplementary or targeted consultation would be conducted (Chapter 5).
- 1.4.4 Before this Report was submitted to the Inspectorate, an email was sent to host authorities that included the table of SoCC commitments (Appendix A.3) and a request for feedback on the adequacy of consultation to date.
- 1.4.5 North Kesteven District Council (NKDC) responded, noting it was satisfied that consultation and engagement on the Proposed Development had met these SoCC commitments, and the Council raised no issues or concerns with how this was undertaken. A copy of NKDC's response can be found in Appendix A.4.
- 1.4.6 Lincolnshire County Council (LCC) also responded. LCC confirmed that the Applicant had, to date, carried out adequate pre-application consultation and that it was satisfied that an appropriate level of consultation has been

conducted at this stage. LCC also noted that its feedback on the SoCC was taken into account. A copy of LCC's response can be found in Appendix A.4.

- 1.4.7 The Applicant welcomes any comments from the Inspectorate on the approach undertaken so far.

1.5 Key Documents

- 1.5.1 This Report refers to a number of other documents that the Applicant has prepared. These include the:

2. Consultation and engagement with Local Authorities on the Approach to Consultation

2.1 Overview of the Applicant's approach to consultation through the pre-application period

- 2.1.1 It is important to the Applicant that communities, the general public and other stakeholders continue to be involved in the development of the Proposed Development throughout the DCO process. Public consultation helps to gather feedback and identify key issues of concern, enabling the Applicant to address these where possible and improve its proposals. Public engagement will continue throughout the submission and Examination stages of the Proposed Development and into the construction phase so that the Applicant can ensure communities are informed of its activities.
- 2.1.2 Pre-application consultation is a key requirement of the PA 2008 and a crucial part of raising awareness and understanding about the Proposed Development. It also helps to develop a two-way dialogue with local communities and consultees in order to understand the issues that are important to them.
- 2.1.3 In developing the approach to consultation for the Proposed Development, the Applicant has given careful consideration to the specific requirements set out in the following legislation:
- a. Sections 42-50 of the PA 2008;
 - b. Regulations 12 and 13 The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the "EIA Regulations"); and
 - c. Regulations 3 and 4 and Schedule 1 of The Infrastructure Planning (Applications, Prescribed Forms and Procedures) Regulations 2009 (as amended by The Infrastructure Planning (Miscellaneous Provisions) Regulations 2024) (the "APFP 2009").
- 2.1.4 Taking into account best practice (Ref 4), Government Guidance on pre-application consultation (Ref 5), and each host authority's Statement of Community Involvement, the Applicant undertook a two-stage consultation:
- a. Non-statutory consultation: The non-statutory consultation on the emerging plans for the Proposed Development took place between 11 September 2023 and 20 October 2023. The consultation was undertaken to provide consultees with an early opportunity to influence the proposals while options were still undergoing consideration.
 - b. Statutory consultation: The second stage of consultation was a statutory consultation on the Applicant's Proposed Development in accordance with

the requirements of the PA 2008. This took place between 21 October 2024 and 2 December 2024.

- 2.1.5 The non-statutory consultation informed the approach to the statutory consultation.
- 2.1.6 The timeline in Figure 2.1 sets out the main stages of the pre-application process, including the non-statutory and statutory consultation, as well as key stages of engagement and publicity that the Applicant has carried out in relation to the Proposed Development.

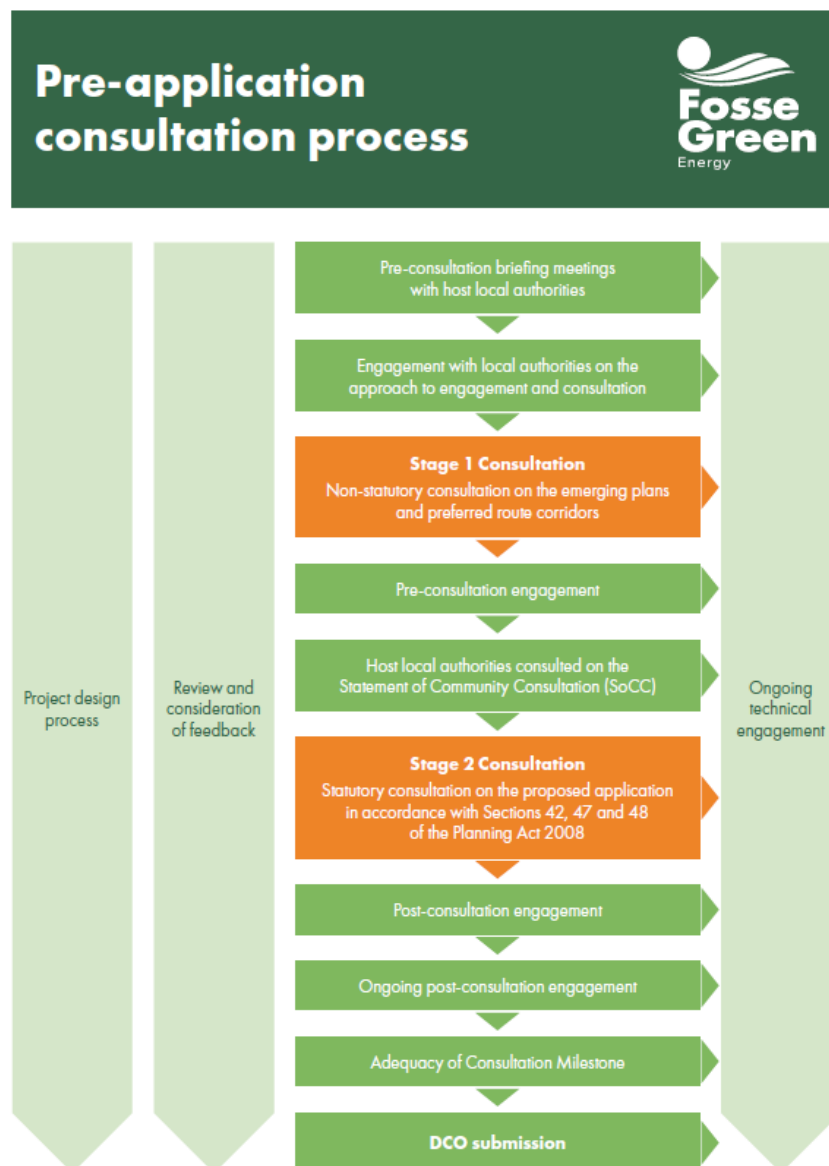


Figure 2-1 - Pre-application consultation and engagement process

2.2 Preparation for the non-statutory consultation

- 2.2.1 The Applicant is committed to delivering projects that are as inclusive as possible and places equality, diversity and inclusion at the heart of business planning and decision-making. Consultation activities were therefore planned to be accessible and inclusive, to ensure that the Applicant engaged with as wide a demographic as possible.
- 2.2.2 The Applicant sought to achieve this through a variety of methods. These included raising awareness of the Proposed Development across the region (using emails, direct mail, local newspaper advertising and community posters), clearly explaining the Proposed Development and signposting to the project website (<https://fossegreenenergy.co.uk/>). All consultation materials were written in plain English.
- 2.2.3 The Applicant engaged in discussions with the host authorities (Lincolnshire County Council and North Kesteven District Council) to develop the approach to consultation and engagement. Meetings were held on the dates listed in Table 2.1. The Applicant was also in regular communication via email with both host authorities. This informal engagement continued through the non-statutory consultation period and beyond.

- 2.2.4 The approach to non-statutory consultation was refined with the host authorities via email and direct dialogue. Comments received from the host authorities, and the Applicant's responses to them, are set out in Table 2.2.
- 2.2.5 Correspondence received from the host authorities regarding the Applicant's proposals for consultation can be found in Appendix A.1.

- 2.2.6 The approach to non-statutory consultation was also discussed with other stakeholders who may have had an interest in the Proposed Development. An early briefing, which included discussion of the approach as well as the Proposed Development itself, was held with the 'Witham and Brant Cluster', a group of Parish Councils in the area of the Proposed Development, on 4 September 2023.
- 2.2.7 An early briefing was also held with Dr Caroline Johnson MP on 27 June 2023. Karl McCartney MP was also offered, although did not take up the offer of, a briefing.
- 2.2.8 These meetings were an opportunity to introduce the Proposed Development and provide insight into the Applicant's proposed approach to consultation to meet the requirements of the PA 2008, Government guidance (Ref 5), the Government's Consultation Principles (2018) and the Gunning Principles as set out in Paragraph 1.3.2 of this report.
- 2.2.9 Online activities were optimised to support access from mobile devices, such as phones, tablets and desktop devices.
- 2.2.10 The Applicant also recognised that many people prefer to engage offline, and as such held four in-person events across the consultation zone.
- 2.2.11 Details of the online and in-person activities are provided in Section 6 of the Non-Statutory Consultation Feedback Report Oct 2024 (NSCFR) (as presented at Paragraph 1.5.1 of this Report).

2.3 Preparation for the statutory consultation including the SoCC

- 2.3.1 In accordance with s47(1) of the PA 2008, the Applicant prepared a SoCC setting out how it proposed to consult about its proposed application with people living in the vicinity of the land.

- 2.3.2 As part of its preparation, and in accordance with s47(2), the Applicant consulted with the host authorities (identified in Paragraph 1.1.10) on the approach to, and content of, the draft SoCC. This consultation was held between 7 November 2023 and 19 December 2023, a period of 42 days.
- 2.3.3 This ensured the Applicant understood how consultation might best be undertaken with those affected communities and that their views could be taken into account when finalising the proposals for the Proposed Development.
- 2.3.4 Feedback on the draft SoCC was received from both host authorities and was considered by the Applicant as part of finalising the approach to the consultation. A summary of the feedback received and the changes that were made to the draft SoCC are presented in Table 2.3. Copies of correspondence received detailing feedback to the draft SoCC are presented in Appendix A.2.

2.3.5 Following consultation with the host authorities, the SoCC was updated to incorporate the changes set out in Table 2.3.

2.3.6 The Applicant undertook the statutory consultation in line with the approach set out in the SoCC. The Applicant has prepared a SoCC Compliance Checklist to demonstrate how the consultation complied with the agreed SoCC. This checklist can be found at Appendix A.3. The checklist identifies commitments made in the SoCC and evidence how this was complied with.

2.4 Section 55 Checklist

2.4.1 Section 55 of the PA 2008 sets out the circumstances under which the Secretary of State (SoS) may accept an application for development consent. Following acceptance, an application will be subject to an examination pursuant to s86 to s102B of the PA 2008.

2.4.2 The 'Section 55 checklist' is a document prepared by the Inspectorate on behalf of the Secretary of State upon submission of an application. Completion of the Section 55 checklist by an applicant is not a requirement under Regulation 5 of the APFP Regulations, nor does the submission of a draft completed Section 55 checklist by the Applicant hold any weight at the acceptance stage.

2.4.3 However, the Applicant considers that the submission of a 'draft' Section 55 checklist can assist the Inspectorate with the compliance check at the acceptance stage by signposting to relevant Application documents or parts within Application documents.

2.4.4 Therefore, the Applicant has decided to submit the Section 55 checklist as part of its application for a DCO. The checklist will demonstrate how the Applicant has complied with the PA 2008, particularly with s42, s45, s46, s47, s48 and s49 of the PA 2008 in relation to the consultation.

3. Approach to Pre-Application consultation

3.1 Non-statutory consultation approach

- 3.1.1 On 11 May 2023, in advance of the non-statutory consultation, the Applicant delivered a 'Soft-Launch' phase of communication to residents, businesses and stakeholders with an interest in the Proposed Development. On this date the project website was launched and promoted. The Soft-Launch consisted of:
- a. Direct mailing to 477 residents and businesses living within or close to the proposed site boundary;
 - b. Emails issued to key stakeholders, including Parish Councils; and
 - c. A press release issued to local media outlets including Lincolnshire Live, The Lincolnite, East Midlands Connected and Newark Advertiser.
- 3.1.2 Communications to update officers and elected members at host authorities, Parish Councils and key stakeholders of the Soft-Launch were also issued on 26 June 2023.
- 3.1.3 Non-statutory consultation was then held between 11 September 2023 and 20 October 2023 for a period of 39 days.
- 3.1.4 The purpose of the non-statutory consultation was to:
- a. Introduce the Applicant and its ambition to deliver a new solar and energy storage park with associated infrastructure, connecting into the National Grid transmission system at a proposed new substation near Navenby;
 - b. Give local and/or interested people and stakeholders the opportunity to provide feedback on the emerging proposals that could inform the evolving design of the Proposed Development;
 - c. Provide information on how the Proposed Development will operate;
 - d. Identify wider potential impacts of the Proposed Development and any opportunities to support local schemes and projects to benefit communities;
 - e. Ensure people know how to receive information on the Proposed Development both during and outside of the consultation period;
 - f. Inform and prepare consultees ahead of statutory consultation, which was anticipated to take place Winter 2024; and
 - g. Seek comments on any other matters relating to the Proposed Development that consultees consider relevant.
- 3.1.5 The consultation was undertaken within an identified Consultation Zone around the area of the Proposed Development but was not geographically

restricted to respondents in this area. This represented an approximate Consultation Zone of three kilometres from the Proposed Development boundary.

- 3.1.6 The Consultation Zone included approximately 13,000 residential and commercial addresses.
- 3.1.7 A map of the Consultation Zone is included as Figure 2 of the Stage One NSCFR, available on the project website (link available in Paragraph 1.5.1).
- 3.1.8 In accordance with the DCLG Guidance (Ref 2) (which was the current guidance at the time of the non-statutory consultation) and to encourage participation in the consultation, a range of methods and techniques were used to consult. These ensured that the various consultees identified above, and all sections of the community that could be affected by the Proposed Development could be involved in the process.
- 3.1.9 The consultation was open to all and widely publicised via email, postcards, print/digital advertising, and social media. Notification of the consultation period was particularly targeted at specific local stakeholders and groups including:
- a. Local communities and elected representatives: Households and businesses in the defined Consultation Zone and their elected representatives (including MPs, councillors, and Parish Councils). This included landowners whose land may be affected by the Proposed Development.
 - b. Special and local interest groups: Special interest groups, such as wildlife trusts, professional bodies, pressure groups, and organisations who may be interested in the proposals because of their area of knowledge or specialism (for example, local historical societies, conservation groups or charities).
 - c. Seldom heard groups: Representatives of people considered seldom heard. Examples of groups considered seldom heard include young people, old people, people with physical disabilities or learning difficulties, and people for whom English is not their first language. During the consultation, the project team sought to identify interested parties to include in future engagement.
 - d. Host authorities and Parish Councils: The Applicant consulted with host authorities and Parish Councils as detailed in Paragraph 3.1.13b.
- 3.1.10 The information provided at the non-statutory consultation (available on the project website) included an online map, a Consultation Information Booklet, which provided an overview of the Proposed Development at that stage and how people could feedback into the consultation, and the Environmental Impact Assessment (EIA) Scoping Report which can be found here: <https://nsip-documents.planninginspectorate.gov.uk/published-documents/EN010154-000011-EN010154%20-%20Scoping%20Report.pdf>

(Planning Inspectorate (2023) Scoping Report submitted to the Secretary of State on 19 June 2023 (Accessed 8 April 2025)).

- 3.1.11 A briefing was held with North Kesteven District Council on 9 October 2023. This allowed the Applicant to present the Proposed Development proposals to council members. A record of the briefing can be found here: <https://democracy.n-kesteven.gov.uk/ieListDocuments.aspx?CId=710&MId=9549> (North Kesteven District Council (2023) Councillor Pre-Application Planning Forum-Monday 9th October 2023 5:00pm (Accessed 4 April 2025))
- 3.1.12 In addition, a wide range of community and other non-statutory stakeholders were identified and notified of the consultation.
- 3.1.13 More detail on the notification methods is provided at Section 5.2 of the Stage One NSCFR, and in summary:
- a. Postcards were distributed to 13,000 residential and commercial addresses within the Consultation Zone.
 - b. Emails were issued to a range of organisations and stakeholders including two Members of Parliament, the two host authorities, and 26 Parish Councils.
 - c. An advertising campaign took place in print and digital media and using Google search advertising.
- 3.1.14 The Non-Statutory Consultation Feedback Report provides an overview of how the non-statutory consultation was conducted and a summary of feedback received (<https://fossegreenenergy.co.uk/assets/images/pdf/FGE-Consultation-Report-Final-Oct.pdf> (link available in Paragraph 1.5.1)).
- 3.1.15 At the non-statutory consultation, the Applicant asked for people's views and feedback on:
- a. The Proposed Development overall;
 - b. The proposed location of the Proposed Development including solar panel array areas;
 - c. The two Cable Corridor options identified to enable the energy park to connect to the National Grid transmission system. (At this stage, these areas were broad to allow for route refinement informed by continued environmental surveys, minimising any potential adverse impacts);
 - d. Initial ideas to mitigate potential environmental impacts, create areas for ecological enhancements and biodiversity net gain;
 - e. The proposed method of using underground cables to connect to the national grid; and
 - f. Suggestions for community initiatives or schemes that could be supported once the Proposed Development is operational.

- 3.1.16 The feedback received to the non-statutory consultation informed the design and development of the Proposed Development.
- 3.1.17 A total of 158 pieces of feedback were received during the consultation period, which were coded, analysed and reported on as valid consultation responses.
- 3.1.18 Representations were received from local authorities, national and local organisations, PILs, and the local community, including:
 - a. The Environment Agency;
 - b. Thorpe on the Hill Parish Council;
 - c. Norton Disney Parish Council;
 - d. Coleby Parish Council;
 - e. Aubourn and Haddington Parish Council;
 - f. Swinderby Parish Council;
 - g. Thurlby Parish Council; and
 - h. Fosse Green Energy Action Group.
- 3.1.19 The feedback comprised:
 - a. 93 emails;
 - b. 25 online feedback forms; and
 - c. 40 hard copy feedback forms or letters.
- 3.1.20 A detailed summary of how the Applicant has had regard to the consultation feedback provided during the non-statutory consultation is provided in the Non-Statutory Consultation Feedback Report (Section 8) (link available in Paragraph 1.5.1).

3.2 Statutory consultation approach

- 3.2.1 The statutory consultation provided consultees with a further opportunity to understand, comment on and influence the proposals prior to submission of the application. The consultation provided the opportunity for consultees to attend public exhibitions and speak to members of the project team. The consultation also provided more opportunities to increase awareness about the Proposed Development.
- 3.2.2 The consultation focused on sharing how proposals had developed following the non-statutory consultation, and how feedback had been taken account of and incorporated into the Proposed Development and the Preliminary Order Limits.
- 3.2.3 The information provided at the statutory consultation (available on the project website) included:
 - a. A copy of the SoCC;

- b. A Consultation Information Booklet, which provided an updated summary of the Proposed Development and how people could provide feedback;
 - c. A site layout plan;
 - d. The map of the Proposed Development;
 - e. Hardcopy and online feedback forms;
 - f. Promotional materials including the mailer/postcard and community poster;
 - g. The s47 and s48 notice;
 - h. The Preliminary Environmental Information (PEI) Report and supporting documents (including a Non-Technical Summary), which set out the environmental assessments undertaken to date, explained what was proposed to be constructed and where, as well as the decisions which had been taken in developing the proposals and provided an overview of the potential environmental impacts of the Proposed Development. Views were sought during the consultation on the information contained in the PEI Report and its supporting documents; and
 - i. A recording of an online webinar which took place on 26 November 2024.
- 3.2.4 The statutory consultation took place over a 43-day period from 21 October 2024 to 2 December 2024. This exceeds the statutory minimum period of 28 days for statutory consultation as specified by the PA 2008.
- 3.2.5 The statutory consultation was open to anyone that had a view that they wished the Applicant to consider (as was the case for the non-statutory consultation).
- 3.2.6 A tiered consultation zone strategy was put in place. This consisted of a:
- a. Core Consultation Zone of three kilometres from the site boundary, which matched the Proposed Development's initial non-statutory Consultation Zone. Addresses in this Zone would receive direct notification of the statutory consultation through a direct mail postcard.
 - b. Wider Consultation Zone that was specified to reach communities within five kilometres of the site boundary. These would be communicated with through Google advertising, local media advertising, posters and notices. This Wider Consultation Zone included, but was not limited to, North Hykeham, Waddington, Nocton, Metheringham, Rowston, Digby, Bloxholm, Ruskington, Leadenham, Fulbeck, Stragglethorpe, Brant Broughton, Stapleford and Collingham.
- 3.2.7 Parish Councils, relevant local groups, and 'Seldom Heard Groups' in these areas were also notified via an email sent on 21 October 2024 announcing the launch of the statutory consultation.
- 3.2.8 Members of the community who registered their interest in receiving updates on the Proposed Development before 21 October 2024 were also notified of the launch of consultation.

3.2.9 At the same time as consulting the local community, the Applicant consulted a wide range of statutory consultees on the Proposed Development, in accordance with s42 of the PA 2008. These were identified with consideration of Inspectorate (2024), Nationally Significant Infrastructure Projects: Advice on EIA Notification and Consultation, which can be found here: <https://www.gov.uk/guidance/nationally-significant-infrastructure-projects-advice-on-eia-notification-and-consultation> (accessed 17 April 2025). These include:

- a. Host and neighbouring local authorities;
- b. Prescribed consultees (such as Natural England and Environment Agency);
- c. People with an interest in land that might be affected by the proposals; and
- d. Lincolnshire Fire and Rescue Service.

3.2.10 In accordance with s42(1)(b) of the PA 2008, the local authorities in Table 3.1 were consulted.

3.2.11 In accordance with s42(1)(d) of the PA 2008, persons with an interest in land (PILs) were consulted, as set out below:

- a. Category 1 – an owner, lessee, tenant or occupier of the land;
- b. Category 2 – a person interested in the land or who has power to sell and convey the land or to release the land; and
- c. Category 3 – a person who would or might be entitled to make a claim under s10 of the Compulsory Purchase Act 1965 or Part 1 of the Land Compensation Act 1973 or s152(3) of the PA 2008.

3.2.12 S42(1)(d) notices were issued by post on 21 October 2024, when the statutory consultation launched, to PILs within the Order Limits as identified by His Majesty's Land Registry. S42(1)(d) notice were also issued on the same date to parties with subsoil interests within these Order Limits.

3.2.13 In the process of completing a Land Registry refresh, the Applicant identified several new lands interests. A later consultation in line with the statutory consultation was therefore held for newly identified PILs within the Order Limits. S42 notices were issued to these parties on 3 March 2025, who were given 28 days to respond.

3.2.14 More detail on the consultation undertaken with PILs will be provided in Section 8 of the Consultation Report produced as part of the DCO application.

3.2.15 The Proposed Development constitutes Environmental Impact Assessment (EIA) development and, therefore, the EIA Regulations and requirements contained therein apply.

3.2.16 The requirement to consult on preliminary environmental information is set out in Regulation 12(1)(b) of the EIA Regulations. Preliminary environmental information (PEI) is defined in the EIA Regulation as: information referred to

in regulation 14(2) and Part 1 of Schedule 4 (information for inclusion in environmental statements); which, (a) has been compiled by the applicant; and (b) is reasonably required for the consultation bodies to develop an informed view of the likely significant environmental effects of the development (and of any associated development).

- 3.2.17 The SoCC, prepared under s47 of the PA 2008, set out how the PEI Report was to be publicised and consulted on. This included who the Applicant would consult with in accordance with Regulation 13 of the EIA Regulations. The statutory consultation exercise was carried out in accordance with the SoCC (available on the project website).
- 3.2.18 The PEI Report (available on the project website) was published as part of the statutory consultation and was the written output of the EIA undertaken at that date for the Proposed Development. The PEI Report was designed to accord with the minimum requirements for an ES as set out in Regulation 14 and Schedule 4 of the EIA Regulations as far as possible based on known information.
- 3.2.19 In preparing the PEI Report for consultation, regard was had to the Inspectorate's Advice Note Seven: Environmental Impact Assessment: Process, Preliminary Environmental Information and Environmental Statements.
- 3.2.20 The findings presented in the PEI Report were based on a preliminary assessment and reflected the design process at that stage and understanding of baseline conditions, allowing for conclusions as to the likely significant effects to be drawn. Although preliminary, the findings of the assessment set out within the report allowed an informed view to be developed of the Proposed Development being promoted, the assessment approach that had been undertaken, and drew preliminary conclusions on the likely significant effects and environmental measures proposed.
- 3.2.21 Where the design was still evolving or further information on baseline conditions were still to be obtained, a precautionary approach was applied to ensure a likely worst-case scenario was assessed in the PEI Report. The PEI Report presented a level of preliminary assessment appropriate to enable consultees to develop an informed view of likely significant environmental effects of the Proposed Development and help inform their consultation responses during the statutory consultation as part of the pre-application stage. This enabled both the design of the Proposed Development and the EIA to take into consideration any comments received through the consultation.
- 3.2.22 Responses to the Scoping Opinion comments (which had been received on 25 July 2023), detailing how they were addressed within the PEI Report were set out in each environmental topic chapter.
- 3.2.23 The project website was well utilised, being visited by 2,158 total users over the course of the consultation period.

- 3.2.24 In total, 216 pieces of feedback were received in response to the statutory consultation.
- 3.2.25 Representations were received from local authorities, national and local organisations, PILs, and the local community. The feedback comprised:
- a. Online via the feedback form - 47
 - b. Email feedback - 141
 - c. Hardcopy feedback forms - 26
 - d. Hardcopy mail - 2
- 3.2.26 Late responses were received from the Forestry Commission, the Lincoln and Witham Landscape Recovery Project, a member of the Stop Fosse Green Action Group, and from two members of the public. Noting that these responses were submitted a few days after the close of consultation, the responses were considered by the Applicant.
- 3.2.27 On 18 November 2024, a feedback extension was granted to Parish Councils who the Applicant was planning to brief on 27 November 2024. The deadline for feedback was extended to 9 December 2024 to ensure the Parish Councils had sufficient time to respond in detail to the statutory consultation following the briefing. The Applicant received feedback from Coleby Parish Council and Thorpe on the Hill Parish Council in response.
- 3.2.28 Following identification and categorisation of the feedback, the Applicant considered feedback received as part of its ongoing design, assessment and evaluation processes for the Proposed Development.
- 3.2.29 A detailed summary of how the Applicant has had regard to the consultation feedback provided during the statutory consultation will be provided in the Consultation Report submitted as part of the DCO application.
- 3.2.30 As noted in paragraph 2.3.6, the Applicant prepared a SoCC Compliance Checklist to demonstrate how the consultation undertaken at the statutory consultation complied with the agreed SoCC (see Appendix A.3).
- 3.2.31 As noted in Chapter 2.4, the Applicant will submit a Section 55 Checklist as part of its DCO application submission.

4. Summary of Evolution for the Proposed Development

4.1 Overview

- 4.1.1 The Proposed Development underwent a number of changes and updates as a result of the non-statutory and statutory consultations. These changes reflect the evolution of the project options and design taking into account comments received at consultation and also the findings of environmental and technical surveys/assessments.

4.2 Evolution of the Proposed Development presented at the non-statutory consultation

- 4.2.1 The Applicant reviewed and considered all feedback received at non-statutory consultation and continued to develop the Proposed Development. Given specific concerns raised by residents on Morton Lane and residents of the Cathedral View Holiday Park, meetings were held with them over the consultation period which also informed the evolution of the Proposed Development. Changes following non-statutory consultation included refining the Principal Site Boundary to exclude individual residential properties, and the removal of the southern grid connection option due to it resulting in a longer cable route which would have affected additional landowners and resulted in potential temporary impacts.
- 4.2.2 The main design iterations for the Principal Site and Cable Corridor can be seen at Table 4.2 of the Preliminary Environmental Information Report (Volume 1, Chapter 4), available on the project website at <https://fossegreenenergy.co.uk/documents/>.
- 4.2.3 Changes made to the Proposed Development as a result of comments received during the non-statutory consultation are summarised below.
- a. Removal of the southern grid connection option as it would result in a longer cable route affecting additional landowners and resulting in additional temporary impacts;
 - b. Refining the Principal Site Boundary to exclude individual properties;
 - c. Minimising visual impacts;
 - d. Creating links across the Principal Site;
 - e. Reducing potential operational noise impacts;
 - f. Locating all Solar Station Compounds away from Flood Zones 2 and 3;
 - g. Locating larger elements of the solar farm in areas of reduced flooding and screening from existing vegetation and topography;

- h. Removing land previously containing solar infrastructure south of Moor Lane to reduce impact on ground nesting birds;
 - i. As a result of landowner discussions and further environmental assessment, an area to the north of the A46 has now been included for the deployment of solar panels to maximise the opportunities to deliver clean energy;
 - j. Changes have been made in the vicinity of Cathedral View Holiday Park and in land southeast of Thorpe on the Hill to provide additional buffers from the Solar PV Array;
 - k. Additional changes have been made in the vicinity of Cathedral View Holiday Park and in land southeast of Thorpe on the Hill to provide additional buffers from the Solar PV Array Areas;
 - l. The design of the Solar and BESS Stations has been optimised to aggregate these as much as possible to minimise the number of water tanks that may be requested by the local fire and rescue teams should the DC-coupled BESS option be selected for development; and
 - m. Permissive paths have been included to show the Applicant's intention for greater connectivity between the local villages and provision of shorter circular walks. Proposed planting has also been added.
- 4.2.4 Further refinement to the Cable Corridor was also undertaken, with a single, approximately 250m wide route included within the Site. The refinement of the Cable Corridor considered:
- a. Feedback from the non-statutory consultation including concerns related to the provision of additional overhead lines;
 - b. The likely point of connection at proposed National Grid Navenby Substation;
 - c. Optimisation of the corridor so the cable can be laid in a straight line or in shallow curves so that the cable can be pulled through the ducting effectively;
 - d. Provision of adequate space to allow for crossing on existing utilities such as the existing overhead lines and the new Anglian Water main;
 - e. Access to the corridor during construction; and
 - f. Provision of adequate space required to undertake the works to lay the cable.

4.3 Evolution of the Proposed Development Presented at Statutory Consultation

- 4.3.1 Following the statutory consultation, the Applicant reviewed and considered all feedback received and continued to develop the Proposed Development, also taking account of ongoing surveys and assessments. The main changes to the Proposed Development since the statutory consultation include:

- a. Removal of solar photovoltaics (PV) from a field to the south-east of Thorpe on the Hill. This can be used for ecological mitigation and enhancement;
- b. Removal of solar PV from a field east of Morton which was located immediately east of a proposed orchard;
- c. Change of the permissive path network around Housham Wood in response to a request by Lincolnshire Wildlife Trust;
- d. Change of the permissive path network around Cathedral Park, a caravan park north of the A46, in response to requests by local residents;
- e. Change of the permissive path network in the southern part of the site, providing better pedestrian links between Thurlby and Bassingham;
- f. Removal of solar PV in a field west of (the north-western part of) Bassingham to minimise views of the solar infrastructure for residents with open views across the site;
- g. Reduction in the size of the BESS compound. This will reduce noise impacts and allow for more landscaping; and
- h. Slight reduction in the grid connection corridor within which the buried connection cable will be located between the principal site and the proposed Navenby Substation. This change will remove land from our proposals that will no longer be required.

5. How the Applicant would undertake any Supplementary or Targeted Consultation

5.1 Supplementary or Targeted Consultation

- 5.1.1 In accordance with standard pre-application consultation procedures, where necessary and appropriate, the Applicant would conduct supplementary or targeted consultations. Supplementary or targeted consultation is not anticipated at this stage, but the procedure that would be followed should this be required is set out below.
- 5.1.2 Any supplementary or targeted consultation will align with the approaches undertaken during all previous stages of both non-statutory and statutory pre-application consultation.
- 5.1.3 The Applicant will seek to ensure that any required consultation will:
- Provide an update on information relating to the Proposed Development;
 - Be limited to such parties as need to be consulted on the particular issues that are subject to the consultation;
 - Provide the community and other stakeholders with the opportunity to understand, comment on and influence the proposals subject to the supplementary or target consultation;
 - Provide clear and concise technical and non-technical information on the proposals subject to the supplementary or target consultation, as required;
 - Help local people understand the potential nature and local impact of the proposals subject to the supplementary or target consultation;
 - Provide a range of opportunities for people to engage with the proposals subject to the supplementary or target consultation and provide comments and feedback; and
 - Ensure that comments and feedback have been taken into account in finalising the DCO application prior to its submission.
- 5.1.4 Any necessary consultation would focus on sharing how proposals have developed following the statutory consultation and how feedback has been taken into account and incorporated into the Proposed Development and the Draft Order Limits.
- 5.1.5 The need for a further consultation would be determined on a case-by-case basis following a careful review of all consultation feedback received from the statutory consultation and in accordance with relevant guidance on the need for further consultation. Any supplementary/ targeted consultation would be undertaken for a minimum of four weeks.

- 5.1.6 All steps would be considered with regard to notices, advertising/press notices, and, where necessary, events, in line with the approaches adopted during previous stages of consultation and aligned as appropriate with the SoCC produced for statutory consultation.
- 5.1.7 Subject to the requirements for supplementary/targeted consultation, all affected PILs would be informed of the consultation in line with the process set out in the SoCC. The Applicant would also engage with local authorities in areas where such consultation is required within their jurisdiction.
- 5.1.8 All feedback received during any supplementary or targeted consultation would be reviewed and considered using the same methods and approaches as adopted at each of the previous stages of pre application consultation. Comments received during the consultation period would be considered in detail and with due regard.
- 5.1.9 As part of the Applicant's preparation for the submission of a DCO application, following any supplementary/targeted consultation, a summary of the approach taken, the feedback received and the matters raised would be provided as a separate chapter of the Consultation Report, within the application.

6. Conclusion

6.1 Concluding Remarks

- 6.1.1 The Applicant shared its approach to consultation at the non-statutory and statutory stages of consultation with local authorities, with a SoCC developed for the statutory consultation. The SoCC provided the relevant LAs with the opportunity to comment and suggest any potential changes in approach as the process of consultation continued. Feedback from the LAs was taken into consideration and informed the approach to the statutory consultation.
- 6.1.2 At each stage of pre-application consultation, the Applicant has undertaken consultation in accordance with the approach identified in the SoCC and in accordance with the PA 2008.
- 6.1.3 The Applicant has at all times during pre-application consultation given due consideration to all responses received at consultation and while it is not always possible to amend the proposals in response to such comments, a number of changes have been made and the Proposed Development has developed accordingly.
- 6.1.4 In accordance with the requirements under the PA 2008, the Applicant is preparing a Consultation Report which will provide:
 - a. Details of each stage of engagement and consultation undertaken as part of the pre-application process;
 - b. A summary of the responses received; and
 - c. How the Applicant has had regard to the responses received in the development of the Proposed Development
- 6.1.5 The Consultation Report will be submitted as part of the DCO application.

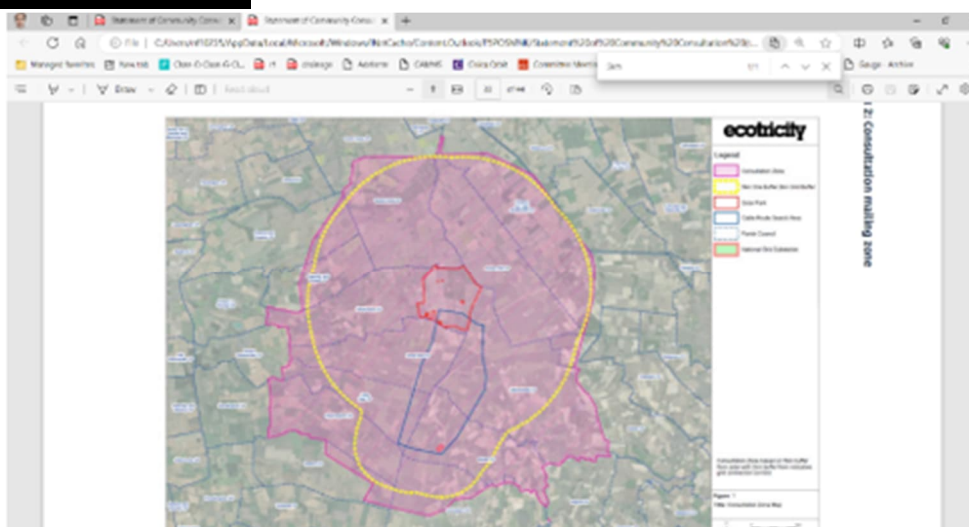
In terms of the consultation zone as you know we are consistently recommending 5km across the piece and have since recently recommended the same for Springwell Solar. Obviously if there is other industry practice from elsewhere then presumably you'll wrap this up into draft SOCC however our recommendation would be to adopt 5km. You'll see from the final version Heckington Fen SOCC below the extent of the 5km buffer around the main energy park site and also noting a 2km buffer around the grid connection, para 4.2.2 of the final SOCC refers:

"4.2.2 The early engagement newsletter (see Appendix 1) was issued to just under 6000 addresses (see Appendix 2) including all properties within 5km of the proposed solar park site and 2km of the proposed grid connection search area to introduce the project and publicise the first phase of consultation".

If you're still minded to adopt a narrower zone then obviously you would need to set the buffer from the outer edge of the northern and southern grid corridor options presented at Scoping unless these have since been refined/modified.

Fosse Green Solar Farm - Consultation on the draft Statement of Community Consultation (Section 47(2) of the Planning Act 2008)

Thank you for consulting North Kesteven District Council in relation to the draft SOCC for the Fosse Green project. The Council can comment as follows:

- Page 6 – we request that the statutory consultation phase is increased to 6 weeks rather than 30 days. The end of February is anticipated; just be mindful of Lincolnshire half term starting 10th February for 1 week in case you were looking to bring the date forward. This period should be avoided
- Section 5 Non Statutory Consultation Summary – text should be expanded to confirm that purpose of NSC was to review scheme layout and mitigation on the basis of feedback. At present it reads that the focus was on receiving feedback rather than then saying how this would be acted upon in terms of emerging designs etc. Feedback report is referenced – we agree that there should be a summary of the key themes highlighted in feedback
- Section 6 Consultation objectives – this should be expanded to include seeking feedback and suggestions in relation to community benefit and mitigations
- Section 7 Environmental information/scoping report – this should be expanded to confirm that the applicant is required to address the matters contained in the Scoping Opinion issued by PINS. At present its not quite clear enough in terms of the applicant's obligations in relation to this document
- Section 7/PEIR – as above can you please clarify legal status of the Scoping Opinion in terms of what the PEIR and future DCO must address
- Section 8 – as above we request consultation extended to 6 weeks
- Section 8 – in terms of the issues that you are consulting on, whilst the use of sub-headings is helpful you need to be mindful that you are bound to receive comments resisting the principle of development (objections) and that you need to be receptive of these. The topic sub-headings suggest that these comments and concerns might not be entertained whereas you need to show that you will be receptive to a range of comments including challenges to the principle of development on policy, technical grounds etc. In terms of the grid connection corridor, depending on National Grid decisions you might also be in a position to confirm publicly the approximate location of the new NGSS around Navenby Heath. In addition, if you do keep sub-headings in can you please add a section on seeking feedback on community benefit options
- Section 9 consultation zone – as with previous feedback latterly 4th September we just want to reiterate the point that whilst you've referred to examples of 2km and 3km radial consultation areas for other NSIPs, our experience has been for a 5km corridor around the energy park site (dropping to 2km around the cable corridor) and this is what we've been recommending consistently across all NSIPs within NKDC. We maintain this position and recommendation.
- Section 9 'Wider Consultation Area' – as above we recommend a 5km zone which would then avoid the need to deal with feedback from outside the 3km core zone. It is unclear how google online advertising will work/details. If the 3km core zone is retained it would help to

identify villages etc beyond the 3km where you might expect to receive feedback and how the proposed local media coverage will reach those areas

- Section 9 'Seldom heard...' – consideration on a case by case basis suggests that you might decline requests? Suggest rewording along the lines of you will accommodate these requests.
- Section 10 – please confirm that the ORPMR venue is at Thorpe on the Hill. Re: booking and availability of meeting rooms can you mention that you would look to agree alternatives in discussion with the parish councils and host authorities? Mix of weekend and weekday events are supported but there is no reference to start and end times to ensure maximum scope for attendance across spectrum of residents.
- Section 10 'Information points' – no indication as to where these are. It is presumed that these are libraries, parish offices/halls etc within the core consultation zone but can you please confirm likely venues so that we can comment; e.g. North Hykeham Community Library?
- Section 10 – no reference to accommodating feedback via social media
- Section 10 – 'Advertising and notices' and 'media releases' suggest expansion to include Lincolnshire Live, Lincolnshire World and The Lincolnite for press/advertising, and for media releases to include BBC Radio Lincolnshire, Lincs 102.2FM, BBC Look North, ITV News Calendar, Lincolnshire Free Press, Lincolnshire Live, Local Lincs Magazine. The area is also covered either in whole or part by Tucann Publishing's Witham Herald and the Hykeham Gazette.

Finally please can you liaise with the developers for Beacon Fen and Springwell to ensure that there is no overlap with the statutory consultation where possible. This is particularly the case for Springwell given that both projects are planned to connect into a new NGSS on Navenby Heath.

Firstly apologies for the delayed reply to your initial email. In terms of the Adequacy of Consultation Milestone (AOCM) and your SOCC compliance list, I can confirm from North Kesteven District Council's perspective that we are satisfied that consultation to date has been consistent with the SOCC and that we have no specific issues or concerns to raise. We note that for the non-statutory consultation the seldom heard groups contacted were agreed with North Kesteven District Council with input from our Communities Team and that a briefing with councillors (NKDC) was held on 18 October 2024 in advance of the statutory consultation (PEIR) process. Council officers have also attended scheduled progress meetings including on specialist topic areas. Adequacy of Consultation Request – Application by Fosse Green Energy Ltd for a Development Consent Order for the Fosse Green Solar Farm in North Kesteven District in Lincolnshire.

Thank you for your email dated 26 March 2025, which included a stage 2 consultation compliance table Appendix A.3.

The Adequacy of Consultation Milestone (AoCM) was introduced through the Nationally Significant Infrastructure Projects (NSIP) Pre-Application Prospectus in 2024, and aims to facilitate an earlier consideration of the adequacy of consultation undertaken by the applicant at pre-application stage by the Planning Inspectorate. The written submission to the Inspectorate may include the views of local authorities.

The Prospectus sets out that written submissions should cover:

- The consultation undertaken to date
- The approaches set out in the Statement of Community Consultation
- Summarises the Consultation responses and the way in which they are shaping the application.

In response to your request for a view from Lincolnshire County Council on the adequacy of consultation and having had regard to Section 42 (Duty to consult), 47 (Duty to consult the local community) and 48 (Duty to publicise) of the Planning Act 2008 (as amended). I can confirm that Lincolnshire County Council is of the view that Fosse Green Energy Ltd to date has carried out adequate pre-application consultation in accordance with the requirements as set out in Sections 42, 47 and 48 of the Act.

The Applicant commenced early engagement with Lincolnshire County Council regular meetings with the Planning Lead together with technical meetings with other



specialist council officers and its consultants have taken place throughout the majority of the pre-application process. Fosse Green Energy Ltd formally consulted the Council on the draft Statement of Community Consultation (SoCC) on 07 November 2023.

There has been active engagement between the Fosse Green project team and Lincolnshire County Council throughout the pre-application process. This has included regular liaison meetings between council officers and the project team approximately once a month. The approach to consultation has been a key topic of discussion at relevant times. The Council has been given the opportunity to review and provide feedback on the draft SoCC, statutory and non-statutory consultations. The Council's feedback was taken into account.

We have been kept up to date on amendments to the proposals through liaison meetings, and have been invited to discuss our comments from the consultations and agree mitigation measures at topic based technical meetings in relation to highway, public rights of way, agricultural land, landscape and visual and ecology matters.

Lincolnshire County Council is therefore satisfied that an appropriate level of consultation has been conducted at this stage.
