The Proposed Development is defined as a Nationally Significant Infrastructure Project (NSIP) pursuant to s14(1) (a) and s15(1) and s15(2) of the Planning Act 2008 (PA 2008), as an onshore generating station in England with a capacity exceeding 50 megawatts (MW). S115 of the PA 2008 further states a DCO can include consent for 'associated development' which is development that is not an NSIP in its own right but is associated with the NSIP.

5. Non-technical description of the Proposed Development



* Brief non-technical description of the Proposed Development

The Proposed Development will comprise the construction, operation (including maintenance), and decommissioning of a ground-mounted solar photovoltaic (PV) electricity generating station with battery storage; Onsite Substation and associated infrastructure to generate and export and import electricity; and areas of landscaping and biodiversity enhancement.

The Proposed Development will export and import electricity to the national electricity transmission network. The associated development includes but is not limited to, access provision; Battery Energy Storage System (BESS); underground cabling; and areas of landscaping and biodiversity enhancement. The Proposed Development also includes a 400kV underground Cable Route Corridor of approximately 10km in length connecting the Onsite Substation and the proposed National Grid substation near Navenby (not part of this application).

The Order Limits are shown on the Location Plan [EN010154/APP/2.5] and Land Plans [EN010154/APP/2.1] and are located entirely within the administrative area of North Kesteven District Council and Lincolnshire County Council.

The Order Limits cover an area of approximately 1,368 hectares and includes the land required for the construction, operation (including maintenance), and decommissioning of the Proposed Development. The Order Limits include the Principal Site and Cable Corridor. The Order Limits also include a section of the A46, which is located in the north of the Principal Site, between Thorpe on the Hill and Swinderby.

The Site is located approximately 9km south and south west of Lincoln City Centre in a predominately agricultural landscape surrounded by the villages of Witham St Hughs, Bassingham, Thurlby and Thorpe on the Hill amongst others. The Order Limits consist primarily of agricultural fields interspersed with individual trees, small woodland blocks, hedgerows, linear tree belts, farm access tracks, and local transport roads.

The Principal Site is approximately 1,070 ha. It extends approximately 2km north of the A46 to the west of Thorpe on the Hill; approximately 4.5km south west of the A46 passing Bassingham on the west; and approximately 5.5km south east passing Bassingham to the east. The River Witham passes east west through the south Principal Site for approximately 0.7km between Aubourn and Thurlby. Several minor roads intersect the Principal Site including Moor Lane to the south west and Stone Lane which connects to the A46 from the south.

The Cable Corridor is approximately 351 ha. The Cable Corridor extends from the south east of the Principal Site for approximately 8km passing north of Boothby Graffoe before heading south passing the town for approximately 2.5km and heading west towards Navenby. The River Brant runs north south through the Cable Corridor where it meets the Principal Site. The Cable Corridor passes west to east across the A607, and both Heath Lane and Green Man Road run east west across the Cable Corridor east of Boothby Graffoe and Navenby.
