It was a privilege to meet you earlier this month in the Assembly rooms in our lovely Bailgate area of Lincoln, the Judicial Review for the following.....

Please find my comments typed up for you... Apols I was not totally prepared on the day.

Fosse Green Application for Solar farm on precious Arable food growing land, in Lincolnshire the TOP performing county in the uk with the richest fertile soil. Lincs grows 50% of the 50% the whole uk produces. So, this land is PRICELESS. We need to feed 68 million ppl here at the mo in the uk. The very best land , is Lincolnshire land, and we can only feed 17.5 million ppl. Of the 68million population.

The Great British Food Chain Industry based on East Anglia's rich flat lands, who's tentacles reach out to ,employ, support, provide and deliver to every corner of the UK, they are all connected vital links and cannot be broken without serious circumstances following.

1. First of all, those acres are not 'Brownfield' in the Legislative sense. It is not 'Waste land' and it is not land waiting to be developed in plastic, iron and concrete. This land is already in use growing fresh food and crops to feed livestock farmers elsewhere.

This land, is already supporting thousands of UK jobs and businesses , farmer, clients and suppliers, from the tip of Scotland to the West of west Wales. Where climates do not allow Grain food stuffs or Straw bedding to be grown.

Therefore farmers rearing cows for meat, milk or cheese need Lincs., farmers. Farmers rearing Pigs, Goats, Chickens for meat, milk, cheese or eggs still all need Lincolnshire crops and bedding to survive their winters.

This incredible GB Food Chain industry built up since the end of ww2, in 1945, feeds those farmers needs also. Thousands of young men and women gave their young lives for our priviledged Freedom .

That, we must Respect and Honour, for those brave young ppl. Have Gov not heard of the 40,000 ppl who starved to death in the 1960's in China due to NO Harvest. We must not, allow ourselves to be made Vulnerable by stealth.

We are now at the point where Development needs are out of balance in the uk, where houses were also built on precious food growing land, reducing our food self sufficiency percentage greatly. We need the future to be correct, for sustaining our childrens childrens children. So it is up to us, we must make sure we are heading in the right direction for future generations.

We must not let this loss of arable land continue, this trend of thousands of acres already lost , out of a very finely balanced, National Food Chain Industry, of which LINCOLNSHIRE is at the HEART of and the UKs top performing county in Food Production. We had a croft in Scotland for a couple of years, when our children ere small. Our neighbouring farmers would have given their EYE teeth for just a few acres of that envious , precious land.

Lincolnshire's determined farmers and helpful new technology in the 70's, enabled more food to be grown. In 1984 we reached 78/80% of Food Self Sufficiency, where crops support farms, shops and businesses, supermarkets, etc etc., the whole length and breadth of the uk. It was also very disturbing to see thousands of rich flat fertile arable acres in Cambridgeshire as I travelled home on the train recently, covered entirely with Solar panels. I understand, Essex, Norfolk, Suffolk and many more counties are experiencing this same Blight on the beautiful landscapes too and also' up in arms' about it.

My concerns are about the PRINCIPLES of the Losses within this application, even being considered, as I believe it is being looked at, and decided upon , Out of Context, in Isolation, NOT as part of a National Chain involving thousands of jobs and other businesses. Both as thousands of Clients, suppliers and transport, nationwide.

A. Agricultural jobs lost in Lincolnshire equal 2.5 for every acre lost.

B. Tourism in Lincolnshire , with £3 billion income supports at the moment, 28,000 jobs.

I feel these other Gov departments have not been included maybe in the initial debate of Gov allowing these massive Environmental and Character changes in the UK. I can find no evidence of their comments, concerns or approval anywhere on the Gov websites.
