# 1. Introduction

1.1.1 This Schedule of Negotiations and Powers Sought refers to:

- a. the name of the party affected by the Proposed Scheme, as described in the **Book of Reference [EN010154/APP/4.3]**;
- b. the plot numbers used in the **Book of Reference [EN010154/APP/4.3]** and **Land Plans [EN010154/APP/2.1]** to identify the plots of land within the Order limits within which the aforementioned party has an interest;
- c. the land power sought, being either:
- d. “all interests and rights” where the compulsory acquisition of the land is sought; and
- e. “acquisition of new rights” where the Applicant is seeking to acquire new rights or the power to impose restrictive covenants over the land;
- f. for the acquisition of new rights plots, the land power sought, by reference to the types of rights set below; and
- g. the purposes for which that plot of land is required, by reference to the Works Numbers in Schedule 1 of the **Draft Development Consent Order [EN010154/APP/3.1]** and the description of those Works; and
- h. a record and status of negotiations with that party in relation to all plots in which that party has an interest.

1.1.2 This Schedule of Negotiations and Powers Sought should therefore be read in conjunction with the **Book of Reference [EN010154/APP/4.3]** and **Land Plans [EN010154/APP/2.1]** for an understanding of the plot numbers, and with the **Works Plans [EN010154/APP/2.2]** and Schedule 1 to the **Draft Development Consent Order [EN010154/APP/3.1]** for an understanding of the Work Numbers.

1.1.3 Where a landowner is listed as a subsoil interest in the Status of Negotiations column the following assumption is made:

- a. This party is a presumed subsoil interest in highway land that may be affected by the cable route. It is noted that to prove that the presumption is correct, the landowner needs to produce evidence to show the subsoil is in their ownership and they may be entitled to compensation. However, in practice the value of that compensation is typically low, reflecting the fact that the subsoil is of little, if any, use to the landowner. The Applicant is willing to discuss these cable route proposals with any Interested Party or Affected Person that wishes to do so in this context.

1.1.4 The types of rights referred to, and as are set out in Schedule 9 of the draft DCO, are as follows:

- a. “access rights” means rights over land to, for the purposes of the authorised development and in connection with the authorised development—

- i. alter, improve, form, maintain, retain, use (with or without vehicles, plant and machinery), remove, reinstate means of access to the authorised development including visibility splays, bridges, culverts and road widening or improvements and to remove and traverse impediments (including vegetation) to such access;
  - ii. form, remove, reinstate passing places in the highway;
  - iii. pass and repass on foot, with or without vehicles, plant and machinery (including rights to lay and use any temporary surface);
  - iv. install, use, support, protect, inspect, alter, remove, replace, refurbish, reconstruct, retain, renew, improve and maintain security fencing, gates, boundary treatment, public rights of way and any other ancillary apparatus and any other works as necessary in connection with the access rights; and
  - v. restrict and remove the erection of buildings or structures, restrict the altering of ground levels, restrict and remove vegetation and restrict the planting of trees or carrying out operations or actions (including but not limited to blasting and piling) which may obstruct, interrupt or interfere with the exercise of the rights or damage the authorised development;
- b. “ancillary rights” means rights over land to, for the purposes of the authorised development and in connection with the authorised development, carry out such works as are required in connection with and in addition to Work Nos. 1 to 9 as specified in Schedule 1.
- c. “cable rights” means rights over land to, for the purposes of the authorised development and in connection with the authorised development—
- i. install, use, support, protect, inspect, alter, remove, replace, retain, renew, improve and maintain underground electrical cables, earthing cables, optical fibre cables, data cables, telecommunications cables and other apparatus, works associated with such cables including bays, ducts, protection and safety measures and equipment, and other ancillary apparatus and structures;
  - ii. remain, pass and repass on foot, with or without vehicles, plant and machinery (including rights to lay and use any temporary surface or form a temporary compound) for all purposes in connection with the authorised development;
  - iii. install, use, support, protect, inspect, alter, remove, replace, refurbish, reconstruct, retain, renew, improve and maintain sewers, drains, pipes, ducts, mains, conduits, services, flues and to drain into and manage waterflows in any drains, watercourses and culverts;
  - iv. install, use, support, protect, inspect, alter, remove, replace, refurbish, reconstruct, retain, renew, improve and maintain security fencing, gates, boundary treatment, public rights of way and any other ancillary apparatus and any other works as necessary in connection with the cable rights; and

- v. restrict and remove the erection of buildings or structures, restrict the altering of ground levels, restrict and remove vegetation and restrict the planting of trees or carrying out operations or actions (including but not limited to blasting and piling) which may obstruct, interrupt or interfere with the exercise of the rights or damage the authorised development;
- d. “substation connection rights” means rights over land to, for the purposes of the authorised development and in connection with the authorised development—
  - i. install, use, support, protect, inspect, alter, remove, replace, retain, renew, improve and maintain electrical cables, earthing cables, optical fibre cables, data cables, telecommunications cables and other services, works associated with such cables including bays, ducts, protection and safety measures and equipment, and other apparatus and structures and to connect such cables and services to the National Grid Navenby substation;
  - ii. install, use, support, protect, inspect, alter, remove, replace, refurbish, reconstruct, retain, renew, improve and maintain watercourses, sewers, drains, pipes, ducts, mains, conduits, services, flues and drainage apparatus and equipment and to drain into and manage waterflows in any drain, watercourse and culvert;
  - iii. remain, pass and repass on foot, with or without vehicles, plant and machinery (including rights to lay and use any temporary surface or form a temporary compound) for all purposes in connection with Work No. 5;
  - iv. restrict and remove the erection of buildings or structures, restrict the altering of ground levels, restrict and remove the planting of trees or carrying out operations or actions (including but not limited to blasting and piling) which may obstruct, interrupt or interfere with the exercise of the rights or damage the authorised development; and
  - v. install, use, support, protect, inspect, alter, remove, replace, retain, renew, improve and maintain soft landscaping and biodiversity measures;
- e. “vegetation maintenance rights” means rights over land to, for the purposes of the authorised development and in connection with the authorised development—
  - i. install, use, support, protect, inspect, alter, remove, replace, repair, retain, renew, relocate, improve and maintain vegetation including trees, woodlands, shrubs, hedgerows, seeding, landscaping and other ecological measures and restrict or prevent the removal of vegetation and other ecological measures for the purposes of the authorised development and in connection with the authorised development; and
  - ii. remain, pass and repass on foot, with or without vehicles, plant and machinery for all purposes in connection with the implementation and



maintenance of landscaping and ecological mitigation or enhancement works.
