## Planning Act 2008 – section 102A

### Application by Fosse Green Energy Limited for an order granting development consent for the Fosse Green Energy project

#### Request to become interested parties

We refer to the requests, dated 26 January 2026, for Navenby Energy Limited and Squared Limited to become interested parties under section (s) 102A of the Planning Act 2008 (PA2008) in relation to some land within the proposed Order Limits that is also subject to the planning application for the proposed Navenby battery energy storage system (BESS). We further refer to your:

- a) submission of a representation on 27 January 2026 and to your subsequent request on 30 January that that correspondence not be published because discussions were ongoing with the applicant in relation to matters of concern to those promoting the proposed Navenby BESS; and
- b) submission of a letter on 20 March 2026 objecting to the proposed development.

Based on the information that you have provided with the request of 26 January 2026, the Examining Authority (ExA) has decided it considers that:

- a) Navenby Energy Limited, as a tenant of some of the land within the proposed Order Limits (as of 7 June 2025), should be considered as a person within Category 1 under s102(B)(1) PA2008; and
- b) Squared Limited, as a person with the power to sell and convey some of the land within the proposed Order Limits (as of 15 January 2025), should be considered as a person within Category 2 under s102(B)(2)(b) PA2008.

This letter therefore notifies you that Navenby Energy Limited and Squared Limited have become interested parties under s102(1)(ab) PA2008 from today's date. Their unique reference numbers are respectively [REDACTED] and [REDACTED]. Please ensure you quote those numbers in any future correspondence.

The ExA requests that on receipt of this letter you immediately notify it of the land plot numbers identified on the Land Plans [AS-104] that Navenby Energy Limited and Squared Limited have interests in because your letter of 20 March 2026 does not do that.
