# 1. Introduction

- 1.1.1 This **Guide to the Application [EN010154/APP/1.3]** accompanied an application submitted by Fosse Green Energy Limited (the 'Applicant') to the Secretary of State for Energy Security and Net Zero (the 'Secretary of State') for development consent to construct, operate and maintain and decommission an energy generation station on land approximately 9km south and south west of Lincoln.
- 1.1.2 The Development Consent Order (DCO) application has been submitted to the Secretary of State under s37 of the Planning Act 2008 (the PA 2008) for the Fosse Green Energy project (the Proposed Development). The Proposed Development is classified as a Nationally Significant Infrastructure Project (NSIP) under s14(1)(a), s15(1) and s15(2) of the PA 2008, as it is an onshore generating station in England with a capacity exceeding 50 megawatts (MW).
- 1.1.3 This Guide to the Application was prepared in accordance with Regulation 5(2)(q) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (the APFP Regulations) to support the application. The following section explains the purpose of this document in the context of the DCO application.

## 2. Purpose of this Guide to the Application

- 2.1.1 This **Guide to the Application [EN010154/APP/1.3]** provides an overview of the documents that were prepared in order to satisfy the APFP Regulations, the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 and s37 of the PA 2008.
- 2.1.2 Regulation 5(2) of the APFP Regulations sets out the documents that must accompany all DCO applications. This includes Regulation 5(2)(q) which requires the submission of ‘any other documents considered necessary to support the application’ as well as Regulation 5(2)(o) which requires ‘any other plans, drawings and sections necessary to describe the proposals for which development consent is sought’. Regulation 6 of the APFP Regulations sets out the specific documentation required in support of DCO applications for particular types of development, including the construction of a generating station. This document provides a full list of documents prepared to meet the requirements of Regulation 5 and 6 of the APFP Regulations.
- 2.1.3 This Guide to the Application is a live document that will be updated as part of the Applicant’s submission for each Examination deadline. In accordance with the Rule 6 Letter **[PD-008]**, this Guide to the Application provides a list of the most up-to-date version of all documents submitted by the Applicant either:
- a. as part the originally submitted application and then subsequently updated during the course of either the pre-examination or examination periods; or
  - b. any other documents submitted by the Applicant during the course of the examination including any updates to any such documents that may subsequently be revised during the examination.
- 2.1.4 Furthermore, the updates to this Guide to the Application record the following details:
- a. The reference number allocated to documents by the Applicant and the version number of the document;
  - b. The submission details for documents that have not previously been submitted nor have been the subject of revisions; and,
  - c. The Examination Library reference number allocated to the document by the Planning Inspectorate when this is known.
- 2.1.5 A final version of this Guide to the Application will be submitted at Deadline 7 of the Examination, scheduled for 9 June 2026, in accordance with the Rule 8 Letter **[PD-010]**.
