# 1. Introduction

- 1.1.1 An application (the Application) was made to the Secretary of State for Energy Security and Net Zero for a Development Consent Order (DCO) under section 37 of the Planning Act 2008 (PA 2008) for Fosse Green Energy (the Proposed Development). The Application was submitted by Fosse Green Energy Limited (the Applicant) on 18 July 2025 and was accepted for examination on 15 August 2025. The examination of the Application commenced on 6 January 2026.
- 1.1.2 The Proposed Development will comprise the construction, operation (including maintenance) and decommissioning of a ground-mounted solar photovoltaic (PV) electricity generating station with battery storage, onsite substation and associated infrastructure to generate and export/import electricity.
- 1.1.3 The associated infrastructure includes, but is not limited to, access provision, underground cabling, areas of landscaping and biodiversity enhancement, and a 400 kilovolt (kV) underground grid connection cable circuit (approximately 10 kilometre (km)), connecting to the national electricity transmission network at a proposed National Grid substation near Navenby.

## 1.2 Purpose of this document

- 1.2.1 In Annex F of the Rule 6 Letter **[PD-008]**, the Examining Authority (ExA) has requested updates to the Book of Reference and the Statement of Reasons at specified Examination deadlines. In addition, the ExA has also requested the production of a 'Schedule of Land Rights Changes' report setting out the reasons for the changes included in each update. This document comprises the Schedule of Land Rights Changes.
- 1.2.2 This Schedule of Land Rights Changes should be read in conjunction with the updated Book of Reference **[EN010154/APP/4.3] (Rev 3)** submitted at Deadline 2 alongside this document, and the Statement of Reasons **[REP1-013]** submitted at Deadline 1. This Schedule of Land Rights Changes details all changes in land ownership and any changes to the Statement of Reasons. This Schedule of Land Rights Changes should also be read in conjunction with the Schedule of Negotiations and Powers Sought **[EN010154/EXAM/9.6] (Rev 4)**.
- 1.2.3 The information in the Book of Reference **[EN010154/APP/4.3] (Rev 3)** and the Schedule of Negotiations and Powers Sought **[EN010154/EXAM/9.6] (Rev 4)** is regularly kept up to date through the refresh of HMLR data and ongoing engagement with landowners. Updates to this Schedule of Land Rights Changes will be submitted to the ExA as and when there are any updates made to the Book of Reference and Statement of Reasons.

- 1.2.4 Note that the Table at section 3 of this document includes changes made to the Statement of Negotiations and Powers Sought whilst that document was included as Annex A to the Statement of Reasons. Since the Status of Negotiations and Powers Sought was "de-coupled" from the Statement of Reasons any updates to the Status of Negotiations and Powers Sought can be seen in that document submitted at the latest Deadline.
