# 1. Introduction

## 1.1 Purpose of this Schedule of Changes

- 1.1.1. This Schedule of Changes to the Book of Reference ('BoR') relates to an application made by FVS Dean Moor Ltd (the 'Applicant') on 26<sup>th</sup> March 2025 under section 37 of the Planning Act 2008 (the 'PA 2008') for an order to grant development consent for the Dean Moor Solar Farm (the 'Proposed Development'). The DCO application was accepted for examination on 15<sup>th</sup> April 2025.
