Applicant Response to Deadline 6 of the Examination

1. Submissions made at Deadline 6

Please find below the list of documents submitted by the Applicant at Deadline 6 (D6).

For the documents related to the Development Consent Order (DCO), the D6 submission includes the final DCO, accompanied by the Schedule of Changes setting out the changes from the version submitted at D5, and Validation Report. The draft DCO is also provided in Word format. This version of the draft DCO is the Applicant's preferred version and the Applicant respectfully requests that the Examining Authority recommends this version to the Secretary of State.

Separately, the Applicant has further provided a combined response to the ExA's Rule 17 Letter [[PD-017](#)] and the Schedule of Changes [[PD-018](#)].

The updated Land and Rights Negotiations Tracker confirms that agreements have been reached with all affected parties who raised objections, other than 12 Property FE Limited. The Applicant submits its Closing Submissions which summarise the principal issues that have been raised throughout the Examination. The intention of this document is to assist the ExA and the Secretary of State by clarifying the position on various key matters at the close of examination. The document does not introduce new matters. It explains the Applicant's final position on matters and signposts to existing submission material as appropriate.

The Book of Reference has been updated to reflect any changes since submission. Only non-material changes have been made, and no new parties with an interest in land have been identified. A Schedule of Changes has been provided accordingly. No changes were required to the Statement of Reasons [[APP-014](#)] or Funding Statement [[APP-015](#)]. The final versions of those documents are the submission versions.

The Applicant has submitted a response to the D5 Written Representations from the Council, Lake District National Park Authority, Ms Carling and Mr Fulton, Mr Howell, and Neto Energy on behalf of Potato Pot Wind Farm.

Responses to the questions received from the ExA within the Report on the Implications for European Sites ('RIES') [PD-016] were submitted by the Applicant on the 12 December 2025. The Applicant notes the submission from Natural England which affirms the Applicant's response to the RIES.

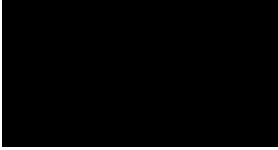
