A. Introduction

A.1 Purpose of this Document

- A1.1 This Guide to the Application has been produced by FVS Dean Moor Limited (the ‘Applicant’) to support the Development Consent Order (‘DCO’) application (the ‘Application’) for the Dean Moor Solar Farm (the ‘Proposed Development’).
- A1.2 The Application is submitted to the Planning Inspectorate who will provide a recommendation to the Secretary of State for Energy Security and Net Zero who will make a final decision on whether to grant consent for the Proposed Development pursuant to the Planning Act 2008¹ (the ‘PA 2008’).
- A1.3 To assist the Examining Authority and Interested Parties in interpreting the Application, this Guide to the Application contains brief descriptions of the Application documents that have been submitted to satisfy the PA 2008, the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009² (the ‘APFP Regulations’) and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017³ (the ‘EIA Regulations’).
- A1.4 Regulation 5 of the APFP Regulations sets out the documents that all draft DCO applications must include. It also provides at Regulation 5(2)(q) for the submission of “*any other documents considered necessary to support the application*” as well as at Regulation 5(2)(o) for “*any other plans, drawings and sections necessary to describe the proposals.*”
- A1.5 Regulation 6 of the APFP Regulations sets out the specific documentation required in support of draft DCO applications for particular types of development, including generating stations.

- A1.6 Due to the extent of the submission documentation, brief descriptions are not provided for all Application documents such as the Environmental Statement ('ES') which contains chapters, figures and appendices.
- A1.7 This Guide to the Application additionally includes a list of all submission documents at Section 8, Table 8.1 of this document. This will be updated throughout examination to indicate any submission documents that have been updated, and any new documents submitted during this period.

A.2 The Applicant

- A2.1 FVS Dean Moor Limited is a joint-venture partnership between two renewable energy development specialists: Firma Energy ('Firma Energy'); and ib vogt ('IBV').
- A2.2 Firma Energy, founded in 2021, is an independent management-owned energy development company based in Leeds. Firma Energy focuses on creating and delivering renewable energy developments with environmental and social benefits.
- A2.3 IBV is a leading renewable energy developer specialising in utility-scale solar farm and BESS infrastructure.

A.3 Overview of the Proposed Development

- A3.1 The Proposed Development comprises the construction, operation, and decommissioning of a solar photovoltaic ('PV') energy generating station with a total capacity exceeding 50 Megawatts ('MW') comprising solar PV arrays, grid connection infrastructure, associated infrastructure, and green infrastructure.
- A3.2 The Proposed Development will be located on approximately 276.5 hectares ('ha') of land located between the villages of Gilgarran and Branthwaite in West Cumbria (the 'Site') (as shown on the Location Plan **[REF: 2.1]**), which is situated within the administrative area of Cumberland Council ('the Council'). The Proposed Development will be within the 'Order Limits' (the land shown on the Works Plans **[REF: 2.3]** within which

the Proposed Development can be carried out). The extent of the Site is the same as the Order Limits.

A3.3 A detailed technical description of the Proposed Development is provided in ES Chapter 3 – Site and Description of Development [REF: 6.1].

A.4 Application Document Volumes

A4.1 In accordance with guidance provided by the Planning Inspectorate, ‘Advice on the Preparation and Submission and of Application Documents’⁴, the Application documents are contained within seven document volumes which are described in Table A.1 below.

A.5 Document Reference Numbering

- A5.1 The Application documents are numbered sequentially and correspond with the document volume they are situated in.
- A5.2 The first digit of the document reference number indicates the document volume (this will be 1-7). The second digit of the document reference number indicates the order that the document (or the chapter, figure, or appendix number where these are standalone) appears in its volume.
- A5.3 For example, the Works Plans are within document volume two of the submission and are the third item within that volume, therefore the document reference number is as follows: Works Plans **[REF: 2.3]**.

1 Volume 1 – Application Form

1.1 Application Form

- 1.1.1 The Application Form **[REF: 1.1]** provides the necessary information the Planning Inspectorate will need to register the Application, including its purpose, location and scope. This is the standard form required under Regulation 5(1) of the APFP Regulations and Section 37(3)(b) of the PA 2008.

1.2 Application Cover Letter

- 1.2.1 The Application Cover Letter **[REF: 1.2]** provides a brief overview of the Proposed Development and a general introduction to the Application. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

1.3 Guide to the Application

- 1.3.1 The purpose of the Guide to the Application **[REF: 1.3]** (this document) is set out in Section A of this document. Brief overviews of the Application documents are provided as well as the Dean Moor Solar Farm DCO Document Tracker (Table 8.1) which contains the status and revision of each document. Table 8.1 will be kept up to date throughout the examination period. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

1.4 Application Acceptance Checklist

- 1.4.1 The Application Acceptance Checklist **[REF: 1.4]** provides a compliance schedule prepared by the Applicant to show that the Application meets the requirements for acceptance under Section 55 of the PA 2008. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

2 Volume 2 – Plans, Drawings and Sections

2.1 Location Plan

2.1.1 The Location Plan **[REF: 2.1]** illustrates the location of the Proposed Development in its wider geographical context in accordance with Regulation 5(2)(o) of the APFP Regulations.

2.2 Land Plans

2.2.1 The Land Plans **[REF: 2.2]** set out:

- The land required for or affected by the Proposed Development;
- Land over which powers of Compulsory Acquisition or any right to use land or impose restrictions may be exercised;
- Any land in relation to which it is proposed to extinguish easements, servitudes and other private rights.

2.2.2 The Land Plans are required under Regulation 5(2)(i) of the APFP Regulations. They correspond with and should be read alongside the Book of Reference **[REF: 4.3]**.

2.3 Works Plans

2.3.1 The Works Plans **[REF: 2.3]** show the locations of the works and the limits within which the Proposed Development and works may be carried out, they accord with the requirements of Regulation 5(2)(j) of the APFP Regulations. The areas on the Works Plans are numbered and correspond with the numbered works set out in Schedule (1) of the Draft Development Consent Order **[REF: 3.1]**.

2.4 Streets and Access Plans

2.4.1 The Streets and Access Plans **[REF: 2.4]**, in accordance with Regulation 5(2)(k) of the APFP Regulations, detail the proposed modifications to existing streets and accesses required for the Proposed Development.

2.5 Traffic Regulations Measures Plan

2.5.1 The Traffic Regulations Measures Plan **[REF: 2.5]**, in accordance with Regulation 5(2)(o) of the APFP Regulations, details any temporary traffic

regulation measures, such as potential road closures required for the Proposed Development.

2.6 Plans of Statutory and Non-Statutory Sites or Features of Nature Conservation

2.6.1 The Plans of Statutory and Non-Statutory Sites or Features of Nature Conservation **[REF: 2.6]** illustrate the statutory and non-statutory nature conservation, habitats, and water body designations within the vicinity of the Proposed Development, as per Regulation 5(2)(l)(i) of the APFP Regulations.

2.7 Plans Showing Statutory or Non-statutory Historic or Scheduled Monuments Sites

2.7.1 The Plans showing Statutory or Non-Statutory Historic or Scheduled Monument Sites **[REF: 2.7]** illustrate the statutory and non-statutory historic or scheduled monument sites and features within the vicinity of the Proposed Development, as per Regulation 5(2)(m) of the APFP Regulations.

3 Volume 3 – Draft Development Consent Order

3.1 Draft Development Consent Order

3.1.1 The Draft Development Consent Order (the ‘Order’) sets out the legal powers that the Applicant is seeking to enable it to construct, operate (and maintain) and decommission the Proposed Development should consent be granted. This document is required under Regulation 5(2)(b) of the APFP Regulations.

3.1.2 The Order contains 14 Schedules which are outlined below:

- Schedule 1 (Authorised development) - specifies numbered works comprised in the authorised development (the Proposed Development) for which development consent is sought and other associated development works. The works should be read alongside the Works Plans.
- Schedule 2 (Requirements) - contains draft requirements corresponding to conditions which, under section 120(2) of the PA 2008, could have been imposed on the grant of planning permission for the authorised development had it not fallen within the regime of the Act. The requirements have a similar purpose to planning conditions.
- Schedule 3 (Legislation to be disapplied) - lists the local legislation that the Order will disapply insofar as the provisions (in that local legislation) still in force are inconsistent with the powers contained in the Order.
- Schedule 4 (Streets subject to streets works) - lists the streets subject to street works pursuant to the power contained in article 12 (Street works) of the Order.
- Schedule 5 (Alteration of streets) - lists the streets which will be permanently altered pursuant to the power contained in article 14 (power to alter layout, etc. of streets) of the Order.
- Schedule 6 (Streets to be temporarily closed or restricted) - sets out the streets which are subject to temporary closure, alteration, diversion or restriction under article 16 (Temporary closure or restriction of streets) of the Order.
- Schedule 7 (Access to works) - sets out the form and layout for the permanent means of access, or to improve existing means of access, in the locations specified in Part 1 and form and layout of the temporary means of access in the location specified in Part 2.
- Schedule 8 (Traffic regulation measures) - contains details of the streets that are subject to temporary traffic regulation measures pursuant to article 19 (Traffic regulation measures) of the Order and

contains the details of the nature of the measures for each affected street.

- Schedule 9 (Land in which only new rights etc. may be acquired) - sets out the areas of land over which only new rights may be acquired by the undertaker and the nature of the rights that may be acquired. The plot numbers in column 1 of that table correlate with the Land Plans, column 2 corresponds with the relevant work numbers and column 3 explains the purposes for which rights over land may be acquired. The Schedule relates to article 26 (Compulsory acquisition of rights) of the Order.
- Schedule 10 (Modification of compensation and compulsory purchase enactments for the creation of new rights and imposition of new restrictive covenants) - modifies existing compensation legislation including the Land Compensation Act 1973⁵ and the Compulsory Purchase Act 1965⁶. This has been updated to reflect any necessary changes arising as a result of the Housing and Planning Act 2016⁷. The Schedule relates to article 26 (Compulsory acquisition of rights).
- Schedule 11 (Land of which temporary possession may be taken) - sets out the land referred to in article 34 (Temporary use of land for carrying out the authorised development) of the Order, which the Applicant may temporarily occupy and the purpose for which that temporary occupation may be taken.
- Schedule 12 (Acquisition of wayleaves, easements and other rights) - makes provision for the undertaker to act on behalf of statutory undertakers in acquiring wayleaves, easements or other rights for the diversion or relocation of electricity, gas, water, sewerage or telecommunication apparatus.
- Schedule 13 (Documents and plans to be certified) - lists the documents and plans to be submitted with the Application and to be certified by the Secretary of State.
- Schedule 14 (Protective provisions) - sets out the provisions for the protection of statutory undertakers affected by the authorised development. Part 1 provides protection for the electricity, gas, water and sewerage undertakers. Part 2 provides protection for operators of electronic communications code networks. Part 3 provides protection for drainage authorities.

3.2 Explanatory Memorandum

- 3.2.1 The Explanatory Memorandum **[REF: 3.2]** explains the provisions in the Order, setting out their purpose and effect as per Regulation 5(2)(c) of the

APFP Regulations. It also identifies examples of precedents from other DCOs where applicable.

4 Volume 4 – Compulsory Acquisition Information

4.1 Statement of Reasons

- 4.1.1 The Statement of Reasons **[REF: 4.1]** explains that there is a compelling case in the public interest which would justify the Applicant's exercise of powers of compulsory acquisition in order to acquire land and rights permanently and to use land temporarily to enable it to construct, operate, maintain and decommission the Proposed Development. This document is provided under Regulation 5(2)(h) of the APFP Regulations. This should be read alongside the Pre-application Land and Rights Negotiations Tracker **[REF: 4.4]** which sets out the status of negotiations with landowners and the powers sought over the Order land.

4.2 Funding Statement

- 4.2.1 The Funding Statement **[REF: 4.2]** outlines how the Proposed Development, including any compulsory purchase acquisition, will be funded in accordance with Regulation 5(2)(h) of the APFP Regulations.

4.3 Book of Reference (Parts 1-5)

- 4.3.1 The Book of Reference **[REF: 4.3]** corresponds with the Land Plans and identifies all parties who own or occupy land and / or have an interest in, or right over land affected by the Proposed Development, and / or who may be entitled to make a 'relevant claim' as defined in Section 57 of the PA 2008.
- 4.3.2 The Book of Reference is required in accordance with Regulation 5(2)(d) of the APFP Regulations. It is structured in five parts, in accordance with the regulatory requirements:
- a. Part 1: Categories 1 & 2: Owners, Lessees, Tenants, Occupiers, Other Interest, Power to Convey or Release Land;
 - b. Part 2: Category 3: Section 10 Compulsory Purchase Act 1965 and Part 1 Land Compensation Act 1973 and Section 152(3) of the PA 2008;

- c. Part 3: Easements or other private rights proposed to be interfered with, suspended or extinguished;
- d. Part 4: Crown Interests; and
- e. Part 5: Special Category Land.

4.3.3 The Proposed Development does not have any Crown Land or Special Category Land within the Order Limits.

4.4 Pre-application Land and Rights Negotiations Tracker

4.4.1 The Pre-application Land and Rights Negotiations Tracker provides a comprehensive view of the progress of securing the necessary land and rights for the Proposed Development, summarising ongoing negotiations, agreements reached, and any objections or issues that need resolution. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

5 Volume 5 – Reports and Statements

5.1 Consultation Report

5.1.1 The Consultation Report **[REF: 5.1]** is required under Section 37(3)(c) of the PA 2008. The Consultation Report explains how the Applicant has complied with the consultation requirements set out in the PA 2008, the APFP Regulations and the EIA Regulations. This document is submitted under Regulation 5(2)(q) of the APFP Regulations and has been written in accordance with all relevant guidance including Nationally Significant Infrastructure Projects: Advice on the Consultation Report⁸.

5.1.2 The report is set out into Chapters and details all of the consultation that has been conducted by the Applicant before the submission of the Application. Both formal and informal consultation methods with statutory consultees are included and the responses are summarised with an explanation of how the Applicant has had regard to the responses.

5.1.3 The Consultation Report contains the following chapters:

- Chapter 1 – Introduction
- Chapter 2 – Early Engagement and Non-Statutory Consultation
- Chapter 3 – Environmental Impact Assessment ('EIA') Consultation
- Chapter 4 – Statement of Community Consultation ('SoCC')
- Chapter 5 – Statutory Consultation
- Chapter 6 – Summary of responses received to statutory consultation
- Chapter 7 – Further/Ongoing Engagement [and Statements of Common Ground]
- Chapter 8 – Conclusions

5.2 Consultation Report Appendices

5.2.1 The Consultation Report Appendices **[REF: 5.2]** comprise a number of appendices containing evidence and supplementary material to support the Consultation Report. Key appendices include:

- Appendix 4.5 - Published 2024 Statement of Community Consultation;

- Appendix 6.1 - Summary of the matters raised by section 47 consultees, section 42(1)(a) prescribed consultees, section 42(1)(b) local authorities, and section 42(1)(d) PILs consultees in response to question 1-19 of the statutory consultation

5.3 Statutory Nuisance Statement

- 5.3.1 The Statutory Nuisance Statement **[REF: 5.3]** addresses potential statutory nuisances that might arise from the Proposed Development as defined under Section 79(1) of the Environmental Protection Act 1990.
- 5.3.2 The statement identifies and assesses potential nuisances including the general site condition, air quality (including dust, steam and odour), artificial light, and noise and vibration that could affect the surrounding community. It also outlines measures to mitigate these nuisances and demonstrates how the Proposed Development will comply with the relevant environmental regulations. This document has been prepared as per Regulation 5(2)(f) of the APFP Regulations.

5.4 Consents and Agreements Position Statement

- 5.4.1 The Applicant requires a range of consents and agreements to construct and operate the Proposed Development. As explained in the Explanatory Memorandum to the Order, some of these are included in the Order, however, there are other consents from different regulatory organisations that will be required separately to the Order. The need for such consents and how these are to be obtained is explained in the Consents and Agreements Position Statement **[REF: 5.4]**. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

5.5 Planning Statement

- 5.5.1 The Planning Statement **[REF: 5.5]** (provided under Regulation 5(2)(q) of the APFP Regulations) describes the relevant planning policy and legislative background for the Proposed Development including local and

national policy guidance. It gives a comprehensive overview of the Proposed Development, explaining its purpose, location, and key components. As well as demonstrating accordance with relevant policy and legislation, the Planning Statement sets out the need for the Proposed Development. As part of the Planning Statement, the potential environmental, social, and economic impacts of the Proposed Development are evaluated and the measures proposed to mitigate them are outlined.

5.6 Policy Compliance Document

- 5.6.1 The Policy Compliance Document [REF: 5.6] outlines how the Proposed Development complies with relevant policy. The Proposed Development's alignment with the relevant national and local planning policy documents is interrogated throughout the document. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

5.7 Design Parameters Document

- 5.7.1 The Design Parameters Document (DPD) [REF: 5.7] sets out detailed descriptions of the dimensions of the Proposed Development, such as maximum and minimum heights, footprints, and other critical measurements that have informed the assessment of likely significant effects in the ES. The DPD is secured by Requirement [3] of the Order to ensure that the Proposed Development stays within defined limits during its detailed design and construction phases, helping to manage expectations and maintain consistency. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

5.8 Design Approach Document

- 5.8.1 The Design Approach Document (DAD) [REF: 5.8] demonstrates how the Proposed Development has considered the National Infrastructure Commission's Design Principles and 'good design' set out in local and national policy. It provides a broader overview of the design principles and strategies guiding the design of the Proposed Development. It explains the context of the design, including considerations for the landscape, visual

impact, cultural heritage, and biodiversity, setting out how the Proposed Development integrates well with its surroundings and meets high standards of design quality. The DAD also details the evolution of the design, explaining the rationale behind key decisions and how the design has developed over time. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

5.9 Potential Main Issues for Examination Document

5.9.1 The Potential Main Issues for Examination Document **[REF: 5.9]** summarises the matters considered by the Applicant as not yet resolved with stakeholders as informed by ongoing engagement. Each potential issue is described and 'RAG' rated in terms of the likelihood of being resolved during examination. This document is submitted under Regulation 5(2)(q) of the APFP Regulations.

6 Volume 6 – Environmental Statement

6.1 Overview

- 6.1.1 The Applicant has conducted an EIA for the Proposed Development to consider what significant effects the Proposed Development is likely to have on the surrounding environment. This has been prepared in accordance with the EIA Regulations.
- 6.1.2 The findings of the EIA are reported within the ES. The submission of an ES is required under Regulation 5(2)(a) of the APFP Regulations.
- 6.1.3 The ES is divided into four volumes:
- ES Volume 1 – Chapters
 - ES Volume 2 – Figures
 - ES Volume 3 – Appendices

- The Outline Construction Traffic Management Plan ('OCTMP') **[REF: 6.3]** – sets out the measures proposed to manage traffic and access during construction of the Proposed Development and the mitigation to minimise impacts onto the public highway network and receptors in proximity.
- The Outline Soil Management Plan ('OSMP') **[REF: 6.3]** – is intended to identify and safeguard the soil resources (topsoil and subsoil) on Site and outlines best practice for the protection of soils during construction of the Proposed Development.
- The Outline Landscape and Ecological Management Plan ('OLEMP') **[REF: 6.3]** – sets out the management of landscape and ecology features and elements within the Site and targets for the long-term condition of new features that are set out in the Landscape Strategy Plan **[REF: 6.3]**.
- Outline Operational Management Plan ('OOMP') **[REF: 6.3]** – sets out the roles and responsibilities and environmental management measures which would support the operation of the Proposed Development.
- The Framework Decommissioning Management Plan ('FDMP') **[REF: 6.3]** – provides a framework for a future Decommissioning Management Plan ('DMP'), setting out expectations and commitments

- 6.4.3 Detailed versions of the management plans will be prepared post consent (should consent be granted) as secured by Requirements set out in the Order.
- 6.4.4 In addition, the Applicant has prepared an Archaeological Mitigation Strategy ('AMS') **[REF: 6.3]** and an Outline Drainage Strategy ('ODS') (contained within ES Appendix 2.4 **[REF: 6.3]**).
- 6.4.5 The AMS has been produced in order to secure a programme of archaeological fieldwork in association with the pre-commencement and construction phases of the Proposed Development. The archaeological work set out in the AMS comprises a staged programme of work to be secured by DCO Requirement; this approach has been adopted to account for varying archaeological potential across different sections of the Site.
- 6.4.6 The ODS sets out the surface water drainage requirements for the Proposed Development. A detailed drainage strategy will be developed post consent (should consent be granted) as secured by DCO Requirement. The final strategy will include details around the adoption of Sustainable Drainage Systems ('SuDS') and the SuDS maintenance plan, including a maintenance schedule and details of easements and outfalls for the drainage system.
