I'm a planning inspector employed by the Planning Inspectorate, and have been appointed by the Secretary of State for Levelling Up, Housing and Communities to be the lead member of the panel to examine this application. I'm now going to ask to the panel member, who has also been appointed by the same Secretary of State, to introduce herself.

Good afternoon. My name is Mary Louise Milliken. I'm a chartered town planner and a planning inspector.

Uh, my name is George McManus, and I'm here today to represent the area's campaign, which is East Riding against solar expansion, which is a group of volunteers who live here in the East riding across the patch, who are involved in numerous campaigns, specifically because they are concerned about applications for what is classified as nationally significant infrastructure projects in CIPs.

We've identified four projects from Howdon over to here which occupying uh likely to occupy in total smaller projects something like 20,000 acres of the East Riding. And we are the umbrella group

speaking on their behalf. But I'm a retired civil engineer and civil servant, and I'm here in that capacity.

And through our website and other contact pages, I want to start off with raising some of the issues that have been raised with us by them. Uh, first of all, it's the issue of context, and that I understand that this is obviously our proposal for the Pear Tree Hill.

But people have spoken to me and said, we have to see the wider picture in this. As I say, 20,000 acres of farmland representing 3% of the crop area, much of it, we believe, of best and most valuable land. Although at this point in time I haven't had a response from our W.E. as to which category the land the land in the Purple Project falls into. Because the government, as you know, is discouraging any such developments on grades one, two and three a land.

Uh, so hopefully at some point in time we'll get that information. People have asked, people have raised the question of food security. And a big rural area for security is of enormous importance, not just to the people that are watching it, because almost everybody knows somebody who has uh, and the associated industries such as horticulture. Whilst the Planning Inspectorate is here, I hope you take the opportunity to visit a couple of people. I'm going to be very careful because I have been speaking to some very vulnerable individuals, including people who fear that they might lose their livelihoods as a result of these proposals.

They don't tend to speak out about these things in public. So much of what has been taught to me has been in confidence, but I can't. I hope that when you get an opportunity to pay a further visit, you'll visit Risdon Plants. It's a small nursery, but 20 acres, uh, between Launceston and Arnold. Second or third generation farm family run a horticulture nursery and their lives are going to be ruined because they are going to be under siege because of Patrick Hill.

I'm also speaking to other farmers who are very concerned in the surrounding villages, such as Meux and Arnold, who fear that if they speak out, they'll be in trouble, because these are generally people

who are not landowners, but tenant farmers who have very much been marginalized. And much of this process, although I'm sure you are doing the best to try and engage. These are people that don't tend to raise their heads above the parapet. Another point that was raised to me, somebody asked, somebody raised the issue of various people have raised issues of biodiversity, and my automatic response is to refer them to the library pages of the documents.

The biodiversity section and volume two of the documents on the library stretches to 15.

The environmental statement stretches the 15 chapters It's taken up to 1200 pages. The biodiversity statement itself, I think, is 160 pages included as one of those 15 chapters. So one of the most common complaints I've had is information overload. How is the general public possibly going to get to grips with the tsunami of information that's coming out on this? Now, I understand that RWA are under responsible for producing these documents, and I'm sure they've done it very diligently.

But if this is a genuine consultation process meant to engage with the general public, I'm afraid it is not user friendly.

The big issue, probably the big issue that has been brought up by the public is visual impact. Whether you live in Scarborough, whether you live in Bridlington or Hornsea, or whether you live in Halifax or Barnsley, you probably holiday on the East Yorkshire coast, and at some point tourism is extremely important to this part of the world. The visual impact of 20,000 acres of the East Riding being given over to fields of plastic is going to be dramatic.

People struggle to envisage that. So when we try to explain it to them, we try to put it in simple terms. Petrie Hill will cover an area the equivalent of 1500 football pitches. A small solar farm that's been proposed down the road. At most Croft is a 10th the size. Obviously, that's not an end to the local planning process, but when people have asked us how they can complain about this, which council they should raise it with, I've had to point out that being an insect, this is not about the normal planning process, that this is where the Planning Inspectorate comes in.

So whilst there have been lobbying councillors and MPs, peace. People really feel powerless when it comes to trying to influence the outcomes in this. Can I raise a couple of personal points? Because it's to do with the consultation or lack of it that I've had with RWA personally. Uh, I want to mention one thing to start off with this morning I was talking about light pollution, and from October to February last year, I tried to arrange an onsite meeting with RWA to take light meter readings.

You'll be familiar with the light meter that photographers carry. Well, I carry a darkness meter that measures the level of light pollution in the night sky. And one of the things that is so important to people that live here are the night skies. 80% of this country has never seen the Milky Way, but 80%

of the people living in this riding have. And that is something that has to be protected when I put it to you that there was a much simpler way to monitor this with automatic light metering systems that we use up in the North York Moors National Park, at which cost them a couple hundred pounds.

They said they never had that in the budget, but they've got it in the budget to rent protecting Greens hotel. I would have thought that a couple hundred pounds wasn't beyond imagination to do some serious research, so I was very disappointed with that. The other issue that I want to raise before my time is up is the issue

that is particularly close to my heart, and I know that bothers a lot of people, which is ethical supply chains. When it comes to solar panels and inverters and the paraphernalia that goes with that

in this area, I know, I know, you're only visiting. We are very proud of our connections with William Wilberforce. He was the son of Hull, and he was educated in Pocklington. And believe me, Pocklington School's very proud of that. I was the mayor for a year and they never stopped banging on about it.

But ethical supply chains is very important to people. And at this point in time, I back in March, we had a webinar with our W.E. and I asked them if they had people on the ground who could guarantee that in forced labour and slave labour was not being used in the supply chains. It took them over three months to give me a response, which was disappointing because it was only three weeks ago and they gave me the response. I expected they were abiding by all the agreements, and obviously they discouraged slavery in the supply chains and everything else, but they could not provide me with a positive answer that they had ways of monitoring on the ground.

Now, 90% of solar panels are probably going to be imported from Xinjiang in China. The United Nations rapporteurs have reported that they have serious concerns about slave labour being used in production of solar panels. In November 2023, Sheffield Hallam University produced a report, overexposed, which I would urge you to read or refer to, which they said highlighted problems with supply chains and slavery.

And the same month, the UK ambassador to the United Nations raised his concerns on behalf of another 50 states. Now, as you know,

GB energy has banned the use of these solar panels in public projects where there is evidence of slavery. We think that should be. I think that should be turned around. We think we should only import these panels where we can prove evidence that there isn't slavery. But because China is a closed country, that's about to be impossible now. There are other sources. Canada, Taiwan, even UK and manufacturing solar panels and our Dodge RWA please.

At this stage and the Secretary of State, make sure we have systems in place to ensure that enforced labour and slavery are not being used, because I don't want anybody involved in this process in years to come to have their blood in their hands. And believe me, I don't. I've never tried to emulate William Wilberforce, but if he was here today, I think he would be supporting this appeal.

And again, it's the reason we're worried about it is because light pollution is bad for everybody.

Uh, it's particularly bad for people who are used to dark skies. So I thought I was trying to be helpful, approaching, uh, RWA and saying, work with me to do some research so that in five years time or ten years time when this is built, we can actually prove whether or not there has been a direct impact on the darkness of the skies. So I was very disappointed that they couldn't find a very small amount of money to go ahead.

I'm just saying, I suppose I'll just understand. Glint and glare is more of a sun like the sun reflecting off the. So in terms of dark skies, I'm just wondering what is it in that particular artificial lighting that you're concerned about?

Or it's not just there's going to be a certain amount of artificial lighting, but there is also certainly likely to be a certain amount of background reflected lighting, either because, for example, down at the bottom end of the project, it's near quite near the city of Hull. Uh, and the impact there should be significant. You also get reflective glare from the moon. Now one of the biggest, the biggest enemy of the astronomer in East Riding is actually the full moon.

Unless you're really into the moon, because it drowns out so much. And when you do not have the moon present, our fear is not only with the glare increase the general level of light pollution, but I think this might be in the biodiversity section. It could have an impact on migrating birds because as evidence coming out of Europe, that glare from solar panels is being mistaken for water and birds are dying as a result.

So there's a couple of knock on effects, but it's because my skies ambassador, I would like to see Dark skies status for this part of the country, and this should damage the chances of that.

Okay. So it might be, for example, that you're able to, um, like get confirmation of all parties with an interest in that land that they agreed to what you're going to be proposing, which will then negate the compulsory acquisition regulations kicking in potentially.

That's right, that's right. So so you'll be aware that the way in which those regulations work is that the process, um, set out in, I think it's regulations 5 to 19 of those regulations only binds where you haven't been able to obtain the consent of a person with an interest in lands. So what? What we are doing as part of our engagement with landowners is seeking that consent. And because, as you say, we're dealing with people we have been dealing with for for some period of time.

We're hopeful that we'll be able to do that. Okay. In my experience, I should just say, because the regulations apply to all persons with an interest in land, not just those with a category one interest. There can sometimes be difficulties in in procuring the consent of those, for example, the category two interest, particularly if you're dealing with a statutory undertaker. Um, simply because it's not always that easy to find the right person in that organisation to, to give the consent. But we're doing

our best and that's what we're, we're aiming for because we appreciate from your perspective, it will make things a lot easier.
