# 5. Landscape and visual

- Consideration of potential effects of construction lighting.
- Consideration of the scope/ opportunity for additional planting and advance planting to further reduce potential effects.
- Consideration of cumulative effects and the applicant's conclusions.
- Consideration of the Overarching National Policy Statement for Energy paragraph 5.10.26, and for the applicant to expand on its response to the ExA's written question ExQ1.10.25 in this regard.

#### 6. Heritage

- To what extent East Riding of Yorkshire Council's (ERYC) outstanding concerns have been addressed, including:
  - o The effect on the setting of the Church of St. Margaret (grade II\* listed).
  - o A proposed passing place opposite Meaux Abbey farm (grade II listed).
- Discussion regarding differences in view of harm to designated heritage assets between applicant, ERYC and Historic England.

#### 7. Biodiversity

- To what extent Yorkshire Wildlife Trust's concerns in its relevant representation/ statement of common ground have been addressed.
- To what extent Natural England's (NE) outstanding concerns have been addressed, including:
  - o Potential impacts related to pink-footed geese.
  - Further details regarding management and monitoring measures in relation to bird mitigation areas.
  - Scape mitigation details, to ensure that the scrapes would remain hydrologically isolated.

- Noisy works location and impact on birds and mitigation.
- Bentonite breakout edits to the outline Construction Environmental Management Plan.
- Protected species the use of mammal gates.
- Noting the applicant's response to the ExA's written question ExQ2.6.3 setting out that no further noise modelling is proposed, whether discussions with NE indicate that this is likely to be agreed.
- To what extent ERYC's outstanding concerns have been addressed, including:
  - Mitigation areas potential for disturbance (including discussion around the forthcoming change request and permissive paths).
  - The size of potential welfare facilities on Figham Pastures Local Wildlife Site (should these be necessary).
  - o Loss of category B trees and potential impacts to T076, a category A oak.
  - Minor discrepancies between the biodiversity net gain (BNG) metric and the BNG assessment, together with further justification behind some of the assumptions of the assessment.

### 8. Transport and access

- Consideration of the use of Park Lane for construction access to Creyke Beck substation, the potential for highway safety related issues and the potential for further mitigation measures.
- Consideration of the potential for any alternatives to the use of Park Lane, such as the use of an access proposed directly off the A1079 associated with an unrelated planning application for works at Creyke Beck substation.
- Consideration/ clarification of maintenance access to Fields E15 to E17, including for any replacement infrastructure, and potential for effects.
- Consideration of potential construction traffic/ routing and implications for the implementation of Field House Solar Farm.

### Notes on participation, conduct and management of the hearing

All interested parties (IP) are invited to attend issue specific hearings. The event will also be livestreamed and a link for watching the livestream will be posted on the <u>project page</u> of the Find a National Infrastructure Project website closer to the event date.

Each IP is entitled to make oral representations at the hearing. However, this is subject to the ExA's power to control the hearing.

Participants may be legally represented if they wish, but the hearing will be conducted to ensure that legal representation is not required. Guidance under PA2008 and the Infrastructure Planning (Examination Procedure) Rules 2010 provide that it is the ExA that will probe, test and assess the evidence through direct questioning of persons making oral representations at hearings. Questioning at the hearing will be led by the ExA.

Every effort will be made to ensure that the issues will be discussed on the day that they are scheduled for. The hearing will finish as soon as the ExA deems that all those present have had their say and that all matters have been covered. If there are additional matters to be dealt with or there are submissions that take a considerable amount of time at any hearing, it may be necessary to prioritise matters and defer others to written questions.

The agenda is for guidance only. It is not designed to be exclusive or exhaustive. The ExA may add other issues for consideration, may alter the order in which issues are considered and will seek to allocate sufficient time to each issue to allow proper consideration of them. Any lack of discussion of a particular issue at a hearing does not preclude further examination of this issue, including the asking of further written questions.

All examination documents are provided with a unique identification number for referencing purposes shown in square brackets [].

The evidence presented orally at ISH2 should be included in post-hearing submissions and submitted by **Friday 31 October 2025 (deadline 4).**
