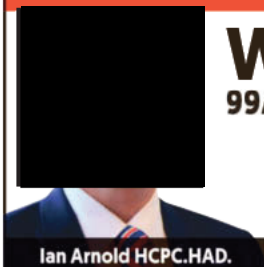

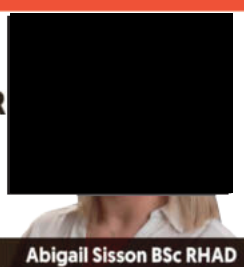

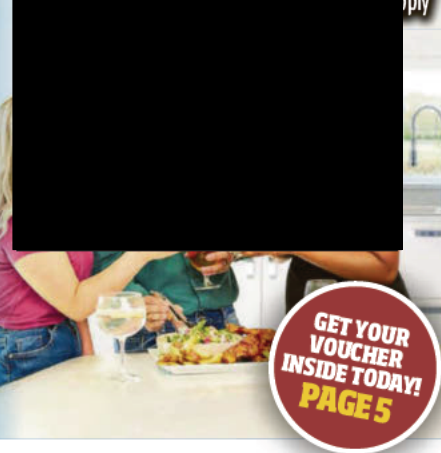

RIVER CAMEL SALMON AND SEA TROUT PROTECTION BYELAWS

- **Prohibit the use of bait for the catching of salmon with the exception of prawn or shrimp.**
- **Require the use of barbless hooks when fishing for salmon, sea trout and brown trout using all rod and line methods.**
- **Restrict the use of treble hooks for the catching of salmon on artificial lures and flies.**
- **Restrict the maximum size of hooks for all rod and line methods when fishing for salmon, sea trout and brown trout.**
- **Require the release of all sea trout caught on rod and line over 50cm in length (from snout to tip of tail) with minimum delay and injury.**
- **Implement a maximum bag limit of two sea trout to be retained at any point in time or within a 24 hour period.**

The 5-year re-application of byelaws protecting salmon and sea trout on the River Camel catchment is considered necessary to protect a declining, unsustainable salmon stock. In particular, the abundance of juvenile salmon stocks throughout the River Camel has been extremely poor in recent years. The salmon stock therefore requires ongoing protection to allow the population to stabilise and recover. The byelaws recognise that the River Camel is a designated Special Area of Conservation (SAC) and that salmon is a designated interest feature.

The proposed byelaws will require the return of all salmon caught by rod and line within the River Camel and restrict the types of methods and hook types that are used to catch salmon. These measures are intended to maximise the survival of salmon following their capture and their opportunity to spawn. Furthermore, there is also a need to protect sea trout from over exploitation at a time of reducing salmon stocks, this is achieved by requiring release of all seatrout over 50cm in length and implementing a maximum bag limit.

Israeli spy chief 'threatened' ICC official over war crimes inquiry

Mossad director tried to persuade chief prosecutor to halt investigation, sources say

The former head of the Mossad, Israel's foreign intelligence agency, allegedly threatened a chief prosecutor of the international criminal court in a series of secret meetings in which he tried to put pressure on her to abandon a war crimes investigation, the Guardian can reveal.

Yossi Cohen's covert contacts with the ICC's then prosecutor, Fatou Bensouda, took place in the years leading up to her decision to open a formal investigation into alleged war crimes and crimes against humanity in occupied Palestinian territories.

That investigation, launched in 2021, culminated last week when Bensouda's successor, Karim Khan, announced that he was seeking an

arrest warrant for the Israeli prime minister, Benjamin Netanyahu, over the country's conduct in its war in Gaza.

The prosecutor's decision to apply to the ICC's pre-trial chamber for arrest warrants for Netanyahu and his defence minister, Yoav Gallant, alongside three Hamas leaders, is an outcome Israel's military and political establishment has long feared.

Cohen's personal involvement in the operation against the ICC took place when he was the director of the Mossad. His activities were authorised at a high level and justified on the basis the court posed a threat of prosecutions against military personnel, according to a senior Israeli official.

Another Israeli source briefed on the operation against Bensouda said the Mossad's objective was to compromise the prosecutor or enlist her as someone who would cooperate with Israel's demands.

A third source familiar with the operation said Cohen was acting as Netanyahu's "unofficial messenger".

Cohen, who was one of Netanyahu's closest allies at the time and is emerging as a political force in his own right in Israel, personally led

the Mossad's involvement in an almost decade-long campaign by the country to undermine the court.

Four sources confirmed that Bensouda had briefed a small group of senior ICC officials about Cohen's attempts to sway her, amid concerns about the increasingly persistent and threatening nature of his behaviour.

Three of those sources were familiar with Bensouda's formal disclosures to the ICC about the matter. They said she revealed Cohen had put pressure on her on several occasions not to proceed with a criminal investigation in the ICC's Palestine case.

According to accounts shared with ICC officials, he is alleged to have told her: "You should

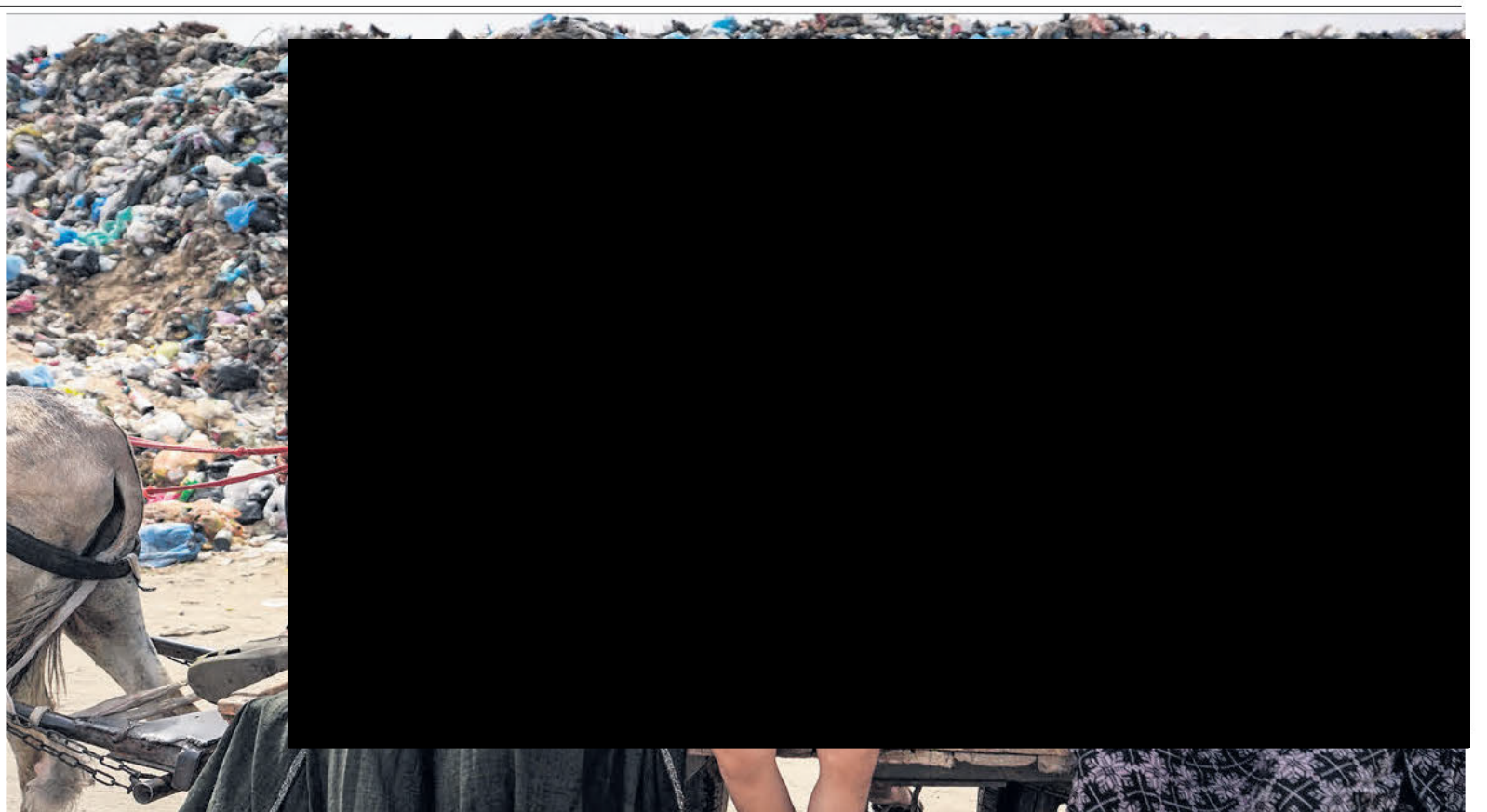

New calls on Starmer to discard Tories' two-child benefits limit

IFS warns 250,000 more children to be impacted by policy over next year

Keir Starmer is facing renewed pressure to scrap the two-child benefits limit, as new research reveals that 250,000 more children will be hit by the policy over the next year alone.

Labour's manifesto for government, published last week, included the promise of an "ambitious strategy to reduce child poverty", but no mention of the two-child limit.

Under the policy introduced by the Conservative chancellor George Osborne, low-income parents are denied key benefits including universal credit for their third and any subsequent children born from April 2017.

Research by the Institute for Fiscal Studies (IFS) finds that when fully rolled out, it will affect one in five

children, costing families an average of £4,300 a year, or 10% of their income. Among the poorest fifth of households, 38% will be affected.

The policy already applies to about 2 million children, but by the end of the next parliament, it will hit an additional 670,000, the IFS figures show.

Eduin Latimer, a research economist at the IFS, said the two-child limit had "a particularly big impact on the number of children in poverty for two reasons: it mostly affects poorer households and, by definition,

its effects are entirely concentrated in families with at least three children".

Labour's decision not to include scrapping the policy in its manifesto has frustrated charities and anti-poverty campaigners, and become symbolic of what some see as the party's excessive caution on tax and spending.

Pressed on the policy last week, Starmer said it had been a "difficult choice" not to promise to scrap it, but insisted his party could not make "unfunded promises".

The IFS calculates that ending the

two-child limit would cost £3.4bn a year in the long run - equivalent, it says, to freezing fuel duty for the duration of the next parliament.

"I think it's a shame: Labour has a long history of tackling child poverty," said Mary-Ann Stephenson, the director of the Women's Budget Group, who described scrapping the two-child limit as "one of the most effective ways of lifting children out of poverty".

"There are voices from across the political spectrum, the churches, anti-poverty

Boots workers feel 'betrayed' by early retirement change

MEMBERS of the Boots pension scheme say that last-minute changes have "wiped out" their retirement plans.

For decades, Boots had told workers who were part of its scheme that they would be able to retire at the age of 60 without any financial penalty.

Many of those with long careers at the Nottingham-based company had therefore been making plans for years to retire early.

But those plans are now up in the air after Boots announced in

November that it was scrapping the ability for staff to retire early, with members now only able to take a full pension without a penalty from the age of 65.

Those who planned to retire at 60 are therefore facing the prospect of either taking a severe cut to their pension payments or finding a way to bridge a five-year gap.

Paul Ridley, 59, is one of thousands affected and only found out

about the changes after reading about it in the press.

Mr Ridley, who lives in South Derbyshire and worked for 20 years at Boots, said: "A lot of us know the Boots of old, a lot of us have given a lot of our lives to Boots."

"You think of Jesse Boot, the links to Nottingham, and then this is what the company has done."

"I think that's the bit that gobs smacks people - it's an emotional

trauma as well as financial.

"The contempt they've shown towards people when they've disrupted their lives just beggars belief."

Mr Ridley says he cannot afford to take a financial penalty and is therefore predicting that he will have to work longer than expected.

One of the main arguments being made against the changes is the need for a more effective transition period.



THE man in charge of the Battle of Britain Memorial Flight (BBMF) has paid tribute to a "remarkable" Spitfire pilot who died in a crash last month.

Mark Long was pronounced dead at the scene after the Second World War Spitfire plane he was flying crashed to the ground in Coningsby on Saturday, May 25.

Sqn Ldr Long was a Typhoon pilot at RAF Coningsby and, for the last four years, a pilot with the BBMF. He lived in Lincolnshire and leaves behind his wife, two daughters and dog.

An RAF investigation into the circumstances surrounding the crash is now under way and all

BBMF flights have been paused while it is carried out, including the D-Day 80th anniversary commemorations on June 5 and 6. In a tribute to Mark Long posted on June 1, Squadron Leader Mark Sugden, Officer Commanding BBMF, said he "personified the very best of the Royal Air Force".

He said: "Words can not adequately convey the loss of such a dear friend and I have been overwhelmed by the support, well wishes and tributes that the team and I have received which speak so eloquently of the remarkable man that Mark was."

"Mark was such a familiar face to not only those at RAF Coningsby but to so many aviation enthusiasts and those in the local community. Mark touched so many lives

are being supported. Lincolnshire Police's investigation into what caused the fire is continuing.

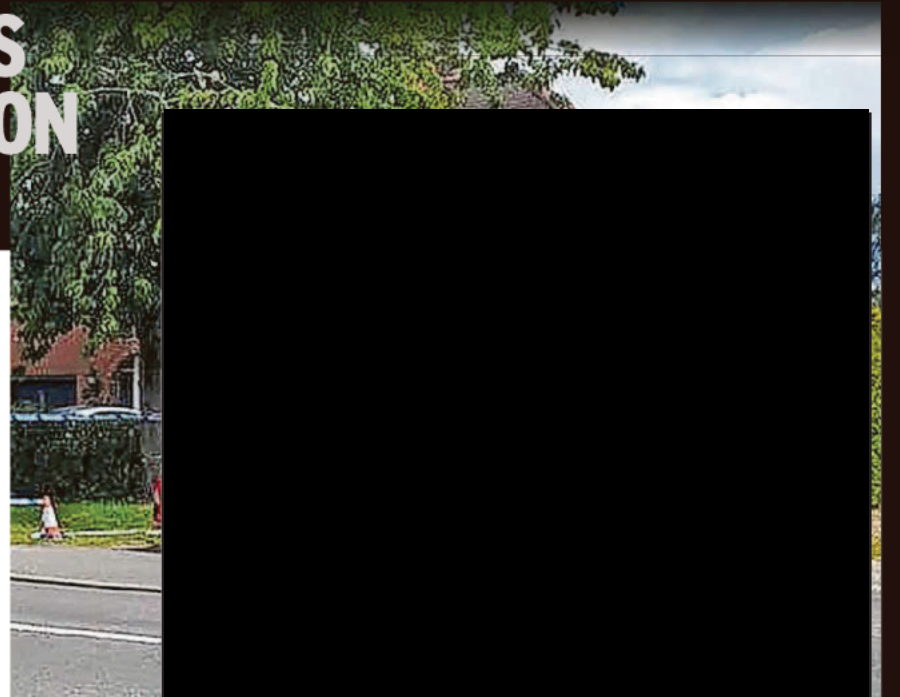
Two people had previously been arrested in connection to the incident. However, they have both been released without any further action being taken.

Overview of One Earth Solar Farm
One Earth Solar Farm would comprise the construction, operation and maintenance, and decommissioning of a ground-mounted solar photovoltaic ('PV') array electricity generating facility and battery energy storage system with a total capacity exceeding 50 megawatts (MW) and import/export connection to the National Electricity Transmission System ('the Project').
The Project would be located on approximately 1,600 hectares of land within the administrative boundaries of Newark and Sherwood District Council, Bassetlaw District Council, West Lindsey District Council, Lincolnshire County Council, and Nottinghamshire County Council (the 'Proposed Site').

Development Consent Order (DCO)
