Request for further information

We are writing under Rule 17 of the Infrastructure Planning (Examination Procedure) Rules 2010.

In seeking to establish a clear starting point for the examination, we would like to receive updated landscape figures which align with the applicant's **Guide to the Application**, and which includes a full index of the supporting documents for this chapter of the ES, with clear titles for each document and what is contained within each document.

As currently drafted the Guide does not appear to correspond with the title of the documents submitted, for example:

 The applicant's Guide to the application refers to Figures 11.1 through to 11.14, in support of ES Chapter Vol 3 on Landscape, however the submitted documents are all labelled the same, Figures 11.1-11.14. These 19 Parts then have differing Figures within them from the title and the Guide. (See Table 1 below)

Other discrepancies include:

- Parts 3 to 10 whilst entitled with the same Figure numbers, include different figures 12.1-12.63, (**Not listed in the Guide to the Application**) some of which appear to be duplicates, it is not immediately apparent why this is the case, or where within the ES Chapter Figures 12.1 to 12.63 are explained. (See Table 2 below).
- Subsequent Parts appear to include further duplicates (Part 18 including 11.14.14 to 11.14.16, 11.14.1-11.14.4 included in Part 16.



In seeking to understand this Chapter further please point out to the ExA where the plan can be found which identifies the individual viewpoint locations, and the sensitive receptors identified in respect of the landscape chapter.
