Land Plans (Doc 2.2)	In the Book of Reference (Doc 4.3) plot 05-012 is described as South of Hollow Gate Lane. The plot on Sheet 8 of the Land Plans appears to be north of the lane.  It would be useful if plot descriptions in the Book of Reference (Doc 4.3) referred to features within each sheet for improved clarity, for example on sheet 11 of 16 plot 11-005 is described in relation to Southmoor Road which is not located on the same sheet.	Plot 05-012: Hollow Gate Lane is also the road name that the Applicant is referring to which is located to the south of this plot. We will label the road on the plan to reflect this.  Plot 11-005: the Applicant will label Southmoor Road on the relevant land plan to reflect this.  To increase clarity, the Applicant is reviewing instances where this occurs and adding labels as appropriate. The Applicant will provide updated plans when required over the course of examination.	Not applicable at this stage.
ES Chapter 6: Biodiversity (Doc 6.6)	ES Chapter 6, section 6.3.2 states that the ecological features set out in Table 6.1 (including designated sites, habitats and veteran trees) are presented in ES Figure 6.1. ES Figure 6.1 does not show this information and appears to relate to ES Chapter 16 (Human Health). Figures showing any statutory or non-statutory sites or features of nature conservation and habitats of protected species, important habitats or other diversity features are required.	Figure 6.1 has been updated and now includes the Study Area (Figure 6.1a) relevant to Table 6.1 and the location of the designated sites, non-designated sites, priority habitats and veteran trees within the Study Area (Figure 6.1b). Details on the legally protected and notable species, habitats and waterbodies, and watercourses are included in Annex 1 of ES Volume 3, Appendix 6.3: Extended Habitat Survey [EN010159/APP/6.21].	The Applicant provided an updated Figure 6.1: Study Area on 7 <sup>th</sup> April 2025, which is available on the project page under ref. AS-004.

Flood Risk Assessment (FRA) and Outline Drainage Strategy (Doc 6.21)	A figure in the FRA distinguishing which areas of the proposed development's order limits are within Flood Zone 3a and Flood Zone 3b is required. The Environment Agency published new flood and coastal erosion risk data on 28 January 2025 with further data planned for release on 25 March 2025. Once this further data has been released by the Environment Agency, the applicant should provide updated versions of the relevant assessments including the FRA, based upon the updated Environment Agency data.	6.7 Chapter 7 – Hydrology and Hydrogeology, Appendix 7.2: Flood Risk Assessment and Outline Drainage Strategy and Figure 7.1-7.17 has been updated to include the Environment Agency new flood and coastal erosion risk data (as released on 25 March 2025).
