Dear planning inspectorate, I would like to submit further comments to the One Earth Solar Farm Scheme.

Moor Farm east of the project - RUSSELL.

This proposal does not allow for any suitable offset for residential views for either us or our nine neighbours that would see hundreds of 3.8 metre high industrial structures sitting in a flood risk area adjacent to our homes. The height of the solar panels being 3.8 metres plus any further increases for the flood plinth design would swamp this low laying landscape, seeing nothing but solar panels in all directions.

From the upper floor of our home there is no screening for this industrial landscape, the view would be a constant negative reminder affecting our wellbeing in our home. Even from our garden we would see hundreds of solar panels and the light reflected from these would be a constant intrusion.

Our nine neighbouring properties also have close views to the fields along with an accredited Caravan site sitting directly opposite this proposed solar field (the caravan site is open all year) which has seen no mitigation.

There is a large wood adjacent to the Wildwood caravan site which forms part of the historic Wigsley airfield/woods this has an abundance of wildlife that comes into the said fields also our garden. This area is of natural beauty, hence the local caravan site, whereby the woods (wildwood) and the national cycle path brings tranquillity to this small area (4 small fields is the proposed solar site to the east of Moor Lane). With further respect to biodiversity, we have counted 78 bats this year from one of the eaves of our house, others bats have also nested elsewhere, they have been living here for years, this project is a real concern for our protected wildlife and other animals such as deer which we see frequently crossing this land. Our ecosystem will be negativity affected by this plan.

The infrastructure impacts overall would be substantial and effect our family activities around our home. Should the inverters be placed within this potential flood area, they too will need to be on raised platforms which would increase their height. We don't know the type of inverters or how close to properties they will be placed. These are known to create an intrusive industrial persistent, hum/noise which will disrupt this peaceful quite rural surroundings, especially in this location as it is quite and there are no industrial farm businesses. The fencing, lighting and security will add to our concerns of this proposed development being unsightly.

Moor Lane has two proposed openings, however, this is a small narrow lane and not large enough for two small cars to pass comfortably, any additional traffic will hinder the community and create hazards for this small lane and its residents.

This area is most certainly tranquil, hence the caravan site and cycle path which is what people treasure for its peacefulness, this project will be a complete eye sore bringing disturbed sleep and stress living adjacent to this.

Sometimes projects are planned in the wrong place and we certainly feel that this project is that, due to the flood risk, protected drinking water catchment area and close to residential properties and their views, along with the concentration of the project on this tranquil landscape.
