Finally, we also make the following comments on the Planning Inspectorate Actions Note¹(Issues arising from Issue Specific Hearing One) as set out below.

Action Point 4: Set out how PD rights for a stat undertaker are assessed in ES. Consider if the whole of the Order Limits should remain as operational land. Note for councils to review.

Response: In order for NSDC to reasonably comment on this issue, we would first need to understand the Applicant's response and we have had no dialogue on this issue. We would be happy to review and comment on any position as confirmed by the Applicant as a Deadline One submission and make our comments (as appropriate) at Deadline two.

Action Point 7: Applicant and councils to discuss and agree way forward on Article 45. Consider including as part of SoCG.
