Anglian Water Response to ExA Written Questions 2 for One Earth Solar Farm – Deadline 4

I write in response to your request under Q12.0.8, Q12.0.9 and Q12.0.10:

Water Resources Assessment (WRA)

Q12.0.8 - Please provide an update of progress made on the WRA, including a timescale for its completion and submission to the examination.

#### Response:

Anglian Water can confirm that a pre-application enquiry with the WRA has been submitted by the applicant. Anglian Water is currently carrying out an assessment of this, including some modelling work required. It is expected that this will be completed by 5<sup>th</sup> November 2005 and a written report will be issued to the applicant. A further update on this matter can be provided at Deadline 5 (12<sup>th</sup> November 2025).

#### **Drinking Water**

Q12.0.9 - Are Anglian Water satisfied with the addition within the dDCO, submitted by the applicant at Deadline 3, relating to them being a consultee on the approval of management plans for the proposed development?

## Response:

We welcome the inclusion of Anglian Water as a named consultee in the amended dDCO submitted by the applicant concerning the approval of these management plans, namely Schedule 2(13) (construction environmental management plan); Schedule 2(14) (operational environmental management plan); and Schedule 2(20) (decommissioning and restoration).
