

**APPLICATION FOR A DEVELOPMENT CONSENT ORDER FOR THE PROPOSED
ONE EARTH SOLAR FARM (APPLICATION REFERENCE: EN010159)**

**NOTIFICATION OF OPEN FLOOR HEARING AND ISSUE SPECIFIC HEARING UNDER
SECTIONS 91, 93 and 94 OF THE PLANNING ACT 2008 AND RULE 13(6)
INFRASTRUCTURE PLANNING (EXAMINATION PROCEDURE) RULES 2010 (AS
AMENDED)**

Notice is hereby given that, at the dates, times and locations set out below, the following hearings will be held by the Examining Authority (on behalf of the Secretary of State (the 'Secretary of State')) for the examination of the application made by One Earth Solar Farm Ltd (company number 13078087) of Unit 2 Crossways Bicester Road, Kingswood, Aylesbury, England, HP18 0RA ("the Applicant") for a Development Consent Order under Sections 14(1)(a), 15(2) and 37 of the Planning Act 2008 ("the Application").

The Application is for development consent for the proposed One Earth Solar Farm ("the Proposed Development"), which is a renewable energy project located on approximately 1,409 hectares of land within the administrative boundaries of Newark and Sherwood District Council, Bassetlaw District Council, West Lindsey District Council, Lincolnshire County Council, and Nottinghamshire County Council.

The Application (Reference No. EN010159) was submitted to the Secretary of State via the Planning Inspectorate on 27 February 2025 and was accepted for examination on 27 March 2025. The Examining Authority was appointed on 25 April 2025 to examine the Application. The Examination commenced on Tuesday 08 July.

Summary of the Proposed Development

The Proposed Development would be located on approximately 1,409 hectares of land **near the settlements of North Clifton, South Clifton, Ragnall, Dunham, and Fledborough** within the administrative boundaries of **Newark and Sherwood District Council, Bassetlaw District Council, West Lindsey District Council, Lincolnshire County Council, and Nottinghamshire County Council**. The Proposed Development comprises the construction, operation (including maintenance), and decommissioning of solar photovoltaic (PV) arrays and battery storage, together with associated infrastructure and an underground cable connection to the proposed National Grid High Marnham Substation. The agreed grid connection for the Proposed Development would allow the export and import of up to 740 megawatts (MW) of electricity to the National Electricity Transmission System.

The Application is required because the Project is classified as a Nationally Significant Infrastructure Project pursuant to sub sections 14(1)(a) and 15(1) and (2) of the Planning Act 2008, as an onshore generating station in England with a capacity exceeding 50 MW. As such, the decision whether to grant development consent will be made by the Secretary of State for Energy Security and Net Zero (the 'Secretary of State').

The DCO, if granted, would authorise the compulsory acquisition of land, interests in land and rights over land, and the powers to use land permanently and temporarily. The DCO would also authorise alterations to the layout of streets, the construction of accesses to the

Proposed Development, the temporary closure and creation and enhancement of public rights of way, street works, removal of hedgerows, and the application, disapplication and modification of legislation.

Environmental Impact Assessment

The Proposed Development is Environmental Impact Assessment (EIA) development, as defined by the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 and accordingly an Environmental Statement (ES) accompanies the Application.
